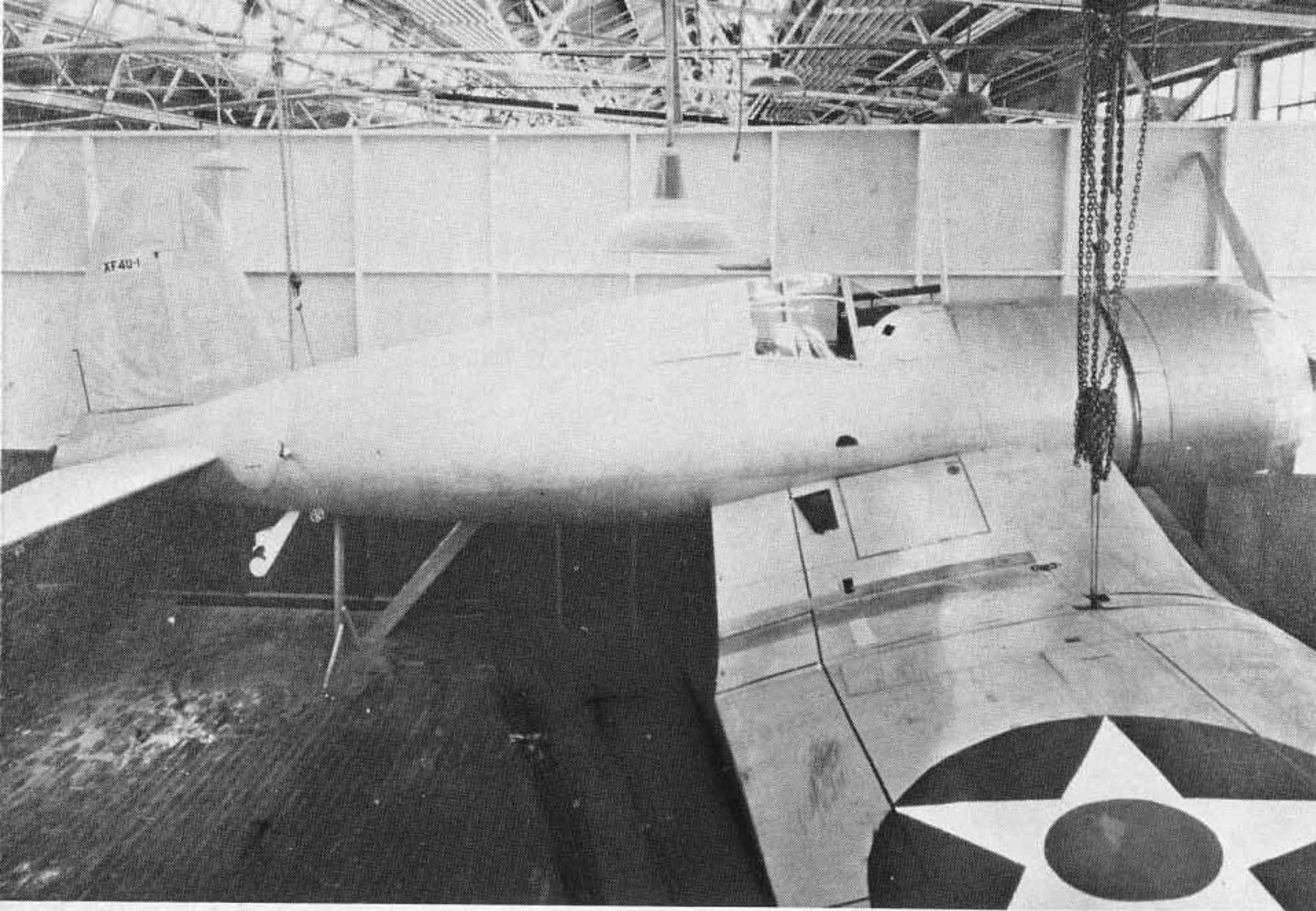

## XF4U-1

The Chance Vought F4U was the 2nd plane to bear the name CORSAIR. The XF4U-1 was Vought's answer to the Navy design competition for a high-speed, high-altitude fighter. The Navy challenge issued on February 1, 1938 was met by the Vought design team headed by the late Rex Biesel. Just two months later on April 8th, Vought submitted a proposal. From the very beginning, the Corsair airframe was designed to mate with the new 2,000 HP radial engine from Pratt & Whitney, the R-2800, just coming off the drawing boards. After thousands of man-hours, the engineers worked out a design incorporating the inverted gull wing, the most powerful engine and the largest prop to date ever used on a fighter. On June 11, 1938 Vought received a contract from the U.S. Navy to proceed with prototypes. By February 1939 the plywood mock-up was ready for inspection by the Bureau of Aeronautics. Passing that, the XF4U-1 was assigned the Bureau number 1443 and started to become a reality. The P&W XR-2800-2 with 1805 HP for take-off was ready now and 27 months after the Navy set forth their requirements for a new fighter, Vought was ready to fly their bird. Armed with two machine guns mounted in the nose synchronized to fire through the prop and one .50 caliber in each wing, the Corsair was well provided to hold its own. In addition to this firepower, provisions were made for receptacles to house a total of 20 anti-aircraft bombs. The reasoning was for these bombs to be used by the high-flying Corsair to drop on enemy bomber formations. The all-aluminum fuselage was complimented with the inverted gull wing which along with the rudder and elevators was fabric

covered. The XF4U-1 incorporated the newly designed spot-welding procedure that resulted in a low-drag smooth external finish. The wing outer panels folded upward to conserve space onboard carriers. The landing gear was designed to retract rearward with the wheels rotating 90° to lie flat within the wheelwells.

May 29, 1940 was the day the XF4U-1 first took to the air. Vought's Chief Test Pilot was at the controls as the Corsair lifted from the runway at Stratford, Conn. Even with the brief maiden flight, Chance Vought knew they had a winner. Weeks passed as Vought continued to fly and evaluate the craft. It was in October 1940 that the Corsair was turned loose on a speed course. Rear Adm. John Towers and others from the Bureau of Aeronautics watched along with Vought officials as it roared by, clocked at a record speed of 405 MPH. The Navy was understandably impressed and after favorable results from its own pilots test-flying the Corsair at Anacostia, a proposal for a production version was requested from Vought. This aircraft was to be the F4U-1. Vought engineering took over now and on December 30, 1940 the changes started that would turn the prototype into the production version. The vulnerability of the integral wing fuel tanks was recognized and they were moved to the fuselage in the production model. This change left wing space that was used to add more firepower in the form of one more .50 caliber gun in each wing. Further testing indicated that the production version would benefit greatly with additional armor-plating, even more firepower, concentrated in the wings, removal of the fuselage guns, adding a jettisonable canopy, increasing aileron area and the elimination of the wing bomb receptacles. After all the changes had been proposed, a final demonstration flight was made at Anacostia in late February 1941. The Navy issued a letter of intent for the F4U-1 and after the details were worked out, on June 30, 1941 a Navy Contract was awarded Chance-Vought to build the F4U-1. 5,559 were eventually built: 2,814 by Vought, 2,010 by Goodyear and 735 by Brewster. These figures include the F4U-1A raised cabin version.

Wing mainspars stacked by the assembly line formed the backbone of the Chance-Vought Corsair. The wing construction was virtually unchanged from the F4U-1 to the F4U-7. [Vought]





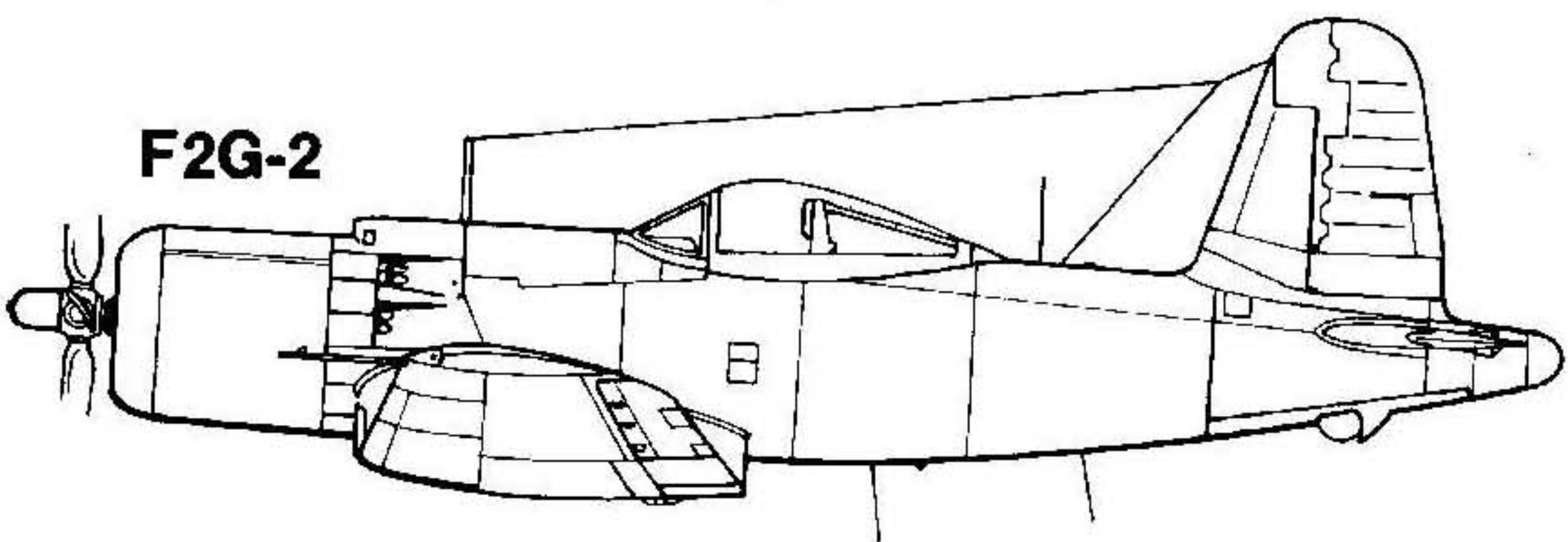
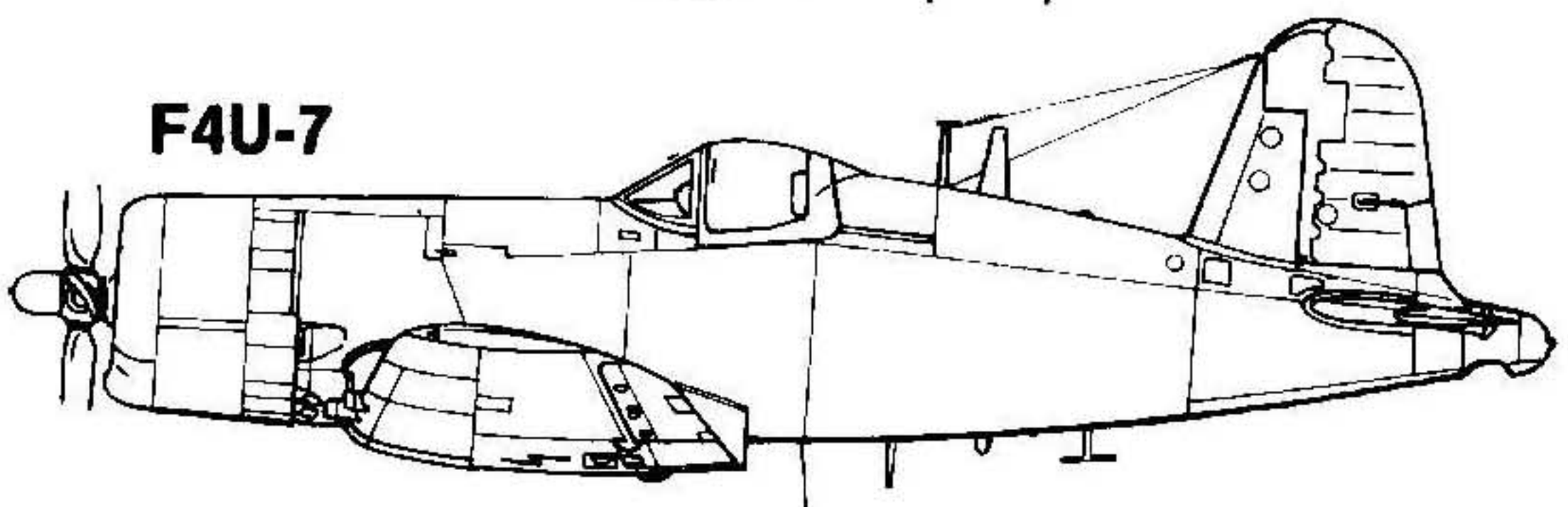
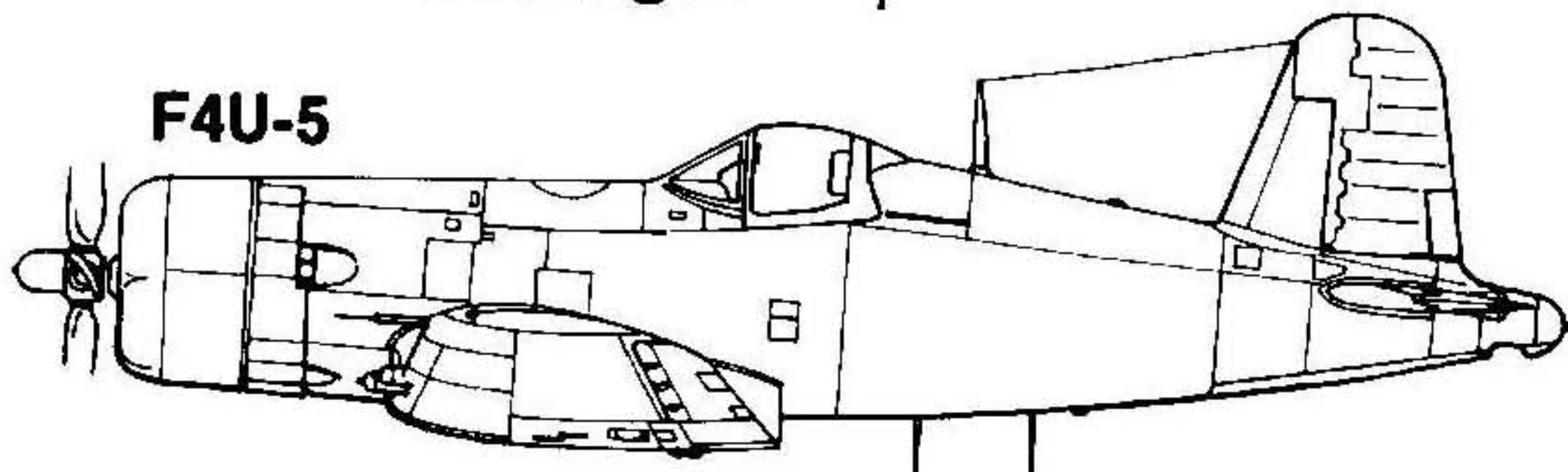
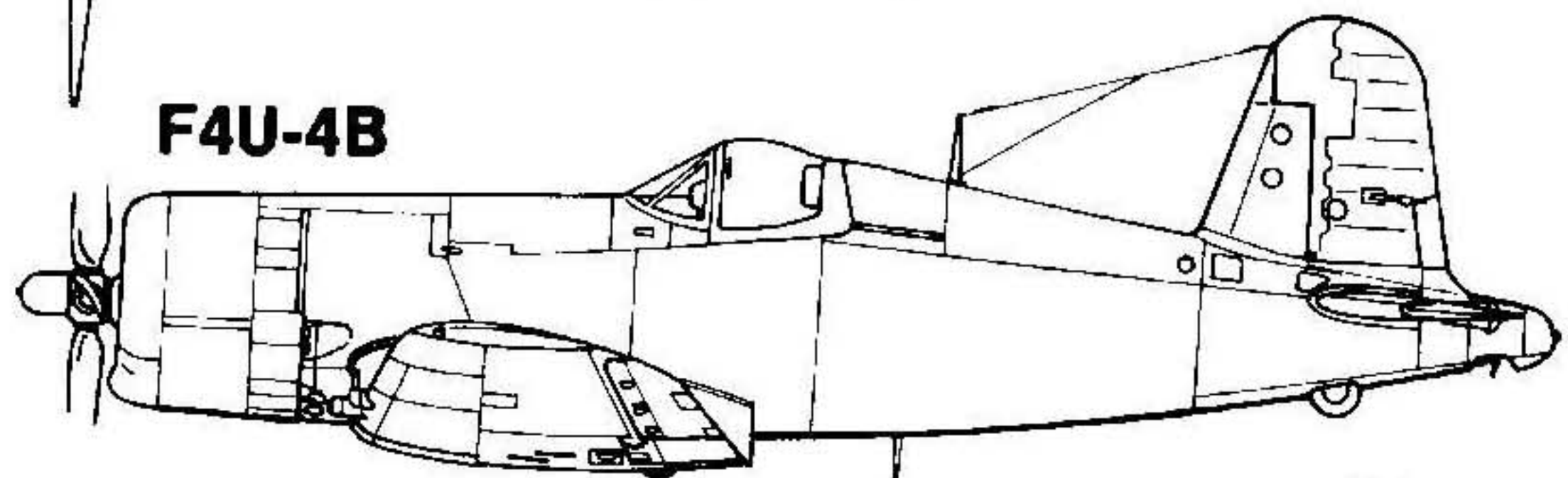
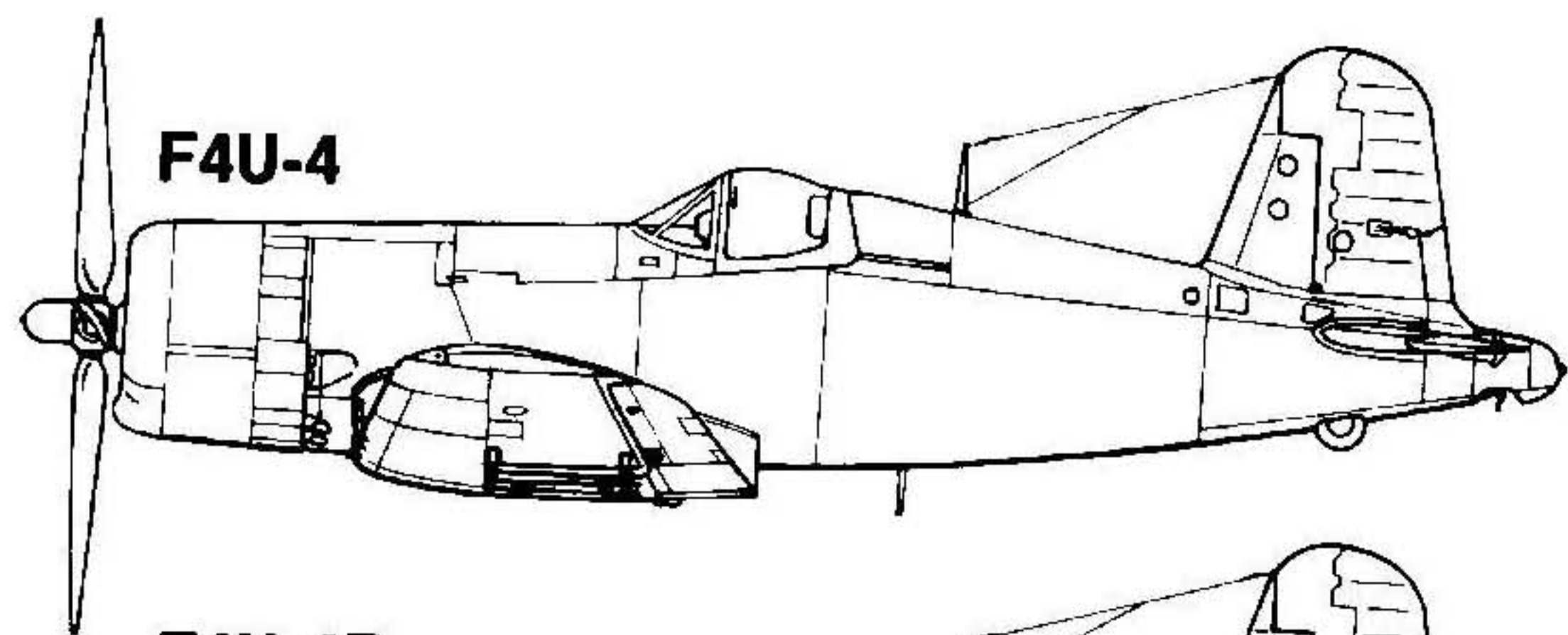
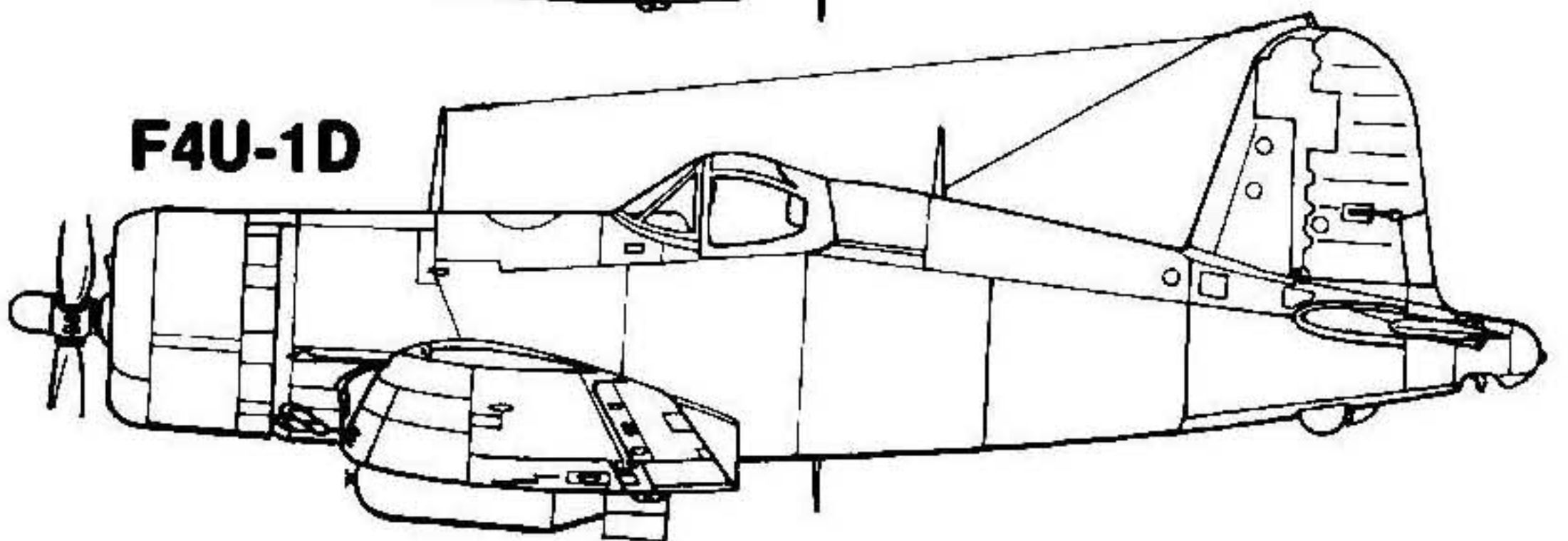
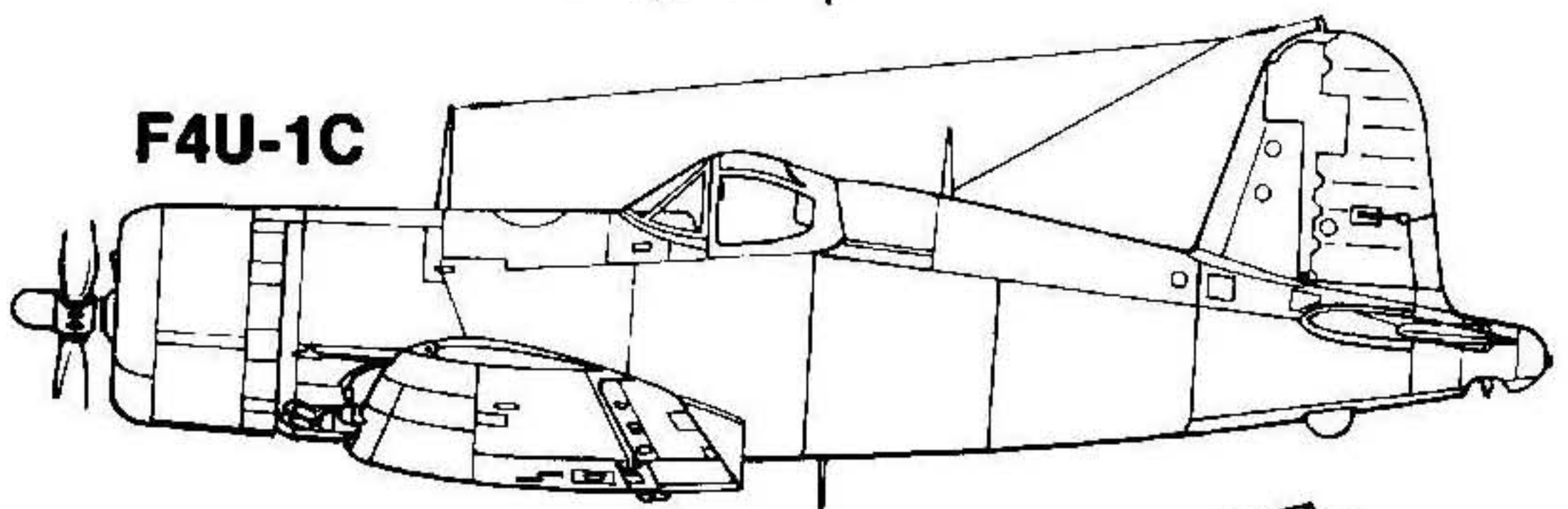
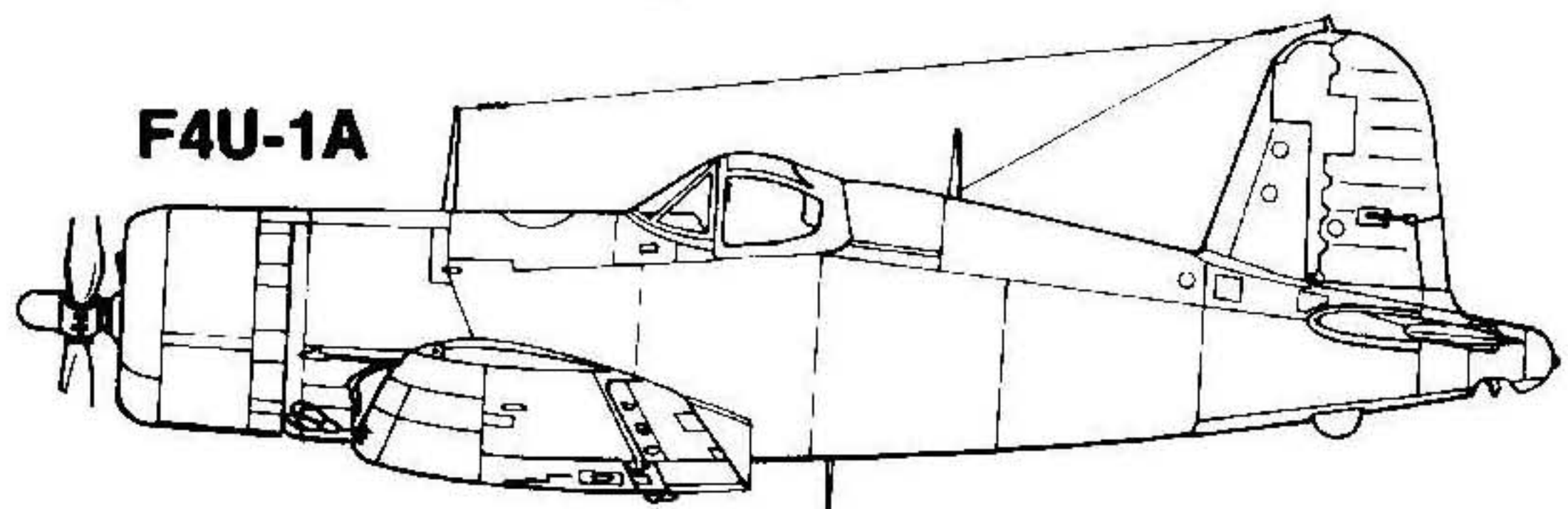
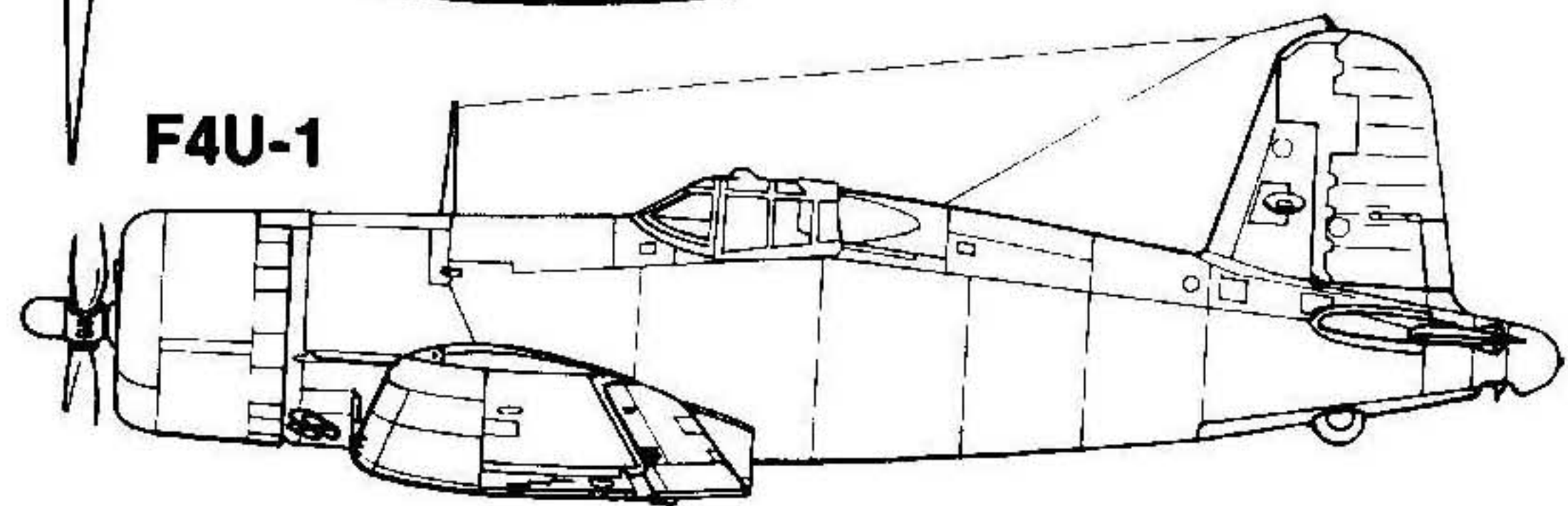
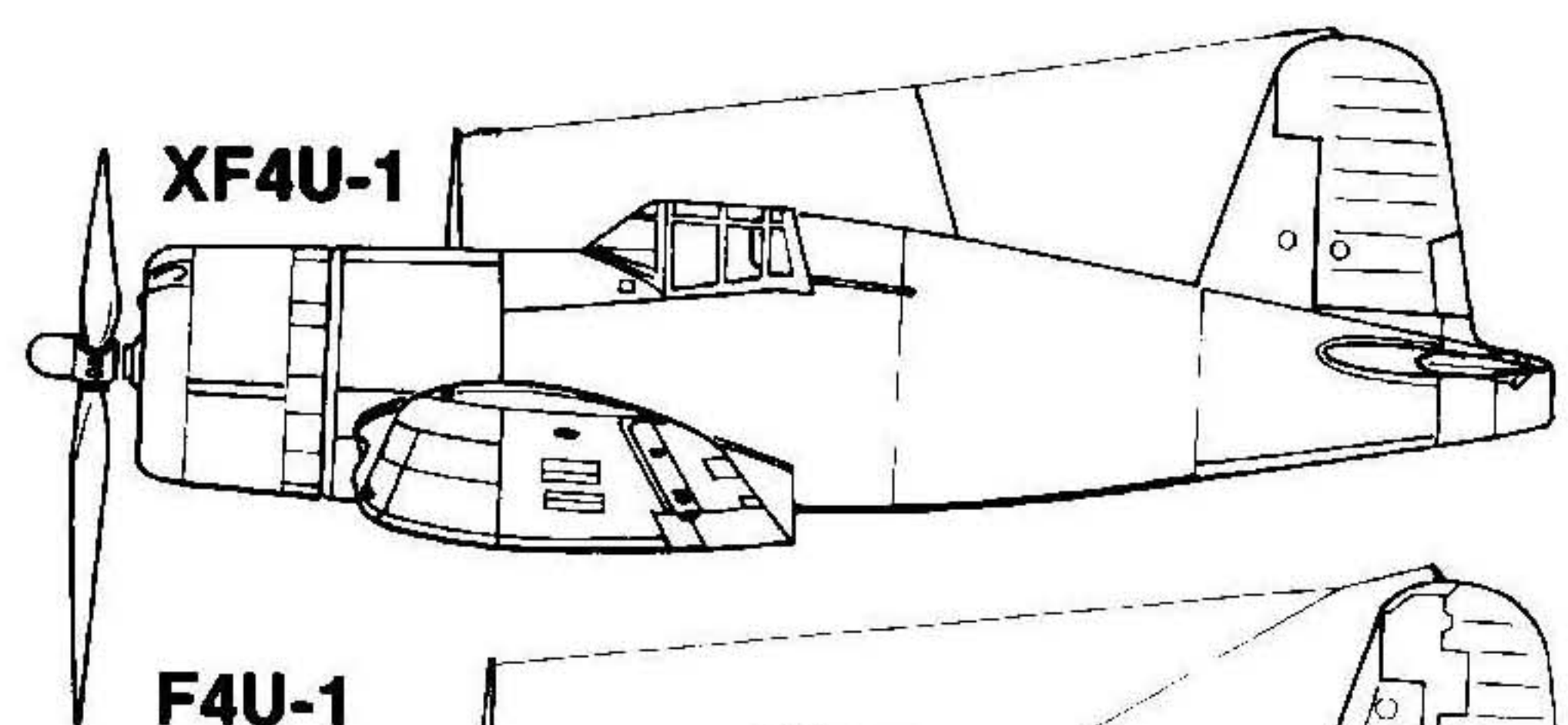

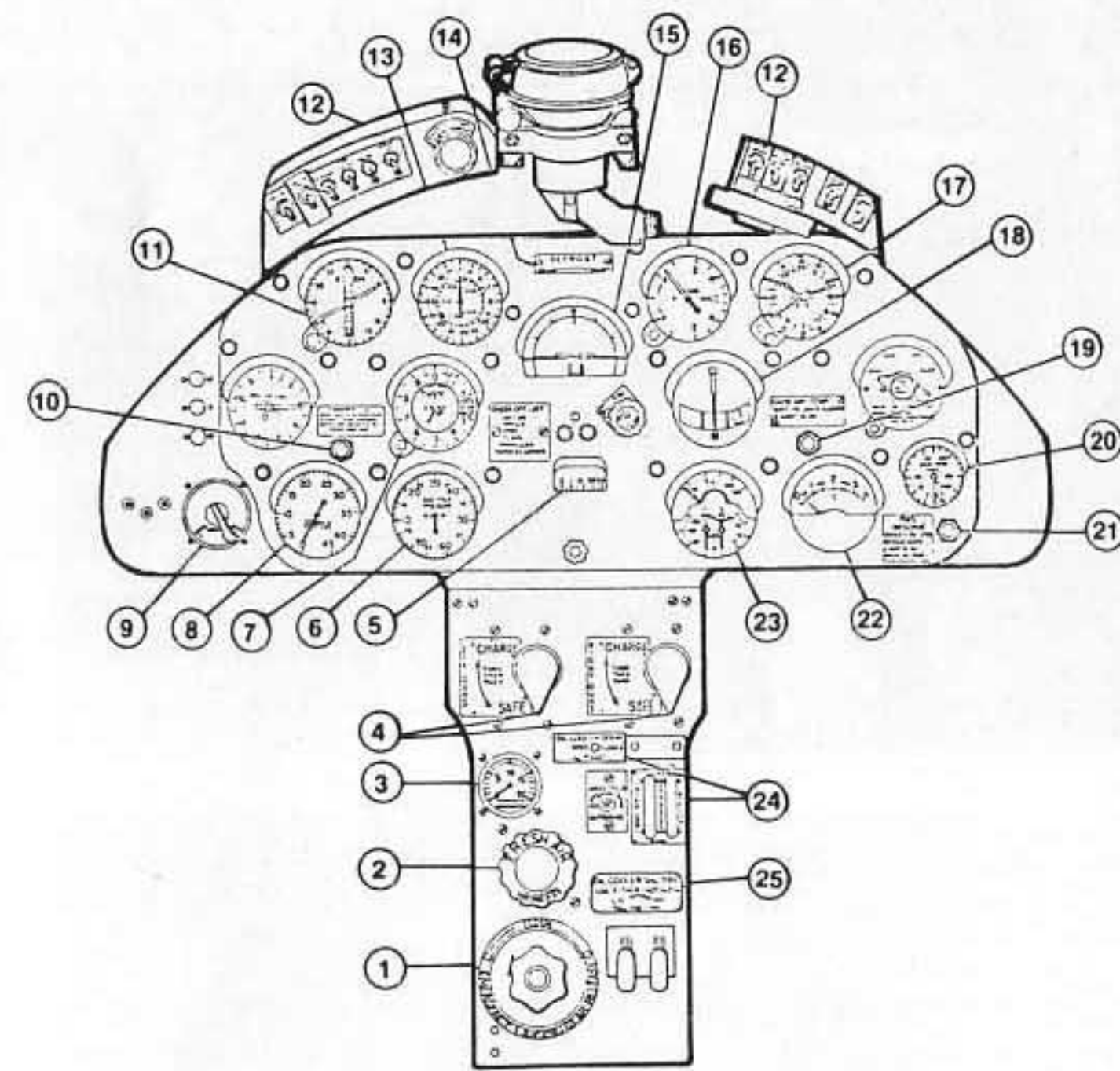






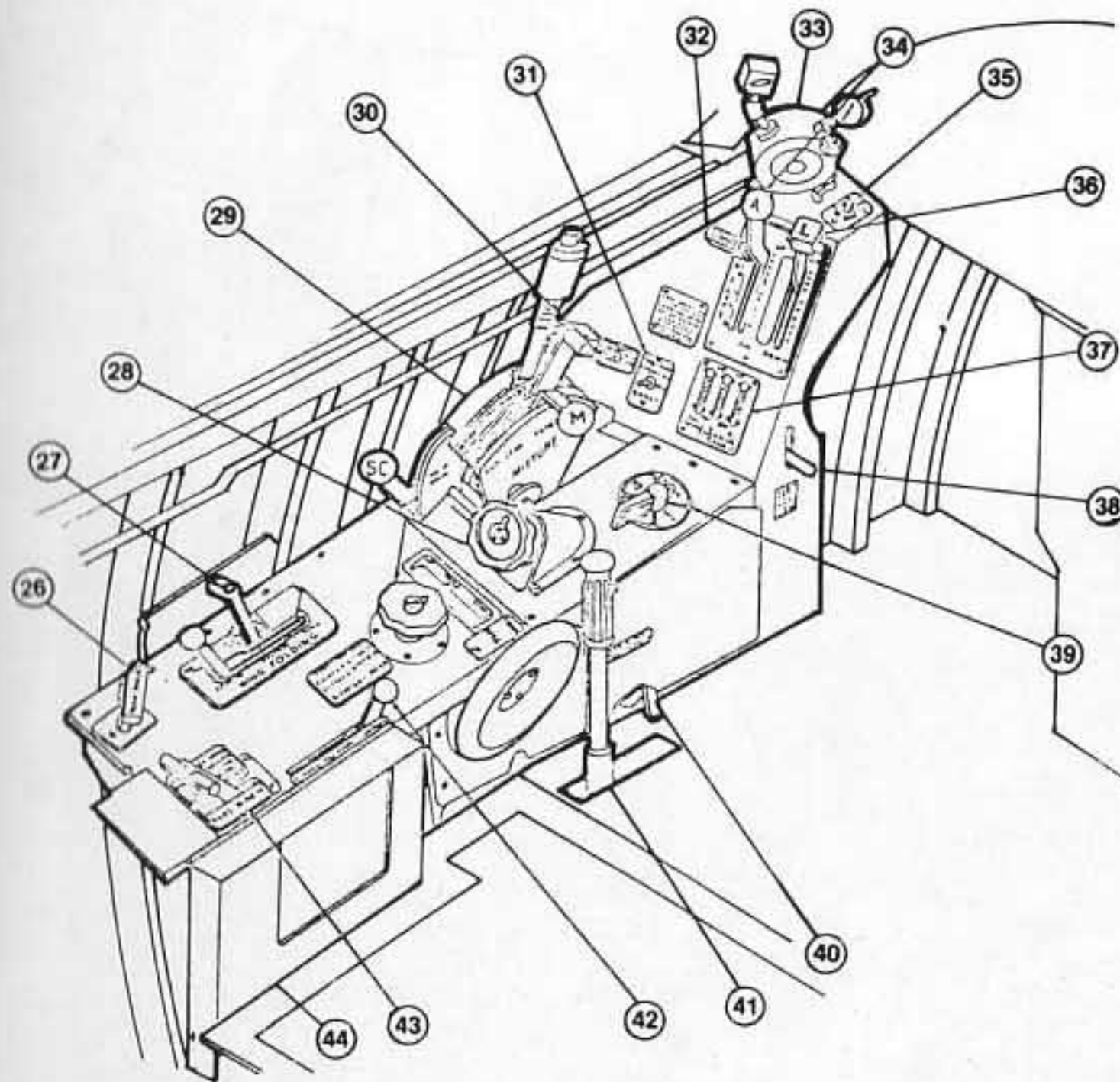


F4U-1 Cockpit showing instrument panel and left side. [Vought]



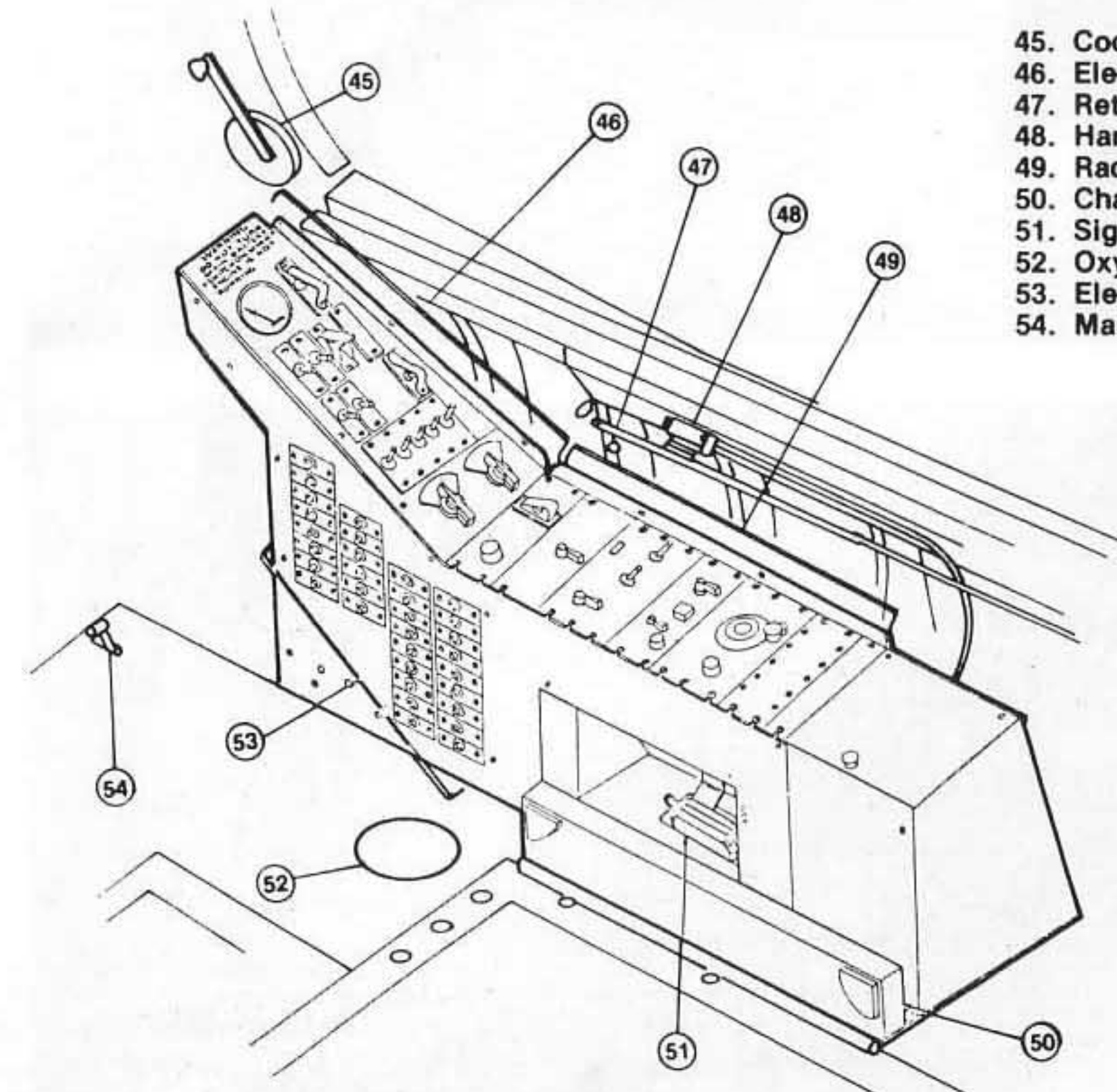

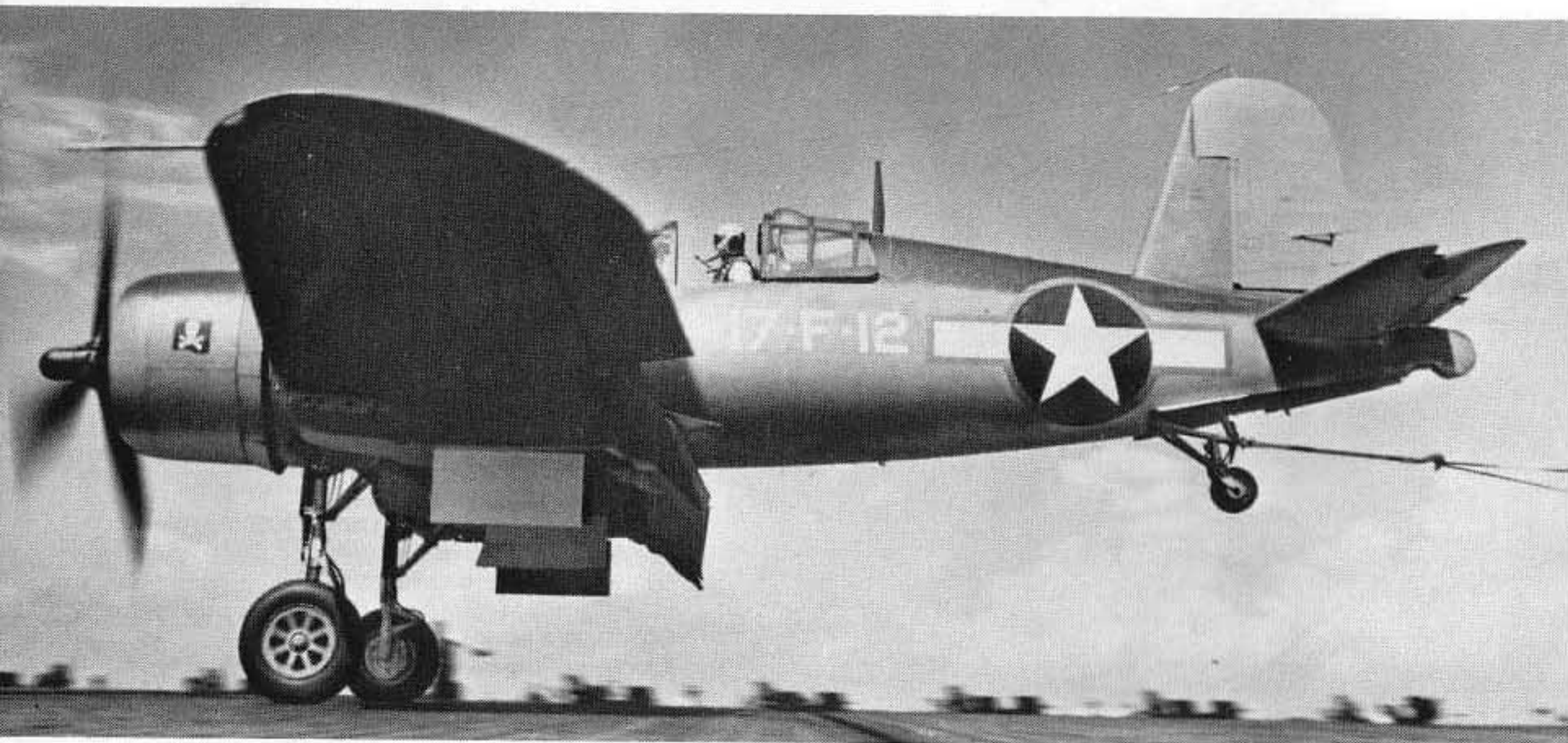




## F4U-1

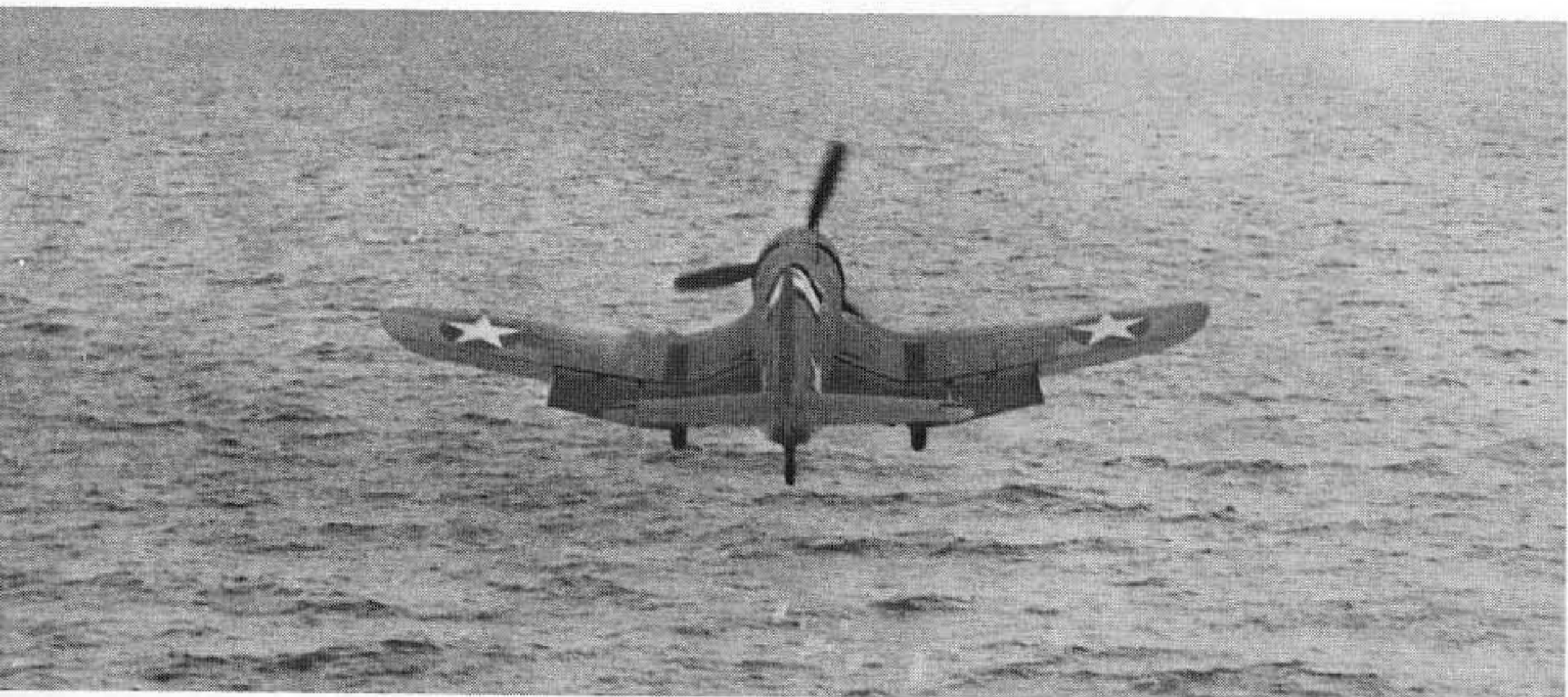
The Navy's initial order for 584 of the F4U-1 fighter placed Chance-Vought into full production and the Navy's confidence in the Corsair was so great that Brewster (F3A-1) and Goodyear (FG-1) were named associate contractors. The first production F4U-1 (02153) flew on June 25, 1942 and was delivered to the Navy just over a month later. The F4U-1 was rated with a maximum speed of 415 MPH, a sea-level rate of climb of 3,120 feet per minute and a service ceiling of 37,000 feet. Armament consisted of six .50 caliber machine guns and a rack on each wing just under the gun ports for a small bomb. Unacceptable performance during carrier trials forced the F4U-1 to become a land-based fighter for the beginning of its combat career. VMF-124 was the first Marine Squadron to see combat with the Corsair, but others followed soon.

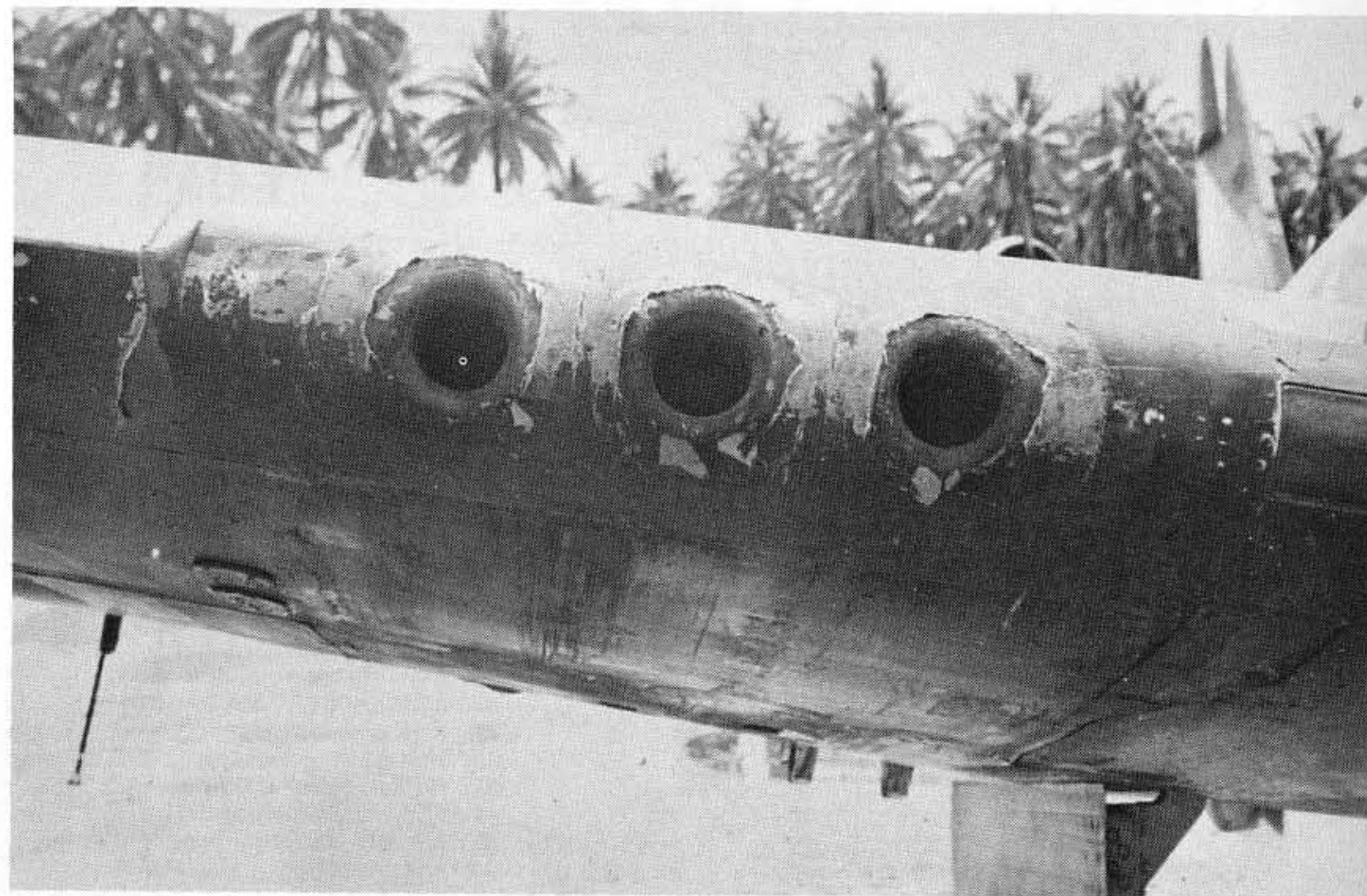

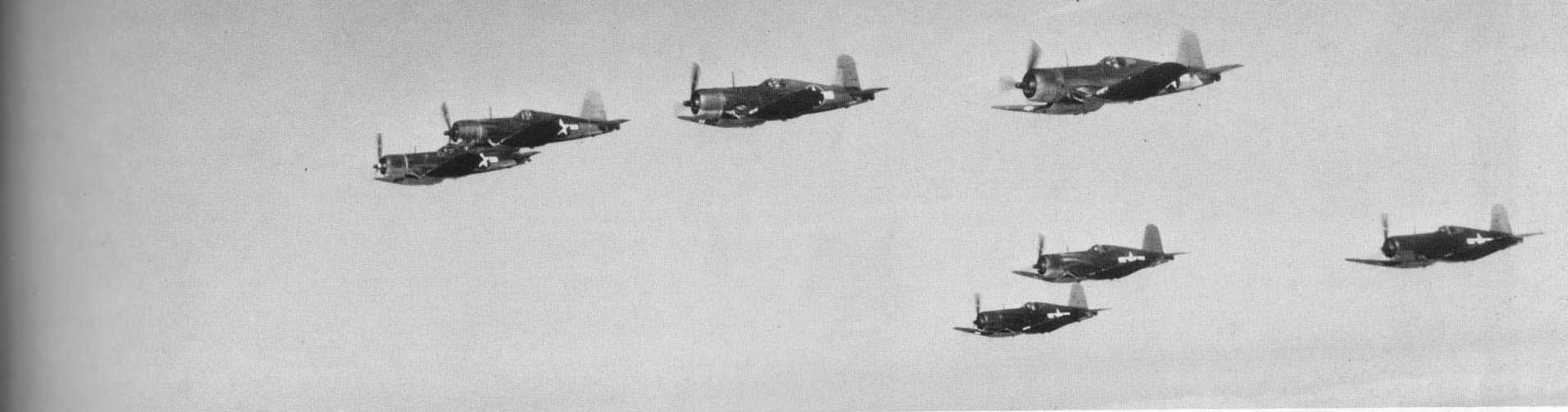

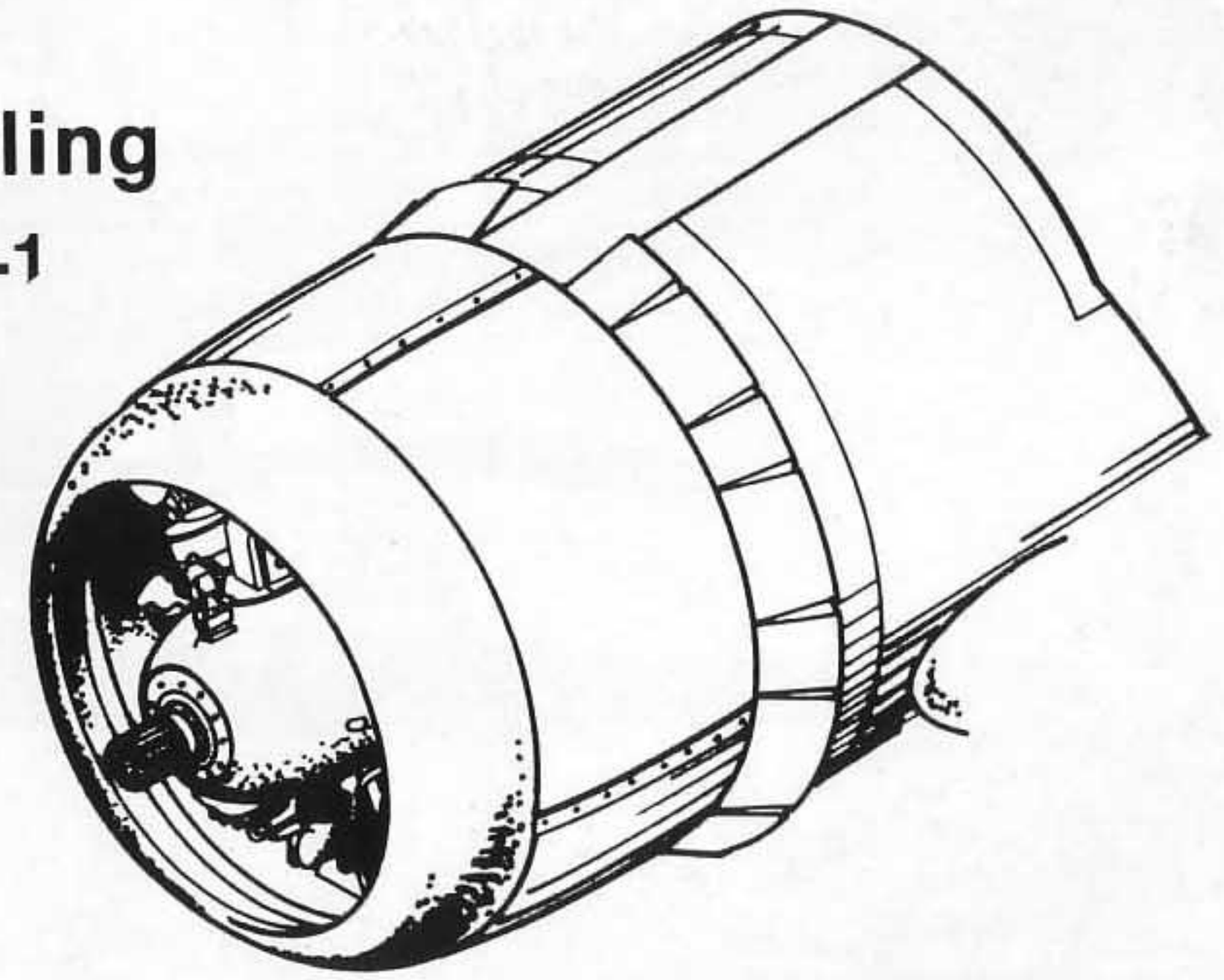

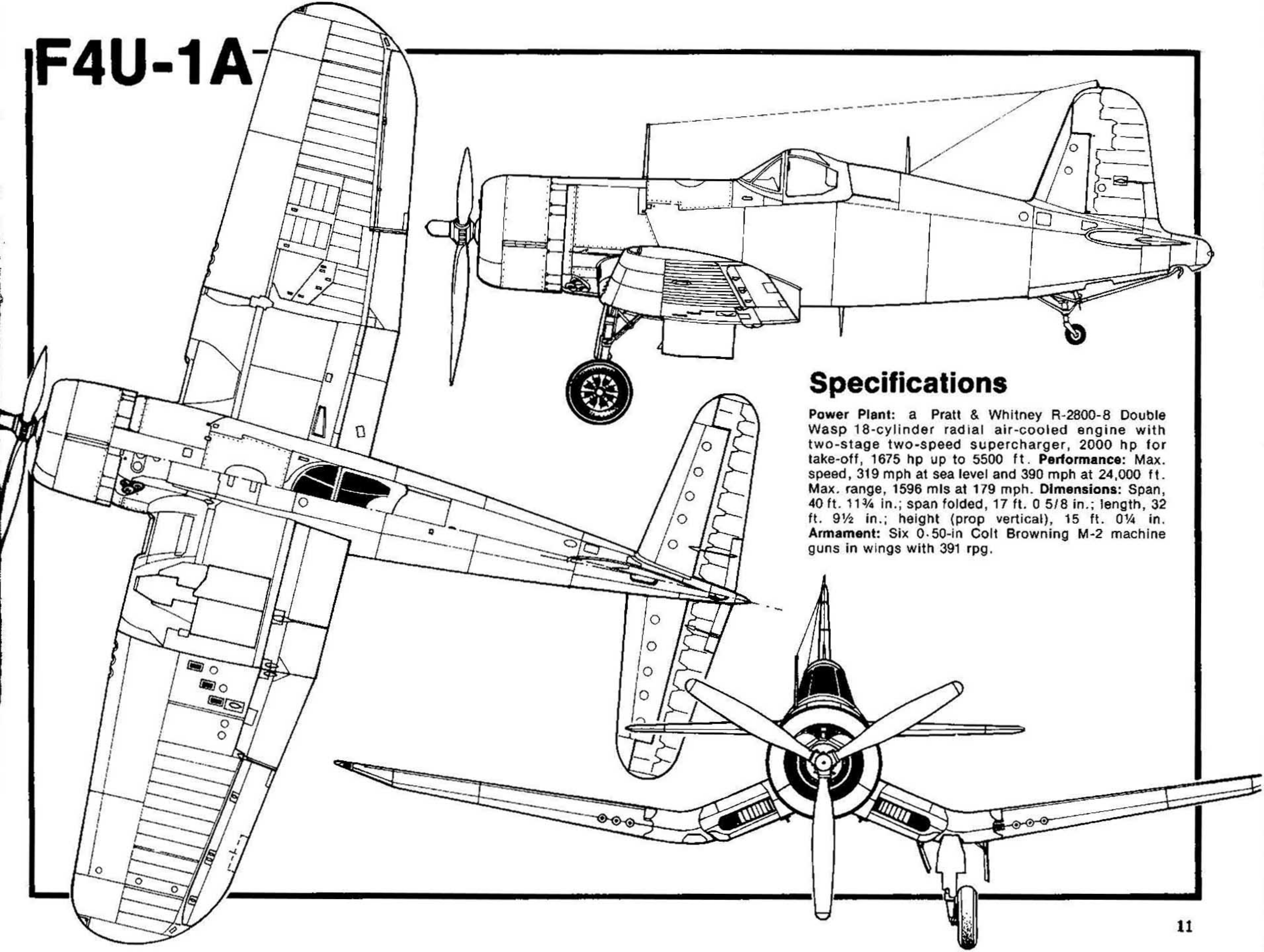

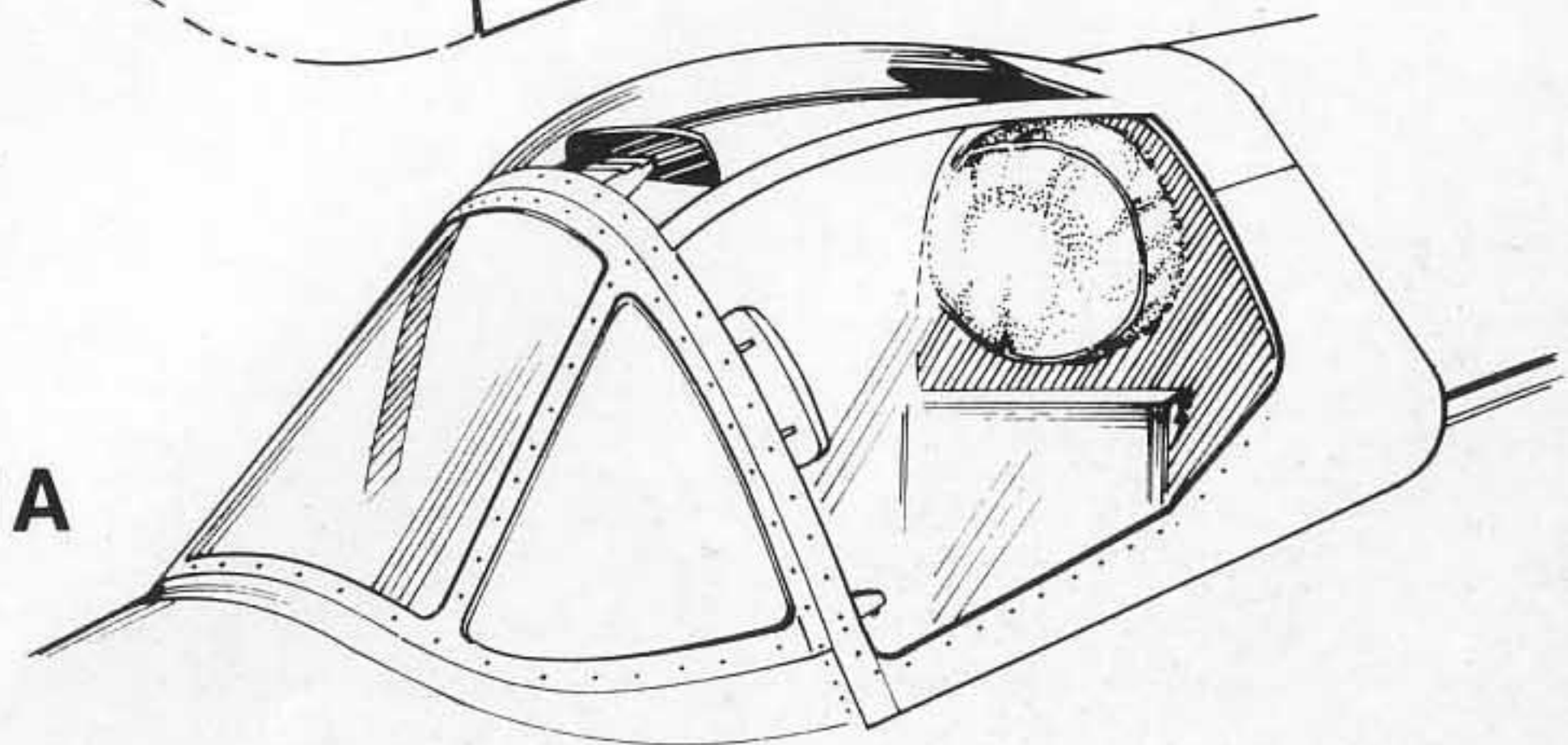

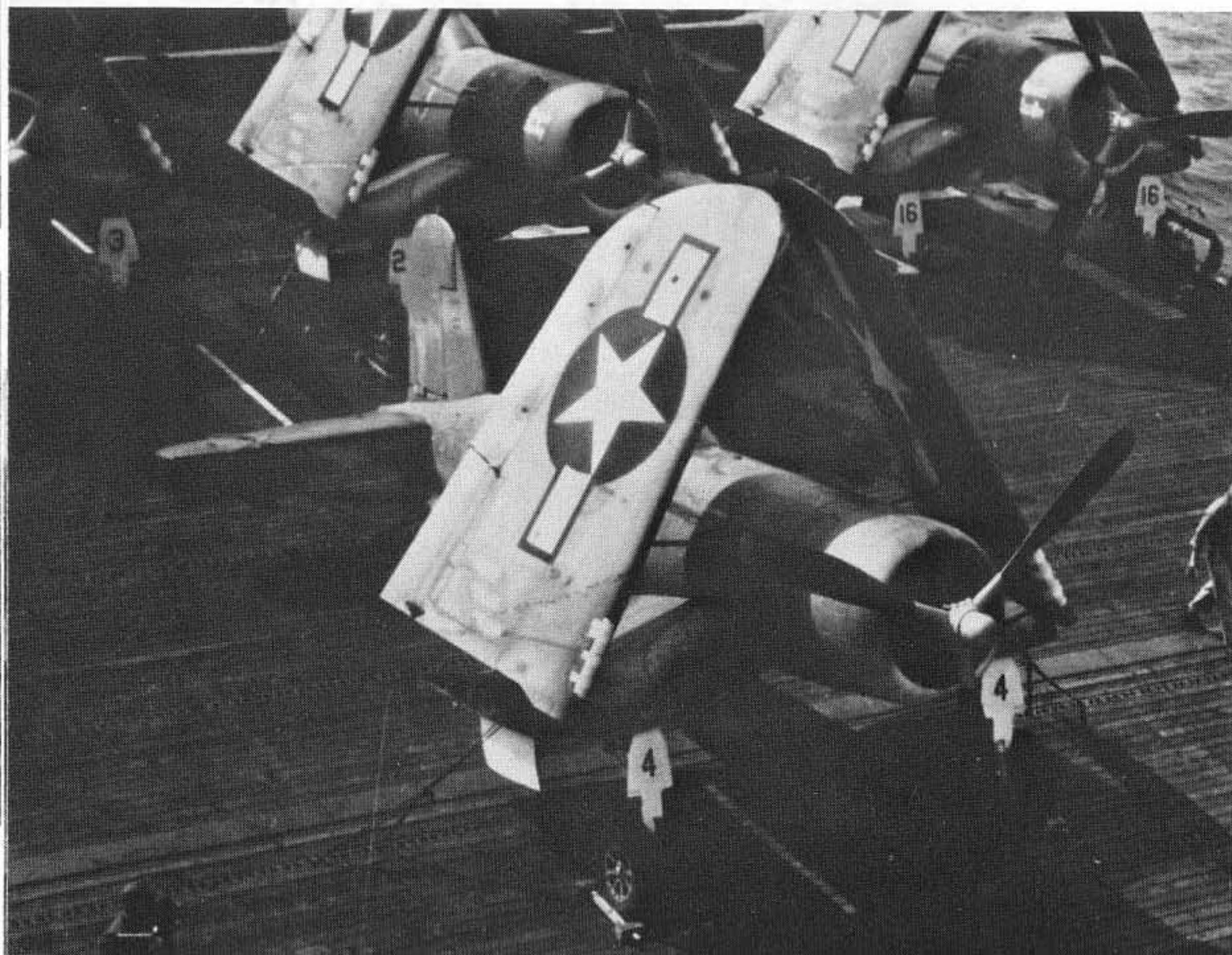

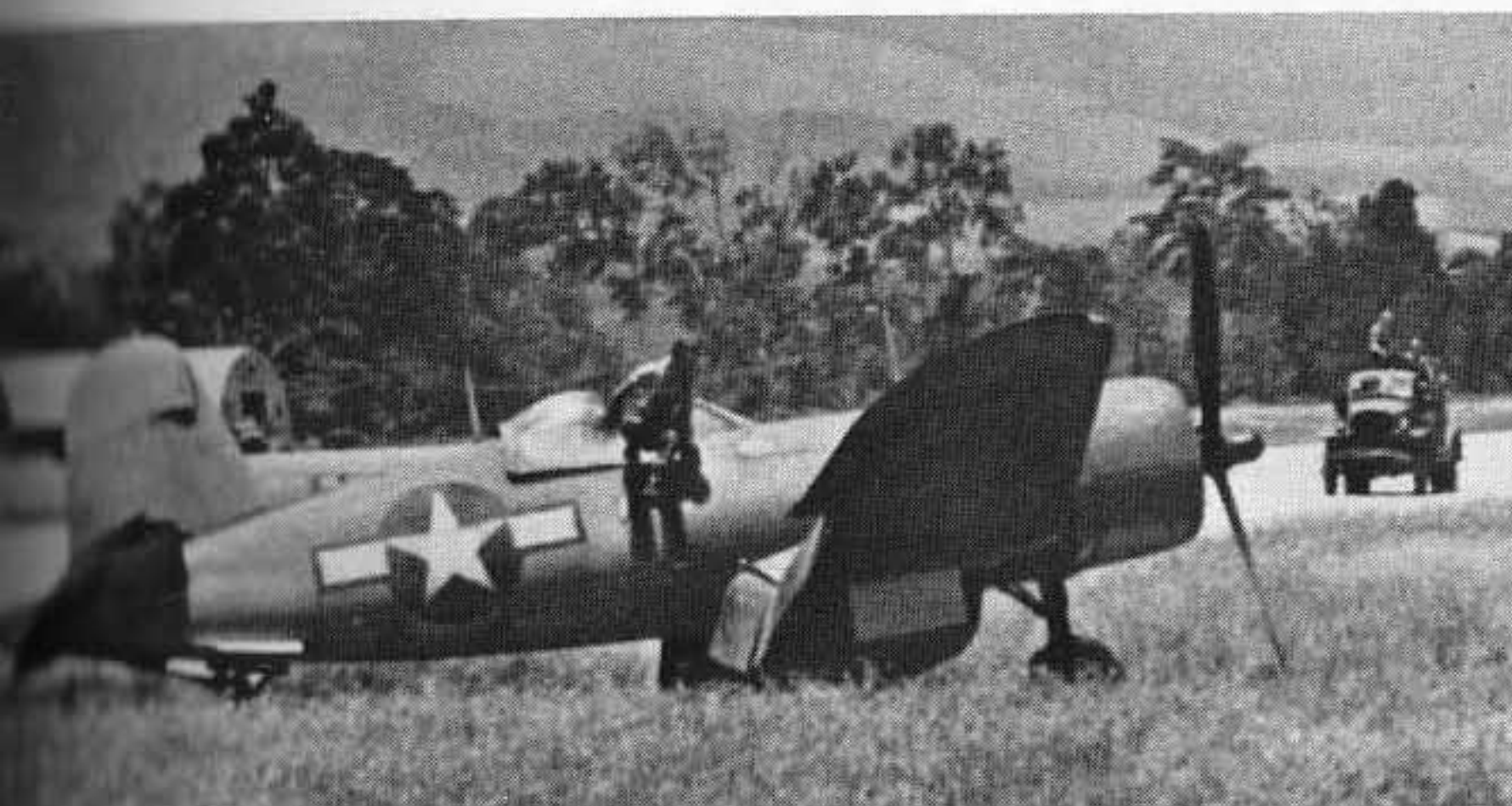


One of the most notorious of ill-fated flights occurred on January 25, 1944. After successfully launching all 24 of its Corsairs from the USS Kalinin Bay the day before, VMF-422 landed at Hawkins Field on Tarawa Atoll. On the morning of January 25, 23 of the 24 planes departed for the 700 mile trip to Funafuti with a stop-over planned for Nanomea, a distance of 463 miles from Tarawa. The Squadron lifted off at 0930 in fair weather. The flight was uneventful for a little over 2 hours until just 15 minutes out of Nanomea. Rain squalls covered them up. Dropping down to 200 feet, Maj. MacLaughlin, the C.O., passed the word for the flight to stay tight on him. Several sharp turns in the soup resulted in everyone being lost. Nevertheless, all but 3 pilots were able to stay together for a while longer. Of these 3 pilots who got separated from the others, one flew on all the way to Funafuti non-stop and landed safely there with 80 gallons of fuel left. One was never heard of again and the third managed to land on Niutao Island where he was found by friendly natives. The remaining 20 pilots and planes continued on coming into the clear over Nui Island about halfway between Nanomea and Funafuti. Two more dropped out in the water with one surviving. Now there were 18. After hitting another squall, 2 more were lost including MacLaughlin. Now there were 16. Shortly it became 15 as one more went in. Running short of fuel, it was decided that they would all ditch together while they could. Before they got into the water, two more strayed off from the others, leaving 13 that ditched together. After 2 days in the water a PBY spotted them but was damaged in the water landing and the whole lot had to be picked up by the USS Hobby. The cost in human life was enormous, 6 pilots lost their lives and of the 23 F4Us that left Hawkins Field, 22 of them were destroyed. [National Archives]

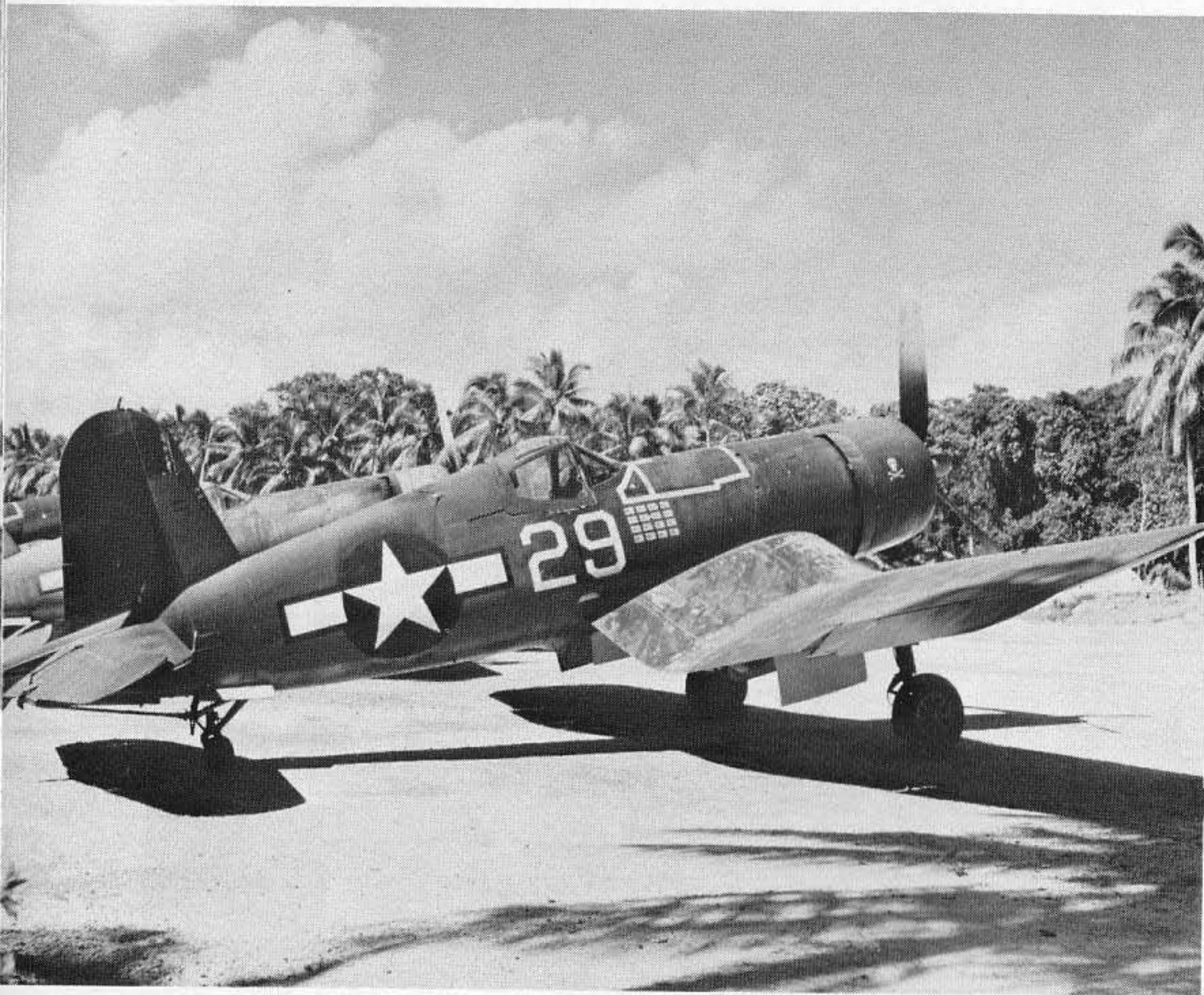

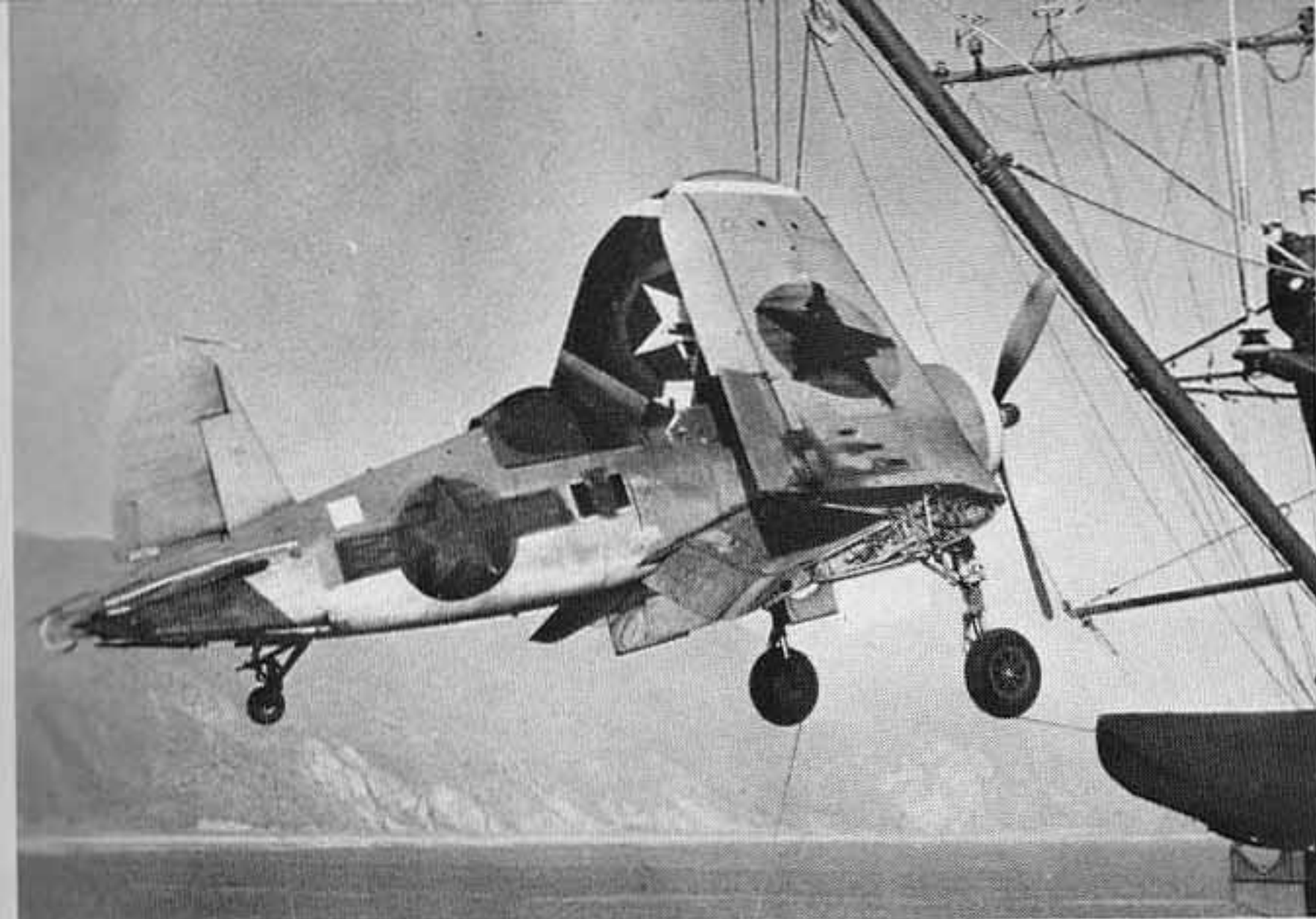

As the war raged on in the Pacific, Vought, Goodyear and Brewster were busy turning out Corsairs and by the 13th of May 1944, 3000 F4Us had been produced. As fast as they rolled off the assembly line, they were ferried out to squadrons and loaded aboard carriers for delivery to the combat zone. The war-weary earlier versions were returned by the same carriers and overhauled and assigned to a training role at bases in the States. Miramar, Santa Barbara, Jacksonville, Cherry Point, El Centro and others trained Navy and Marine pilots to fly the Corsair. 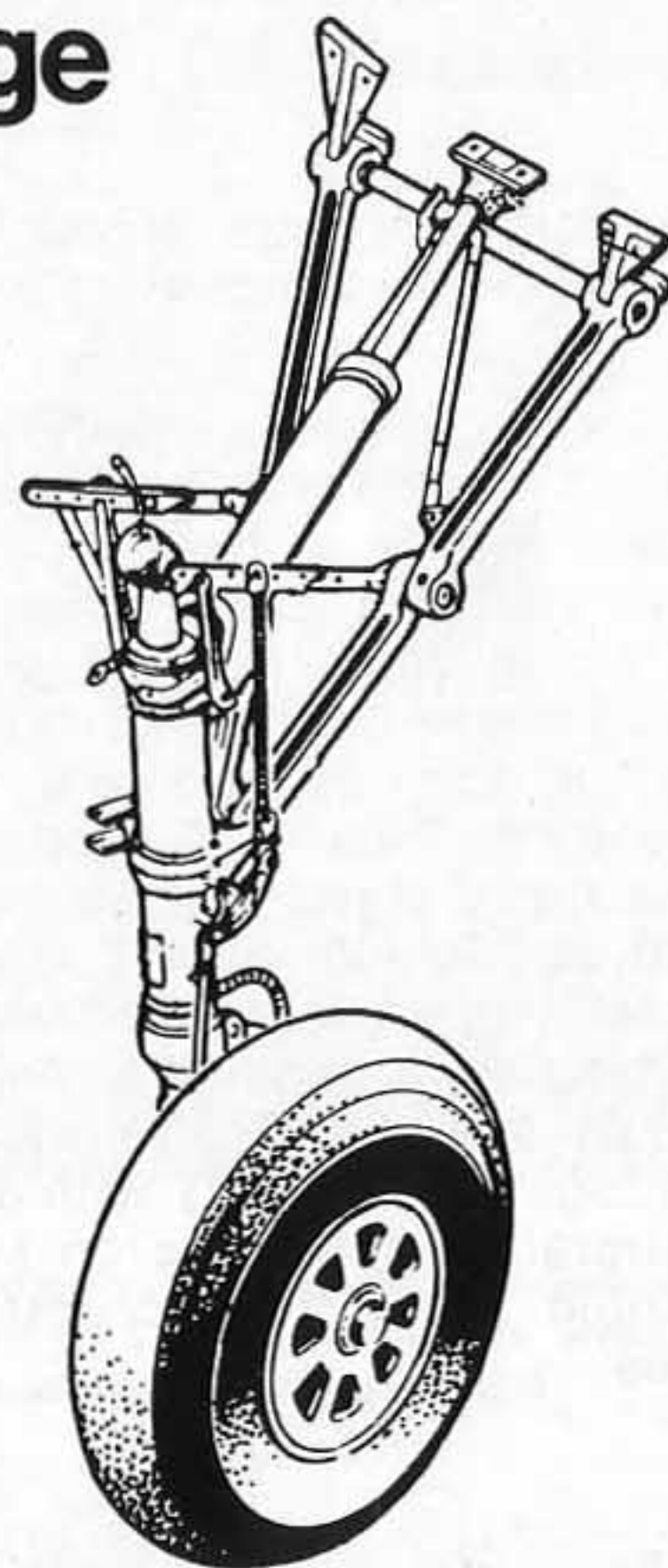

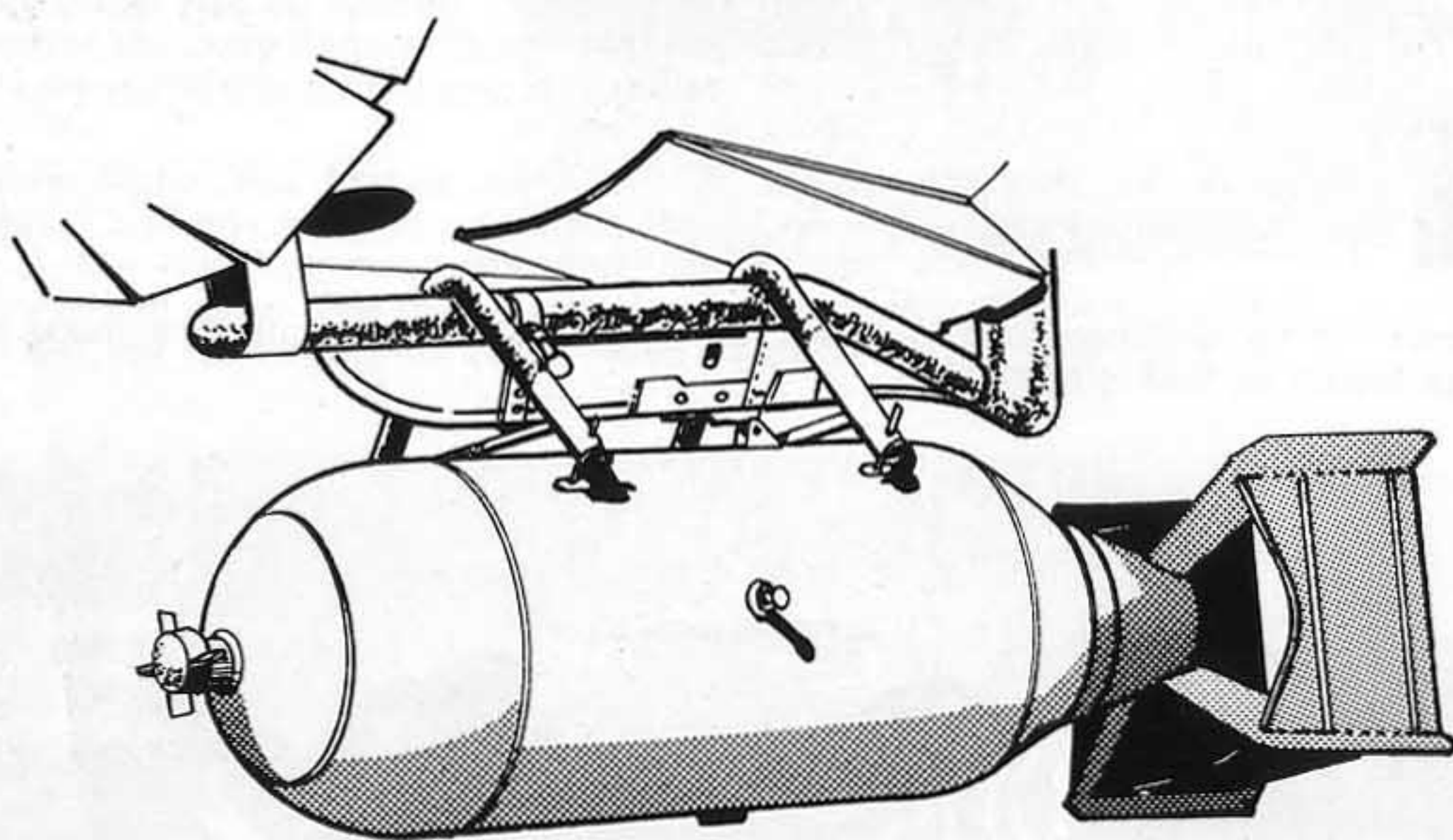

The fighter-bomber concept became a reality early in 1944 as members of VMF-222 worked to perfect a bomb-toting rack and release mechanism for the Corsair. Similar work was going on with VF-17. Vought factory representatives including Col. Charles A. Lindburg, Lou Markey and Ray DeLeva assisted the personnel in perfecting the rig. After thorough ground checks for strength and stability, the green light was given for flight test. Col. Lindburg, representing United Aircraft, flew the test with a 1000-lb bomb on the rack. Taking off on the Green Island bomber strip, the F4U-1A needed little extra runway to become airborne. Subjecting the rig to steep high-speed dives and maneuvers, Col. Lindburg found the Corsair handling well and proceeded to successfully release the bomb. After landing the test was given an enthusiastic thumbs-up, the modification was workable. Spreading rapidly to other squadrons, a new chapter had just opened for the Corsair. The first Marine fighter-bomber strike was flown by the "Devildogs" of VMF-111 with 8 modified Corsairs on March 18, 1944 against anti-aircraft installations on Mille atoll. Later experiments proved that Corsairs could safely and accurately deliver bombs in diving angles up to 85 degrees.

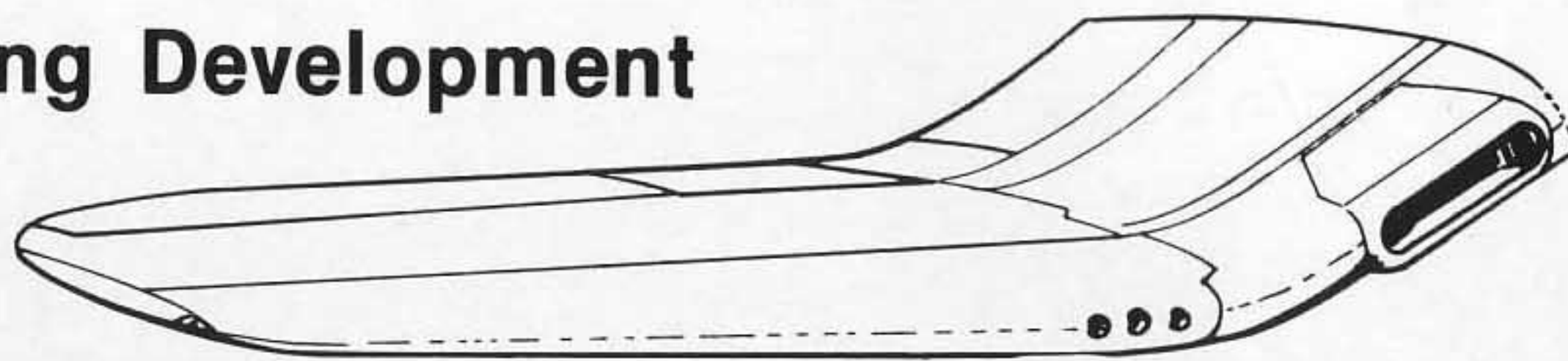

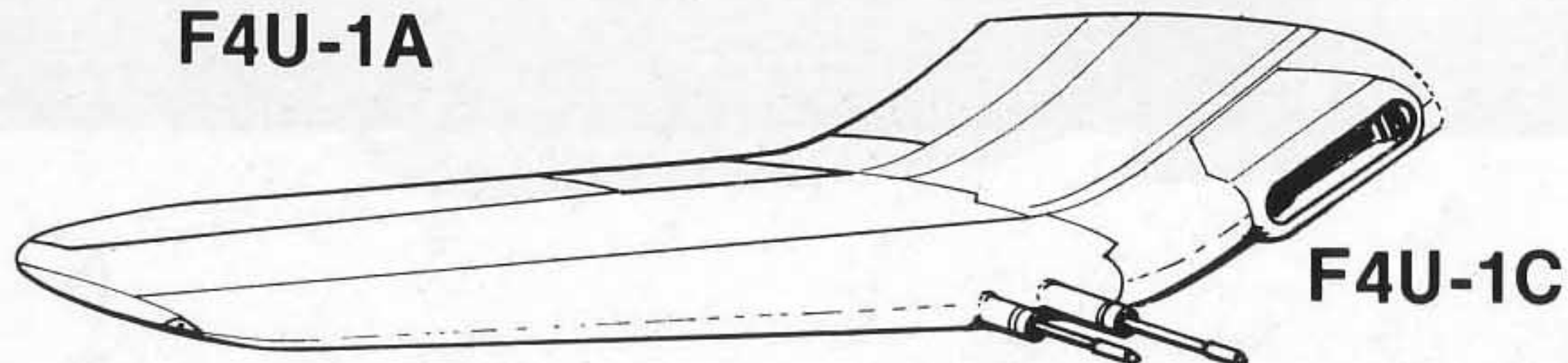
## F4U-1C

The F4U-1C differed from the F4U-1A in armament. In place of the 6-.50 cal. guns, Vought armed the "C" model with 4 20-mm M-2 cannons each having 20 rounds. Especially effective for ground strafing, the cannon-armed Corsair went into combat on April 7, 1945. Flying from the USS Breton, CMF-311 (Hells Belles) and VMF-441 (Black Jacks) took the F4U-1C's to Yontan Airfield on Okinawa. Vought produced an even 200 of these cannon-armed Corsairs.

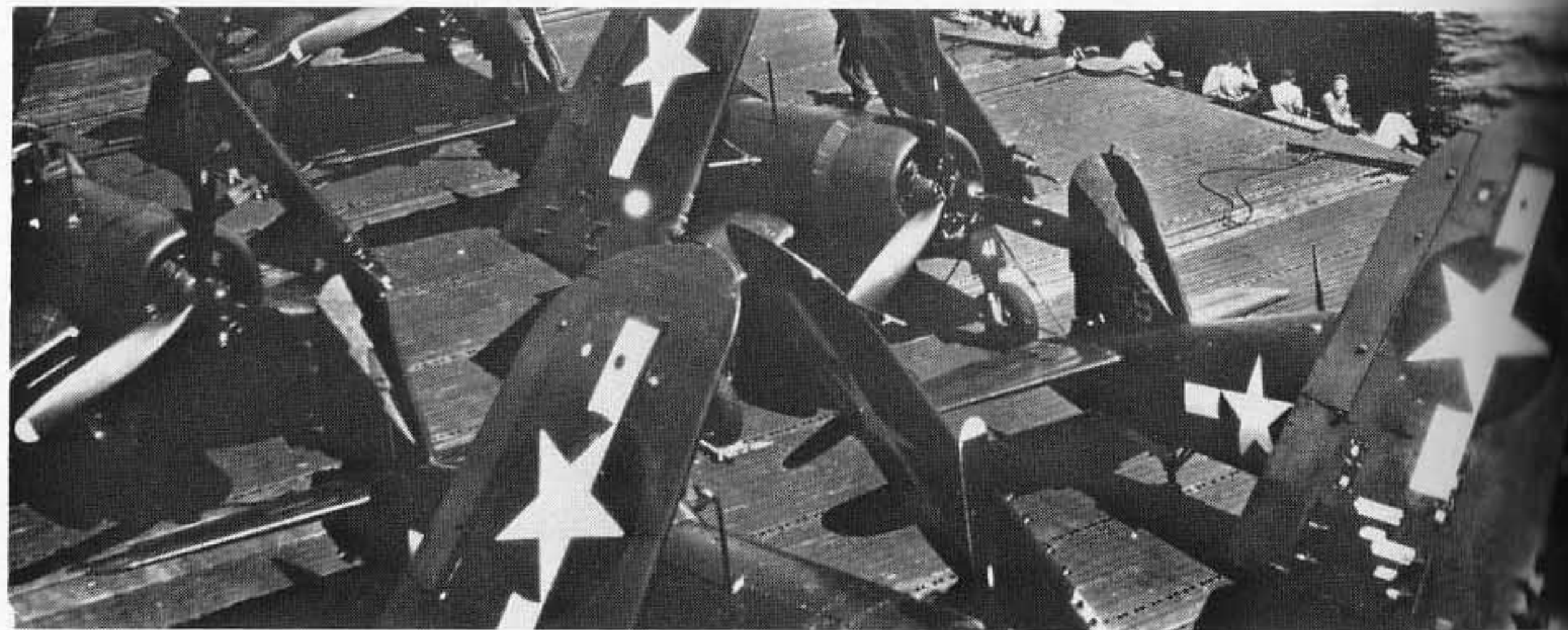

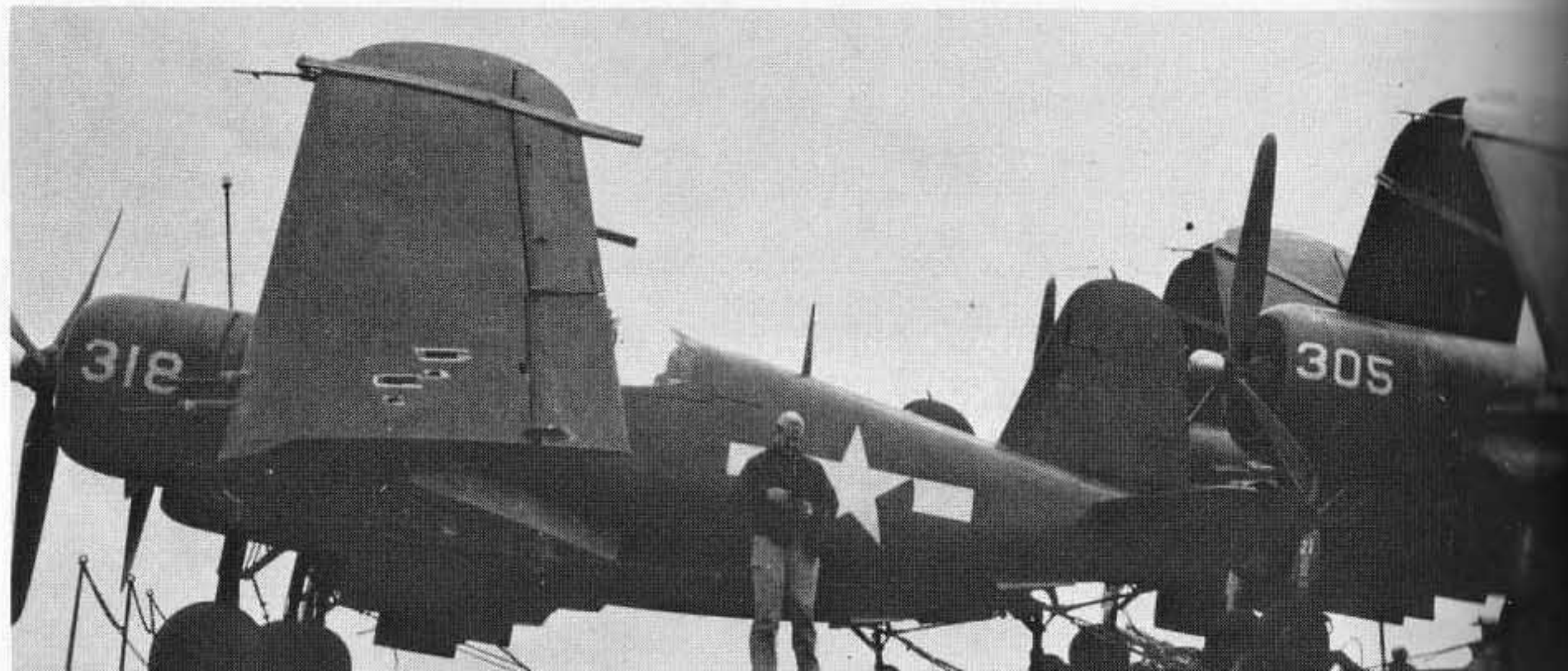

## F4U-1D

The Vought F4U-1D was the first factory-produced fighter-bomber version with a marked improvement over the F4U-1 model. Accepted by the Navy on April 22, 1944 and incorporating the increased performance P&W R-2800-8W engine with water injection, the -1D was capable of delivering 2250 hp for take-off or to escape from enemy aircraft. The water injection feature could be used for a maximum of 5 minutes in a combat-emergency situation. Twin-pylon installations were provided for carrying bombs or droppable 154-gallon fuel tanks or Napalm. In addition to these, a 3rd tank could be carried on a center-line attachment point. External rocket launching stubs were provided under each wing for 4 rockets. The upper braces in the sliding canopy were removed for better visibility in the later models. 3,862 of the -1D model were produced by Vought and Goodyear.

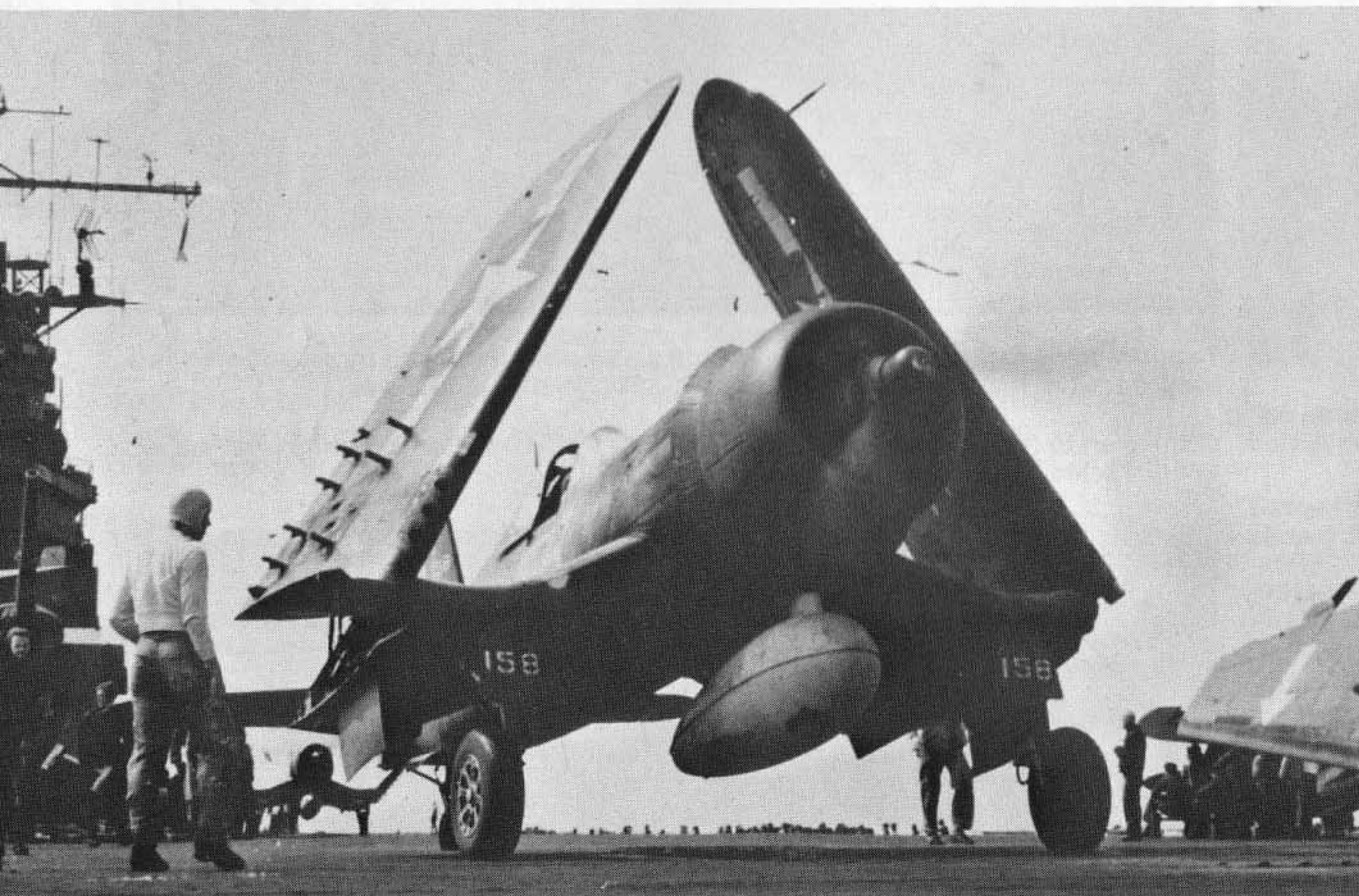

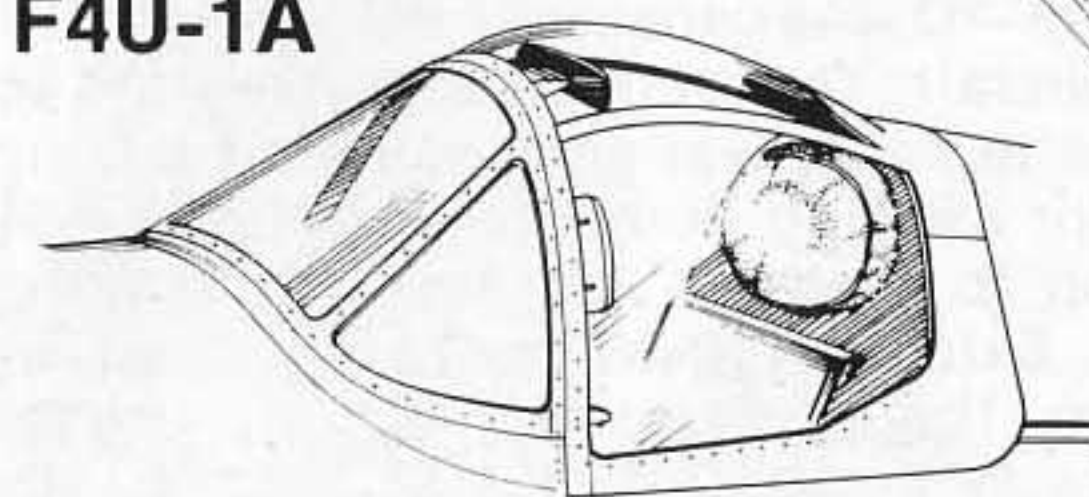

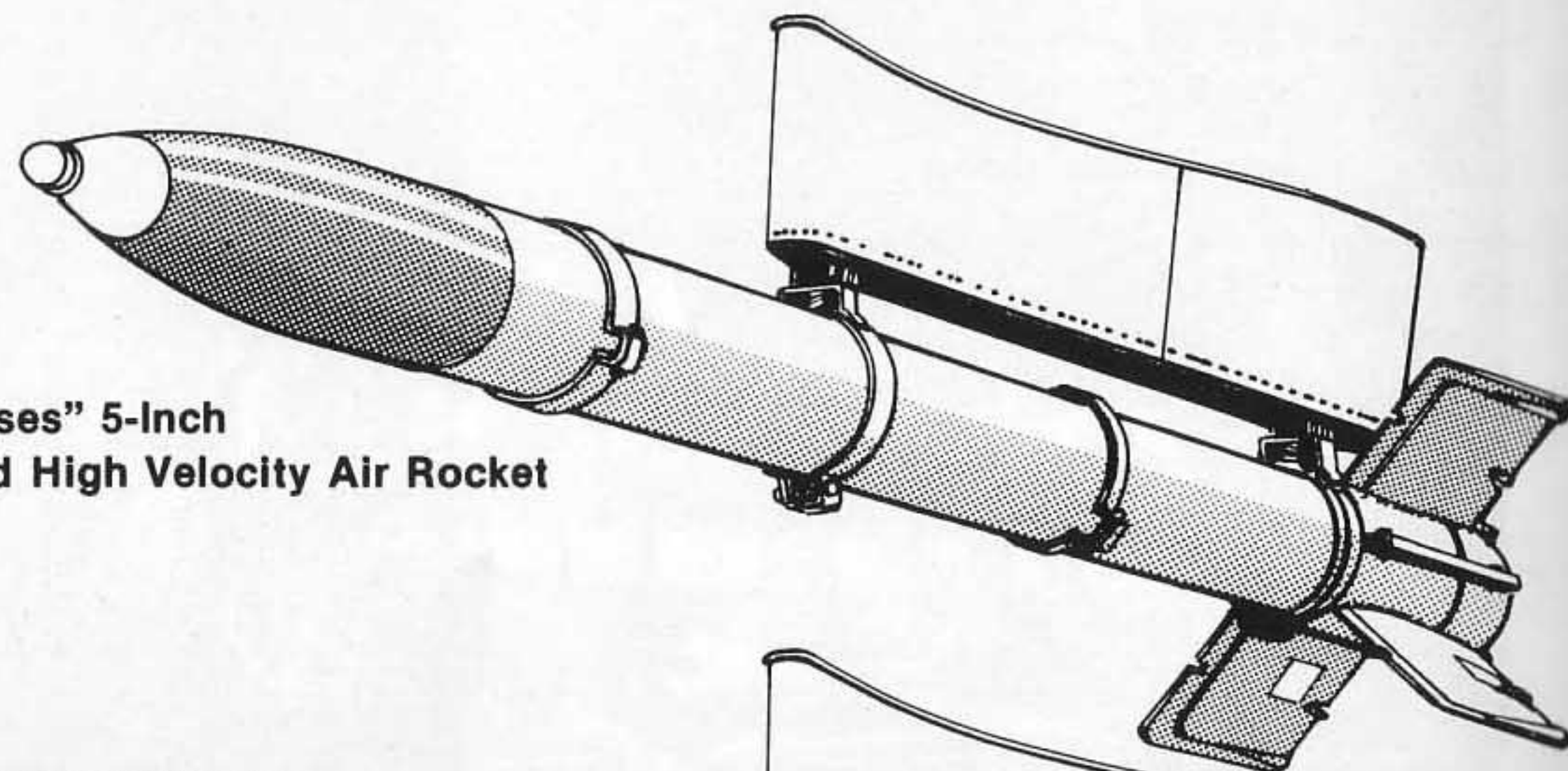

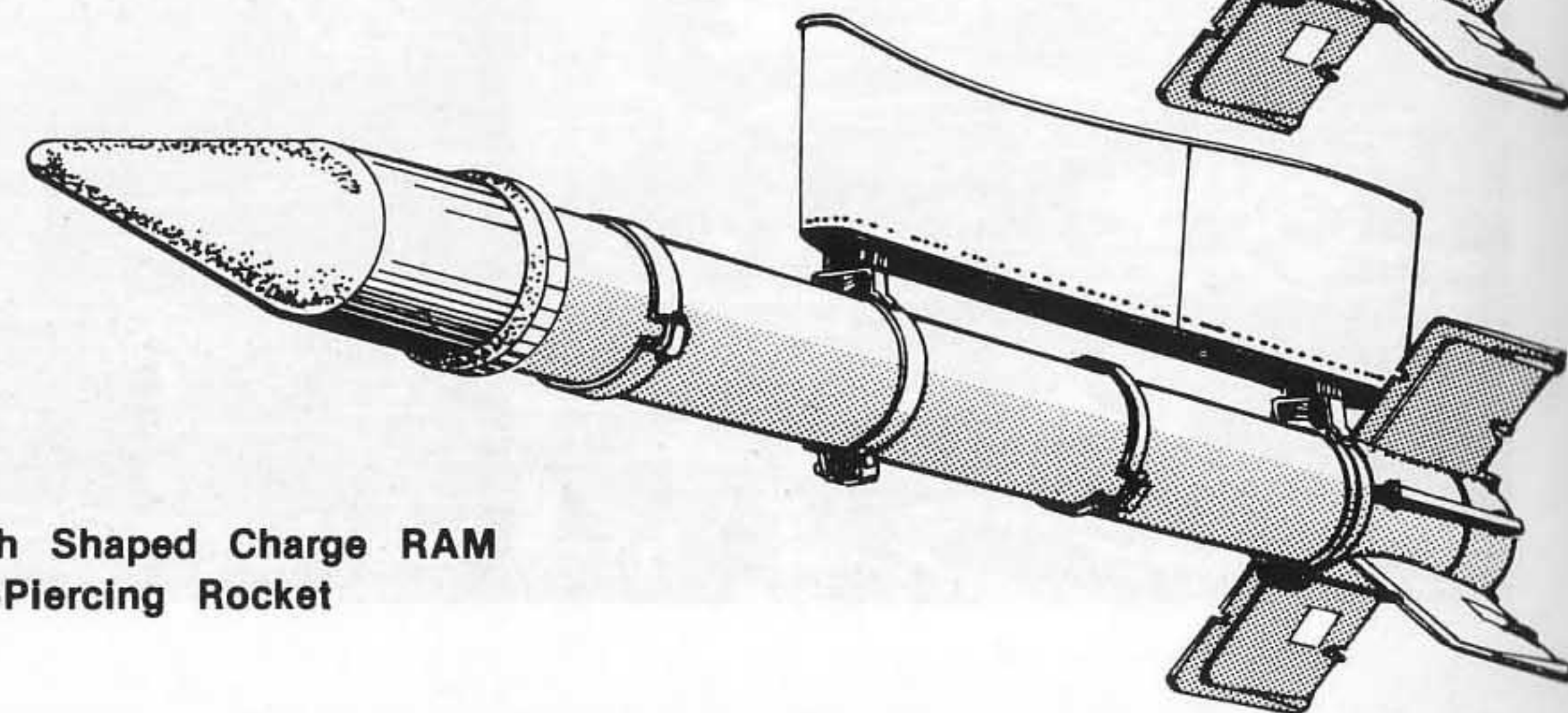

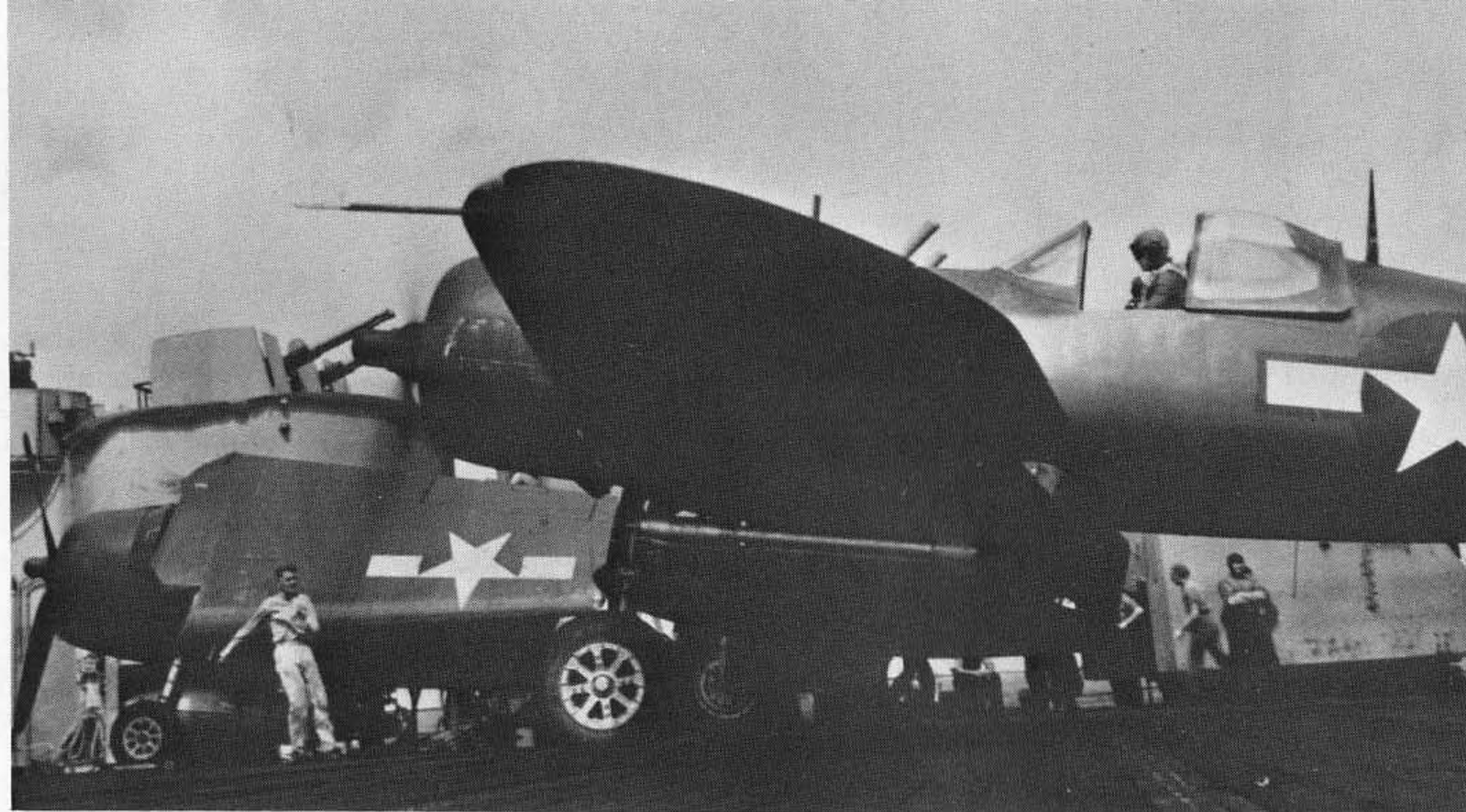

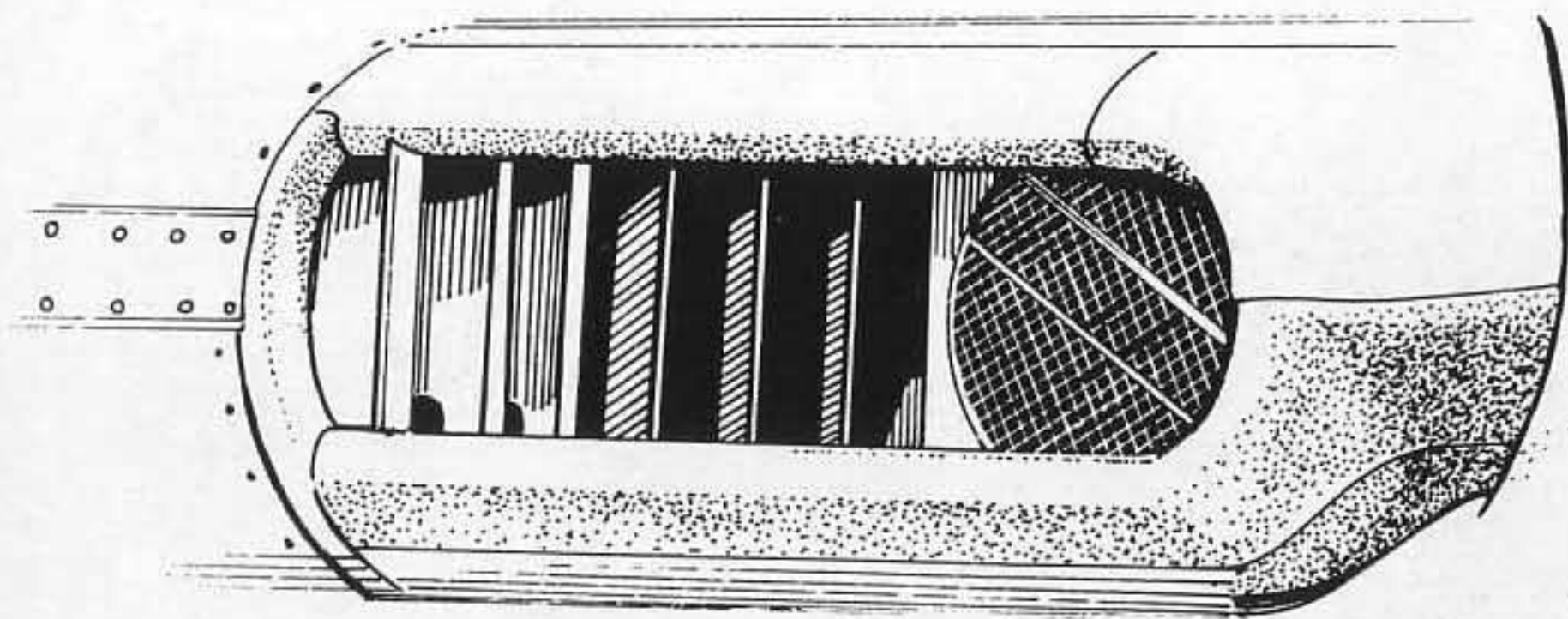

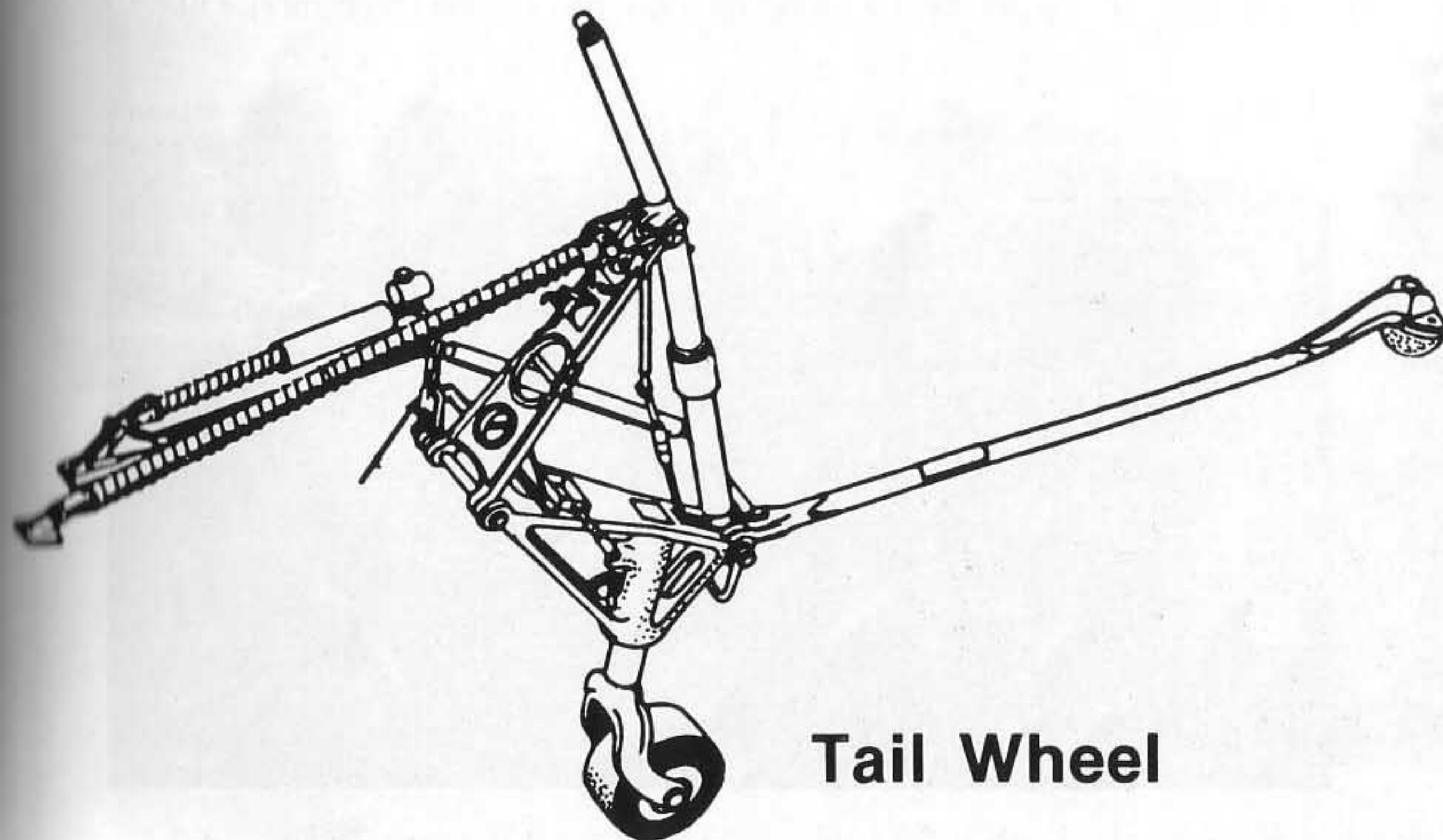

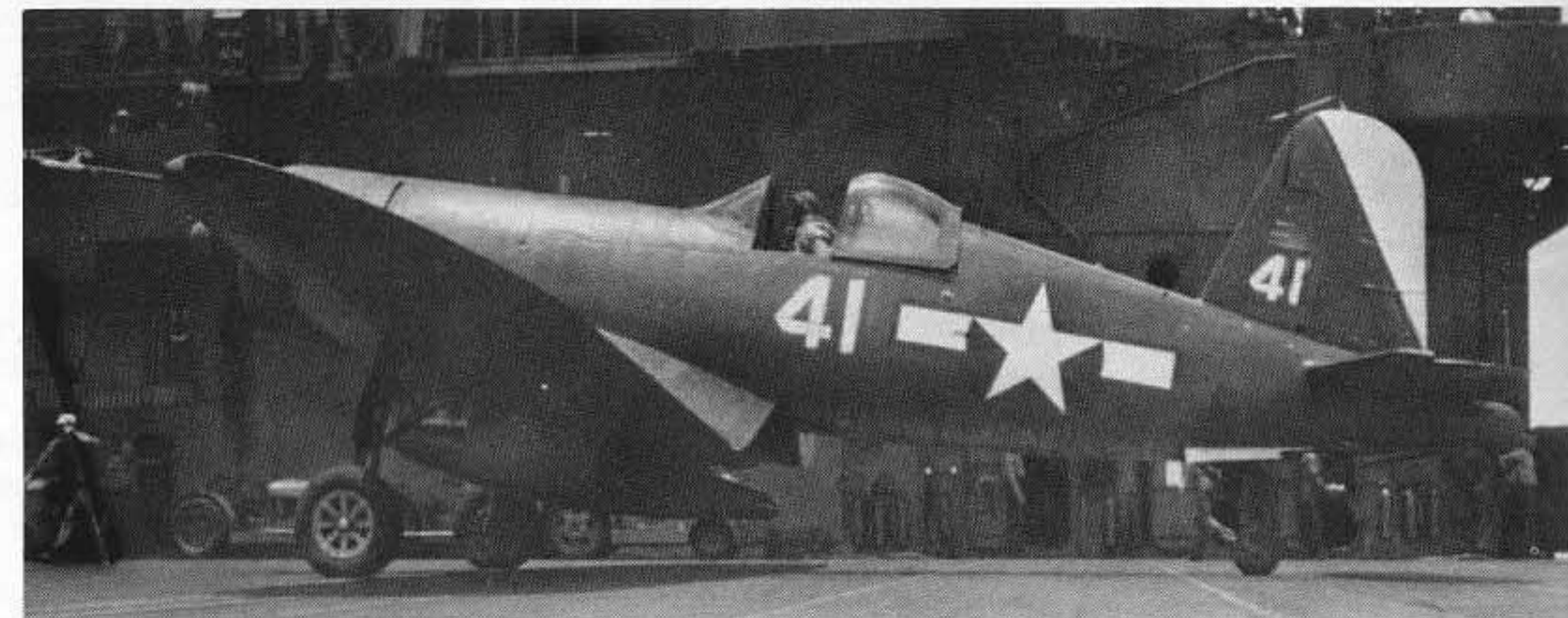




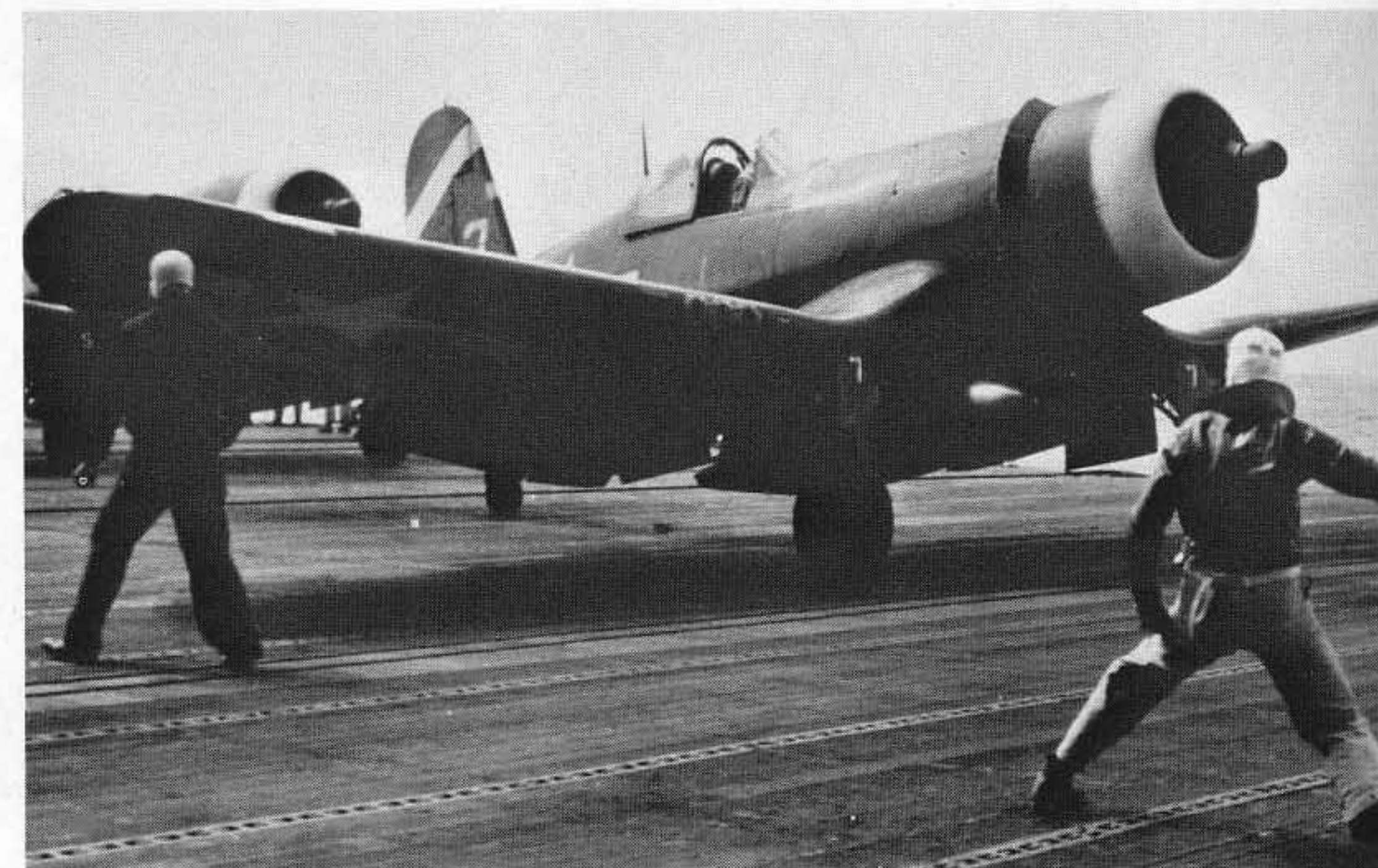

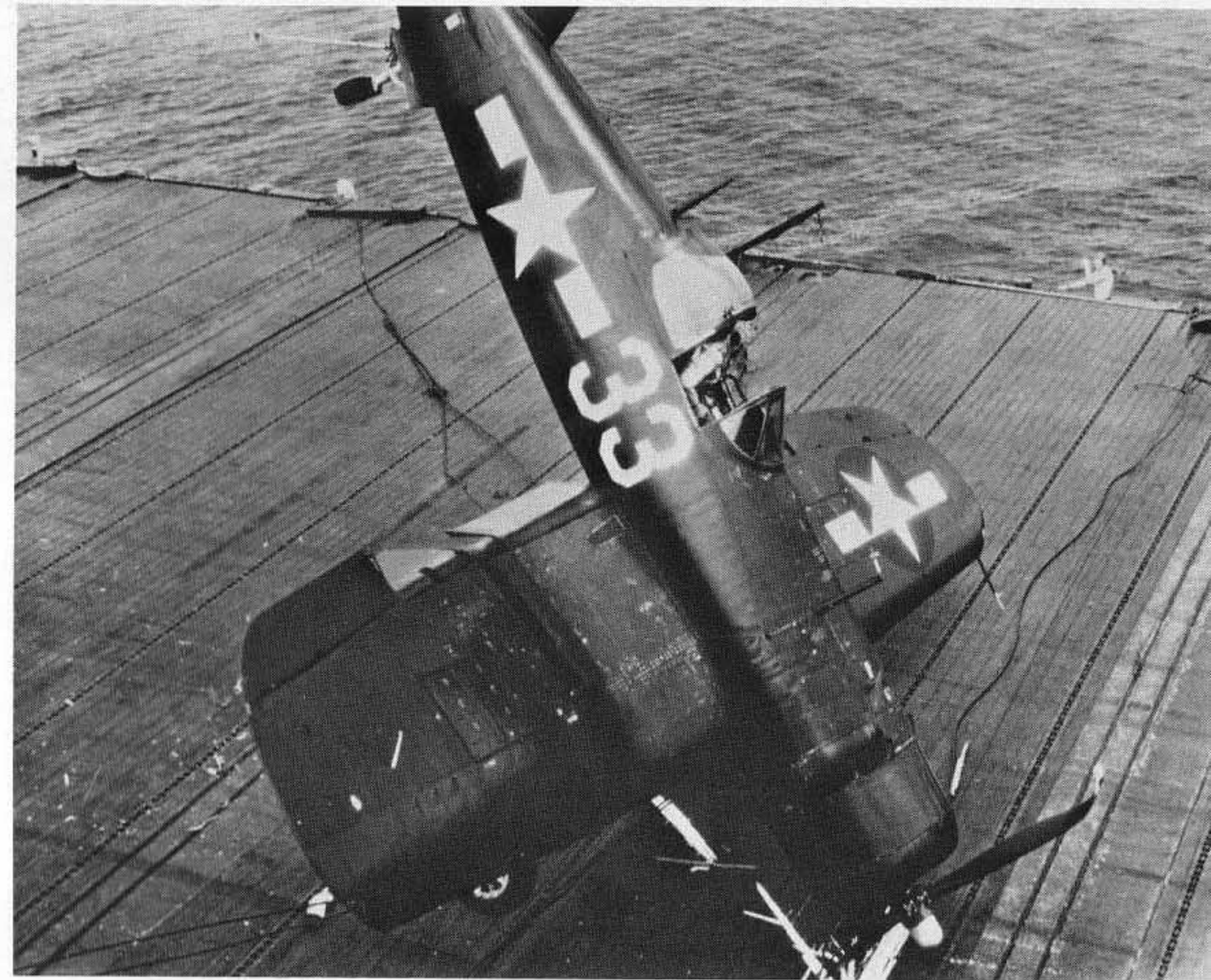

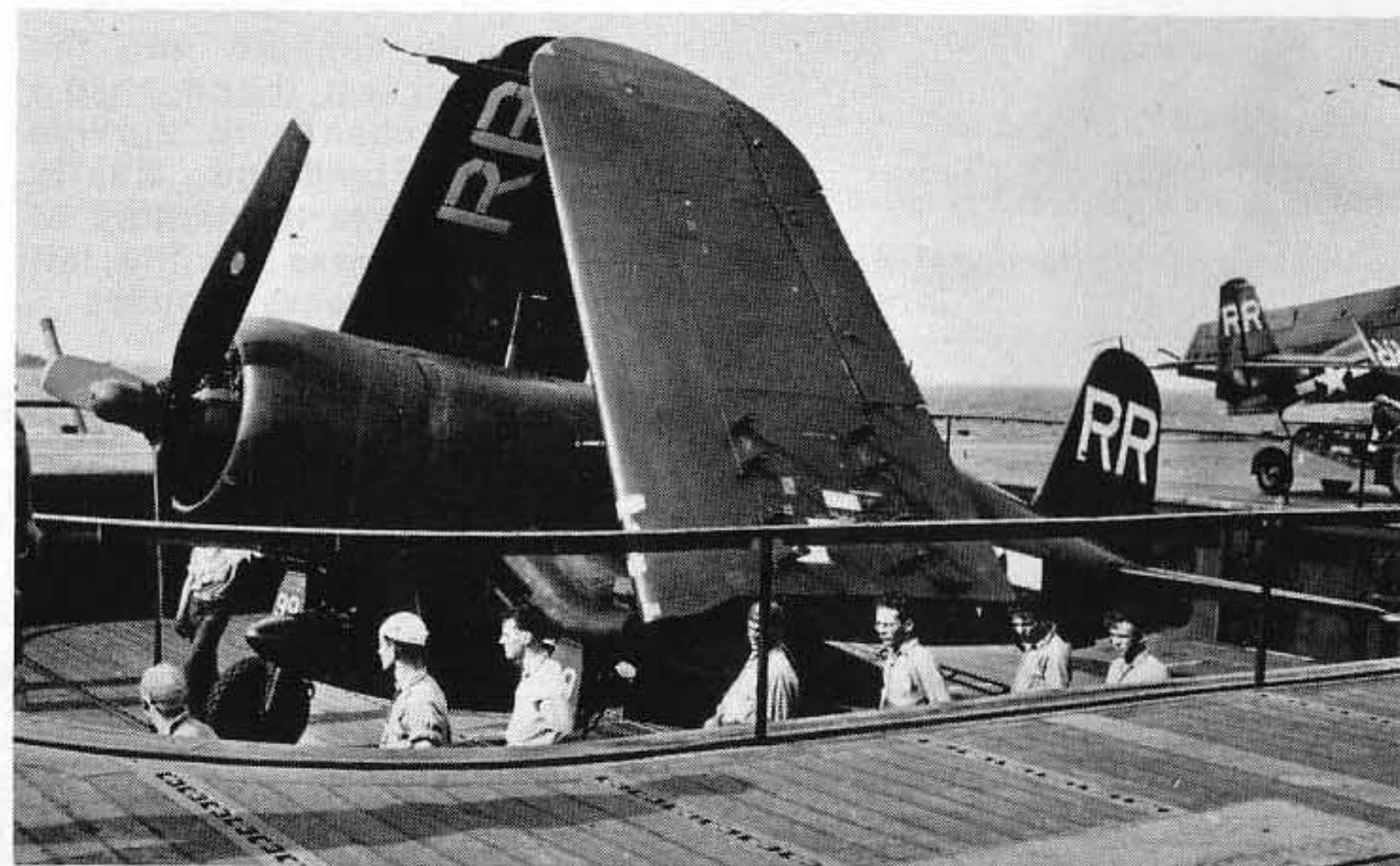

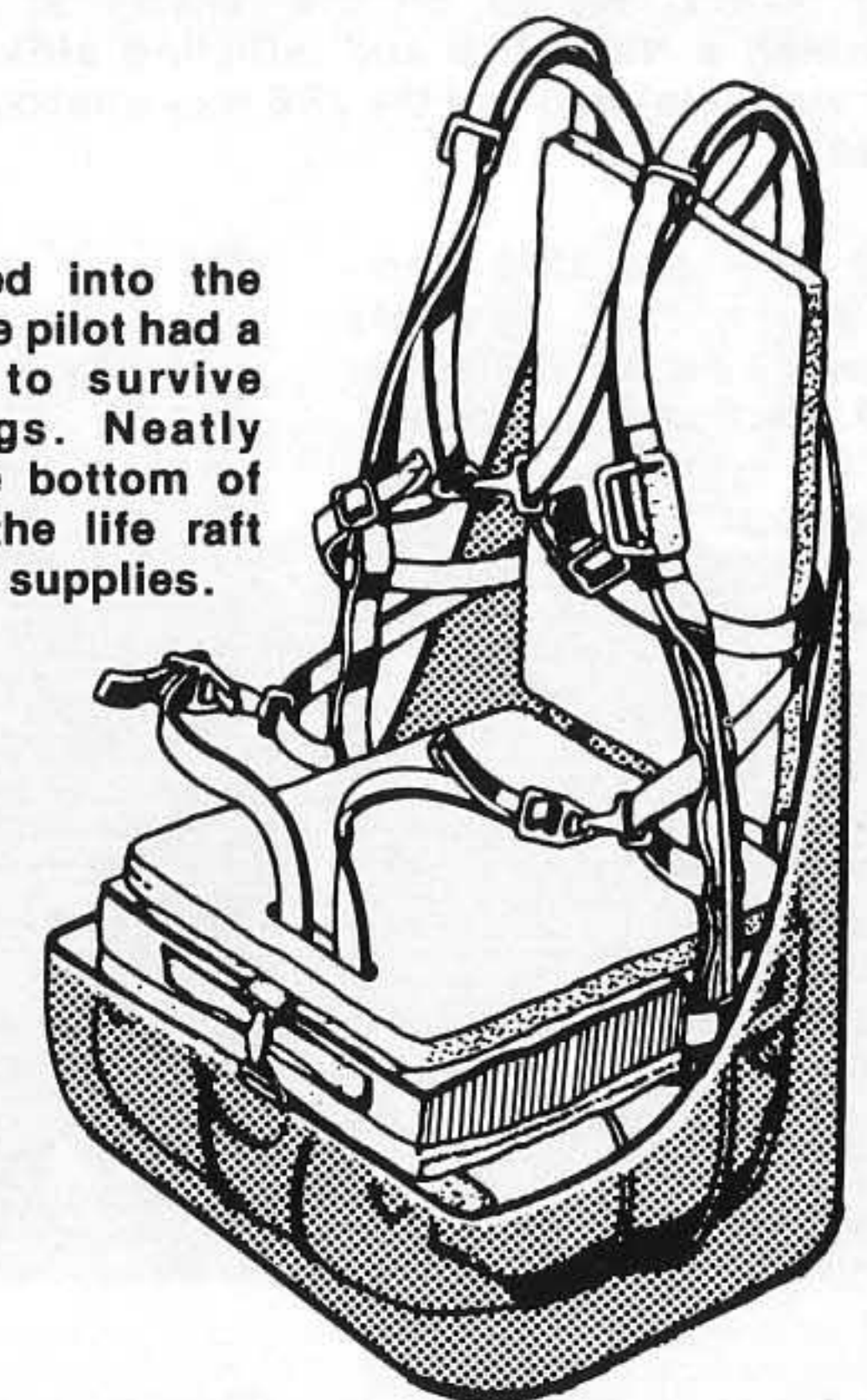
## F4U-1P

A field modification rather than a factory model, the photo reconnaissance version of the Corsair was essentially a F4U-1 that allowed the use of a K-21 aerial camera fitted to a special mount in the lower rear section of the fuselage. Controlled from the cockpit, this unit allowed the pilot to participate in a strike and record the results on film. Shortly after the Corsair returned to base the results of the effort were photographically available. Although the Marines are given credit for the development, both the USMC and NAVY used the F4U-1P modification.

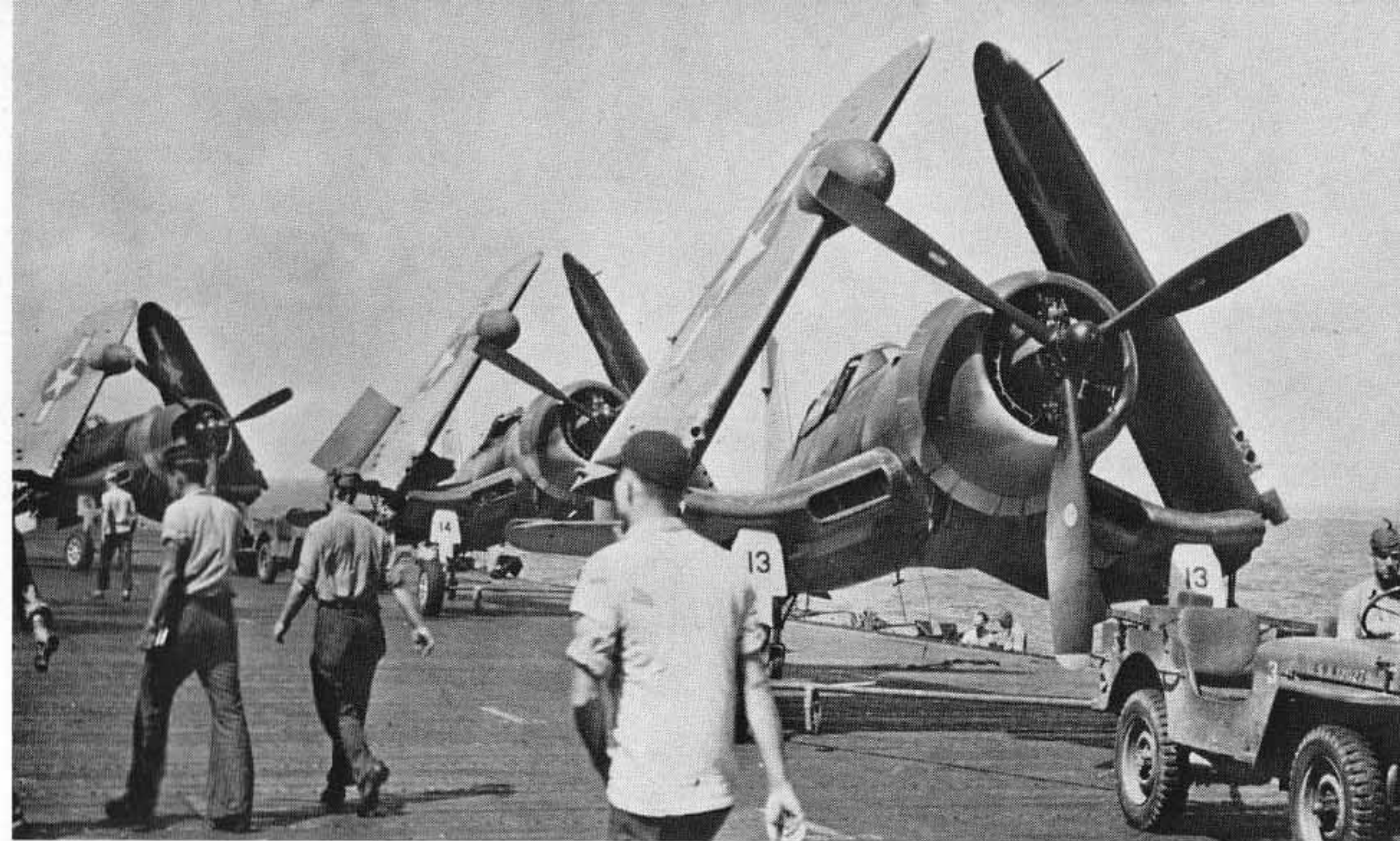
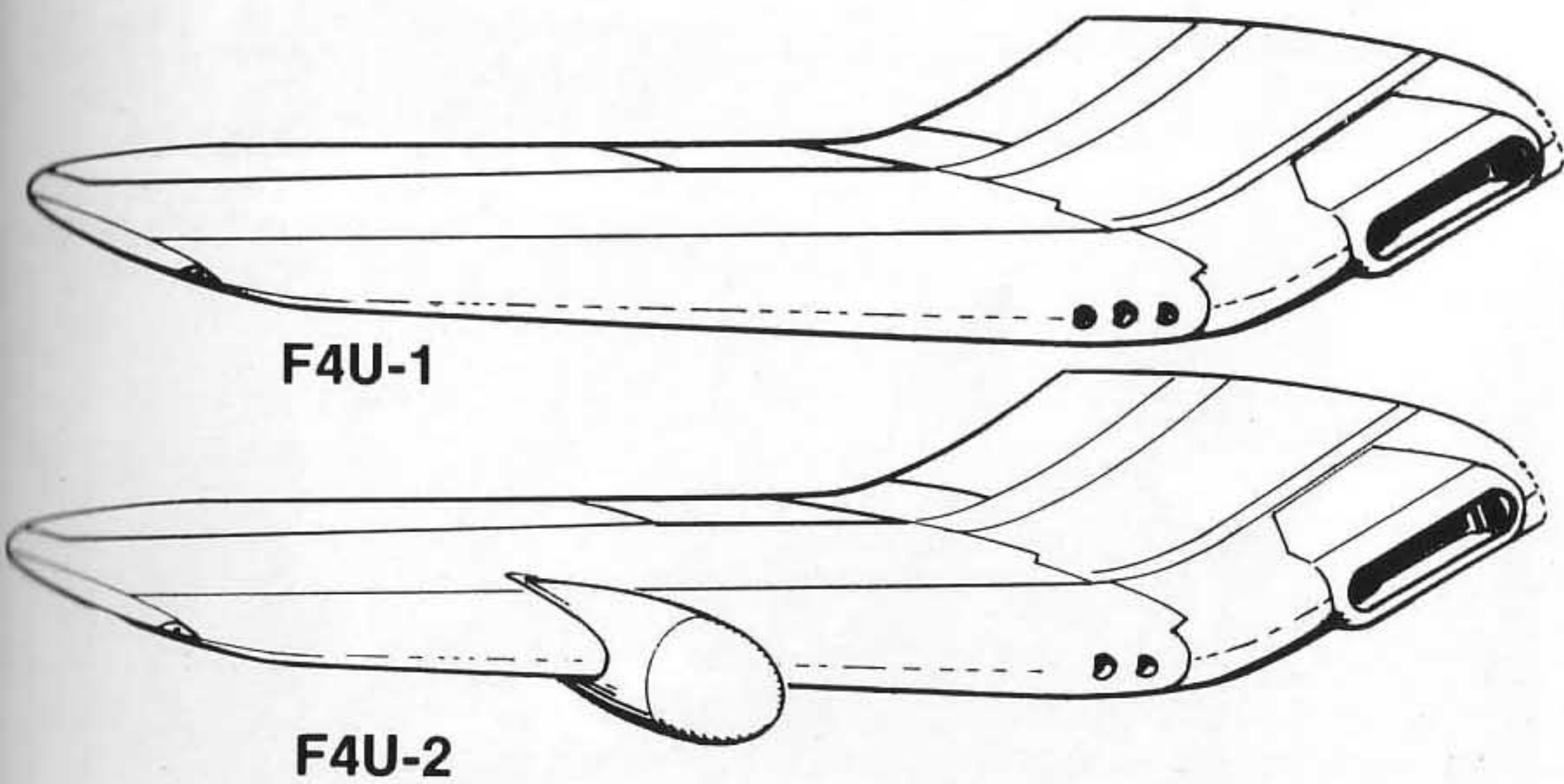




# F4U-2

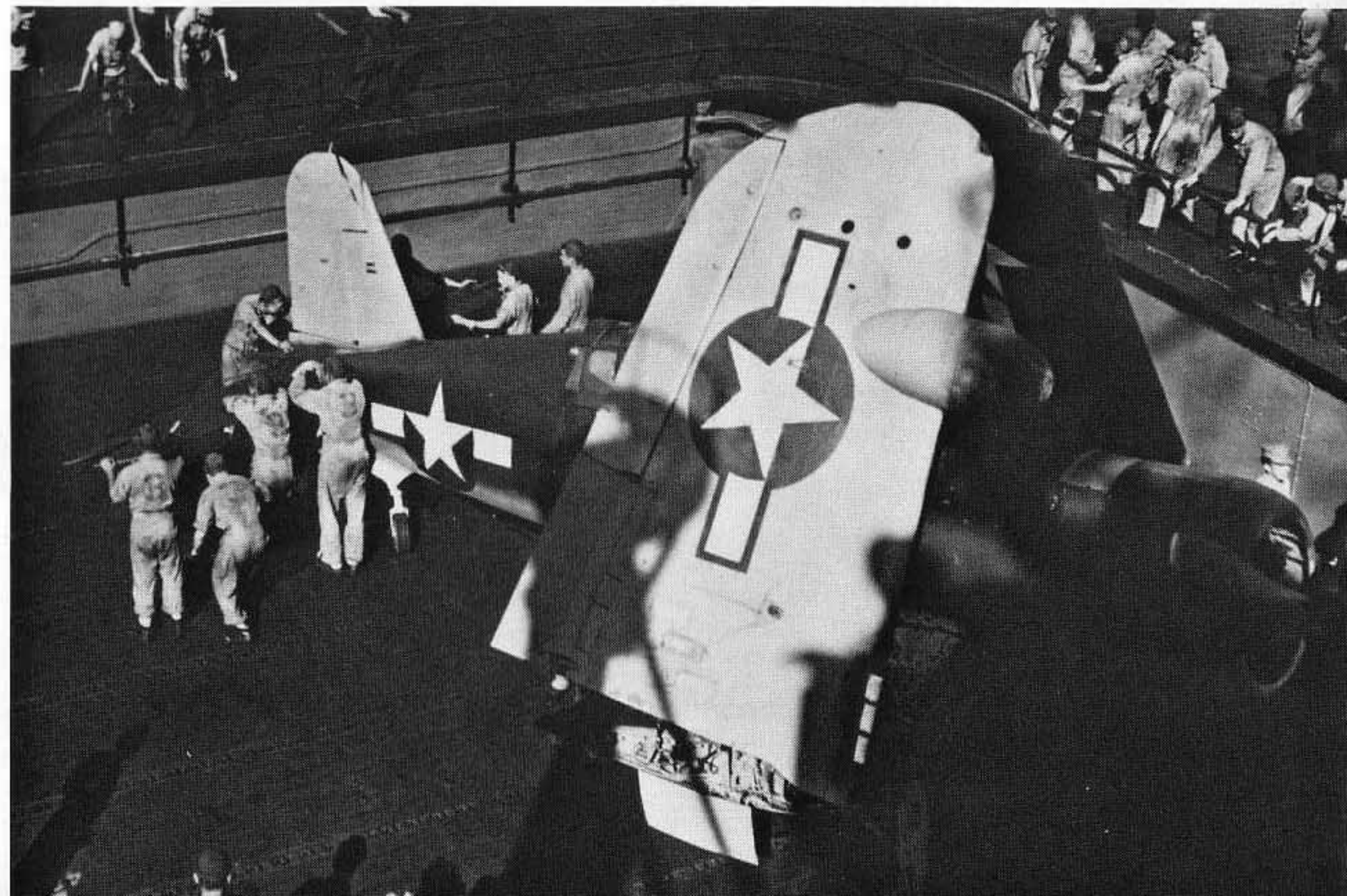
In November of 1941, the Navy requested Chance-Vought to provide a radar-equipped night fighter version of the F4U-1. Vought responded with a proposal for the F4U-2 and set to work on the project. Although a mock-up was constructed, the demand of the war effort to produce F4U-1 forced Vought to delay the F4U-2 project. The Navy then, in full cooperation with CV, assigned the project to the Naval Aircraft Factory and it was there that 32 of the 34 F4U-2 Corsairs were produced, the main changes to the F4U-1 being the addition of a starboard wing radome (weight compensation being the removal of the outboard .50-cal. gun on the starboard wing), radar/transmit/receive equipment in the radio compartment, a radio altimeter system and an increased output generator. To eliminate the exhaust flames for night fighting, flame dampeners were added to the six exhaust stacks on the P&W R-2800-8 engine. The remaining two F4U-2s were field-modified by VMF(N)-532 in the South Pacific. During the operational life of the F4U-2, three units were equipped with them, VMF(N)-532, VF(N)-75 and VF(N)-101. This pioneer night-fighter developed the technology and paved the way for night-fighter tactics during WWII.

## **F2G**

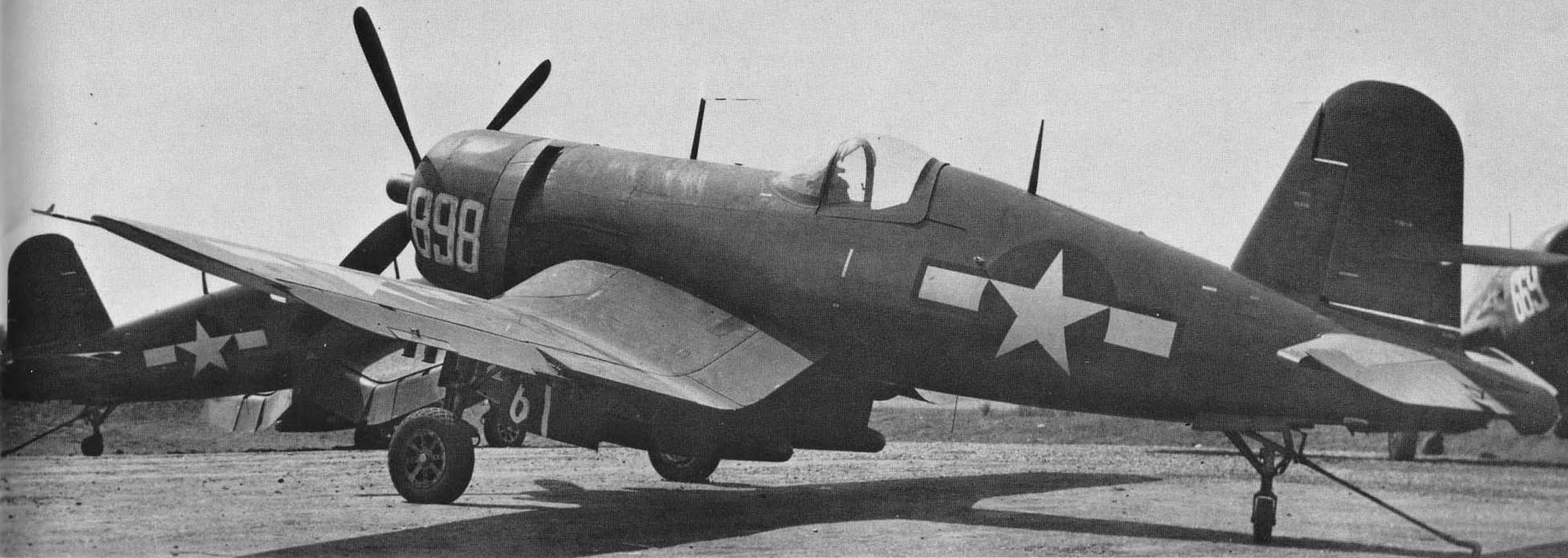
Late in the war, Goodyear was approached by the Navy to build a high-performance version of the Corsair. Their reply was the F2G. This bubble-canopy version was to be built in two variants, the F2G-1, a land-based version with manually folding wings, and the F2G-2, a carrier version with hydraulically folding wings and arresting hook. Powered by the P&W R-4360-4 Wasp Major engine rated at 3000 HP, the F2G possessed a rate of climb that permitted it to reach 30,000 ft. in only 4 minutes. Armament was identical to that of the F4U-1D/FG-1D. Including the "X" models, 18 F2Gs were completed and flown by Goodyear before the contracts were cut back and the war was over. The F2G-1D featured an auxiliary rudder that is clearly visible in the photo above.

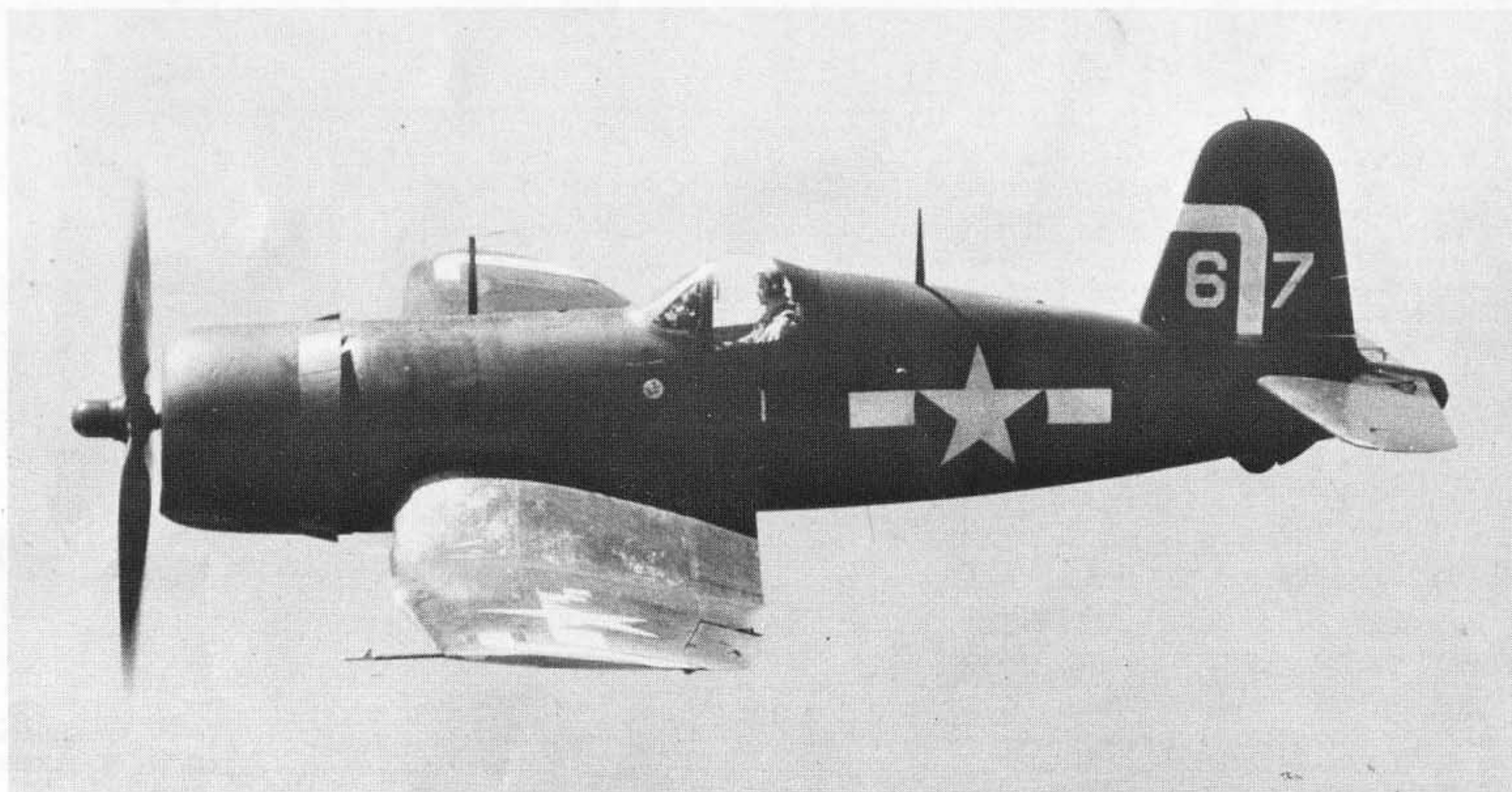

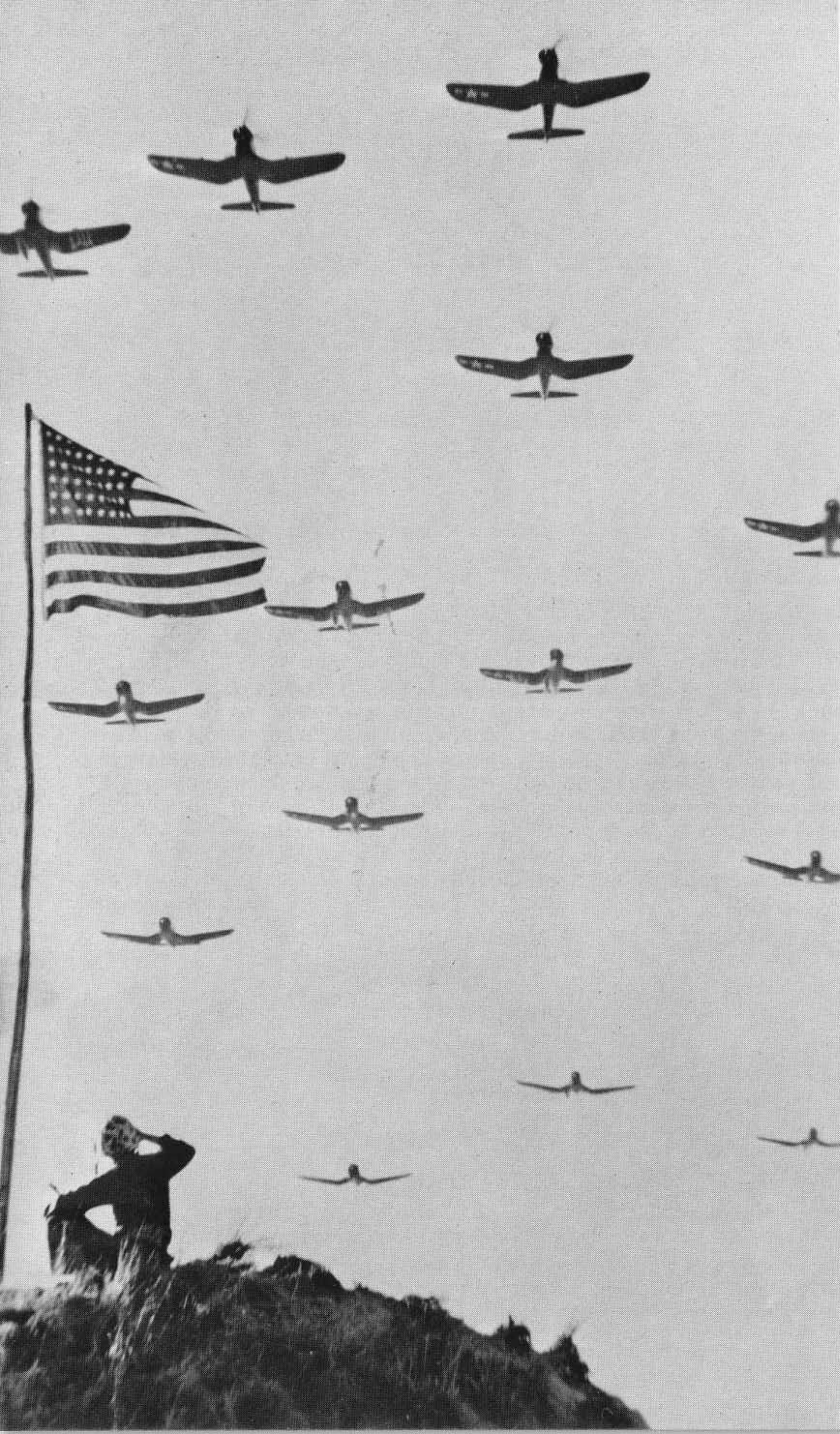
## F4U-4

The Navy's final acceptance of the first production F4U-4 (80759) came on October 31, 1944 and production of the first of the four-bladed prop Corsairs began. The F4U-4 was powered by P&W R-2800-18W engine (R-2800-42W in later -4 models) and rated as a 451 mph fighter. In addition to the 4-bladed prop and chin scoop, the F4U-4 had a redesigned cockpit to provide greater efficiency, visibility and comfort. 2,357 units were produced by Vought and although arriving late in WWII some were used by both the USN and USMC for the 4 months from May 1945 'til the end of the war. 2050 including the 5 "X" models were produced as the F4U-4 and armed with 6-.50 cal. machine guns, 297 F4U-4B models armed with 4-20mm cannons, 1 (97361) F4U-4N night-fighter with radar and 9 F4U-4P models for photo-reconnaissance. The final F4U-4 rolled off the Vought assembly line in August 1947.

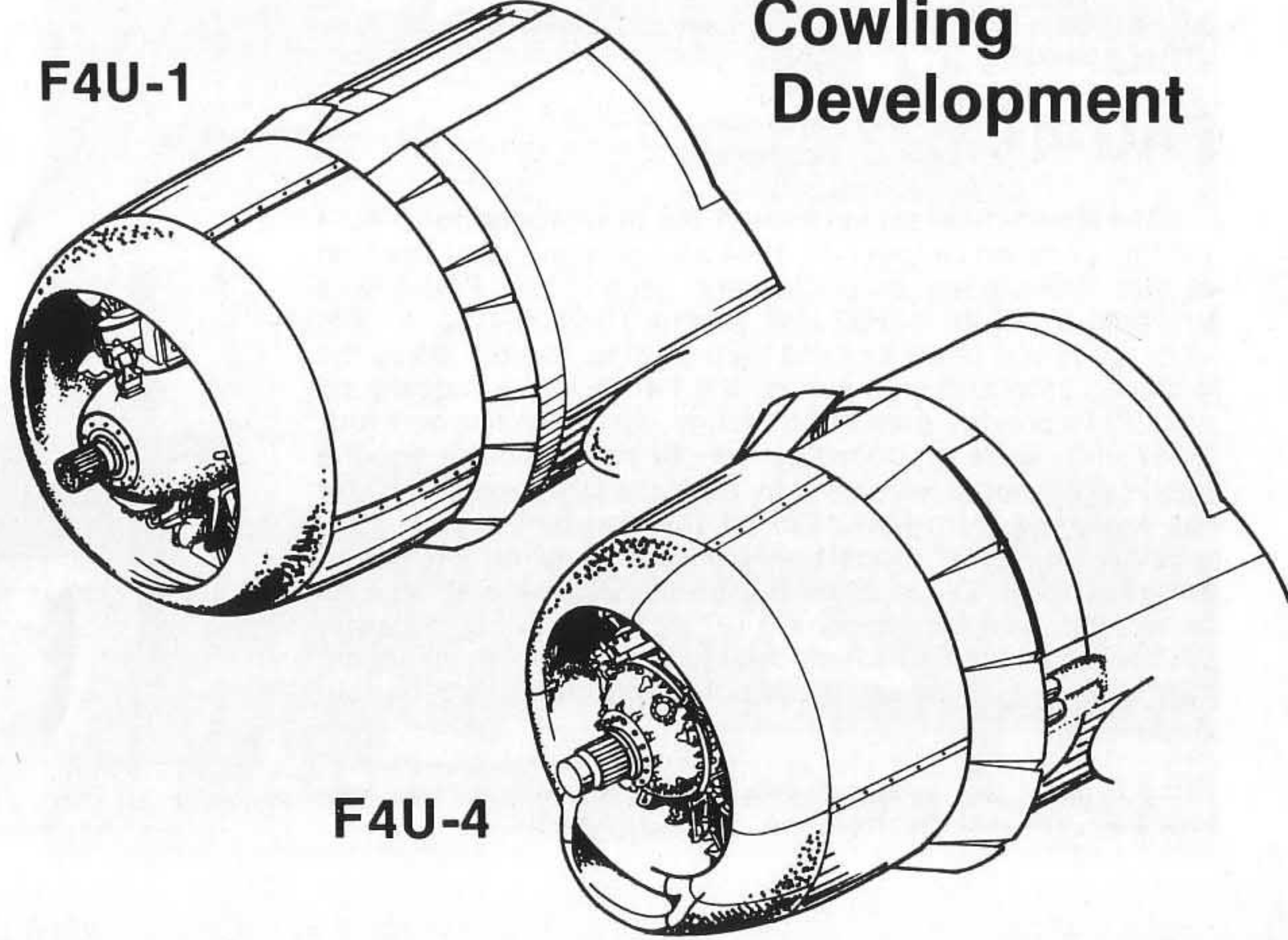

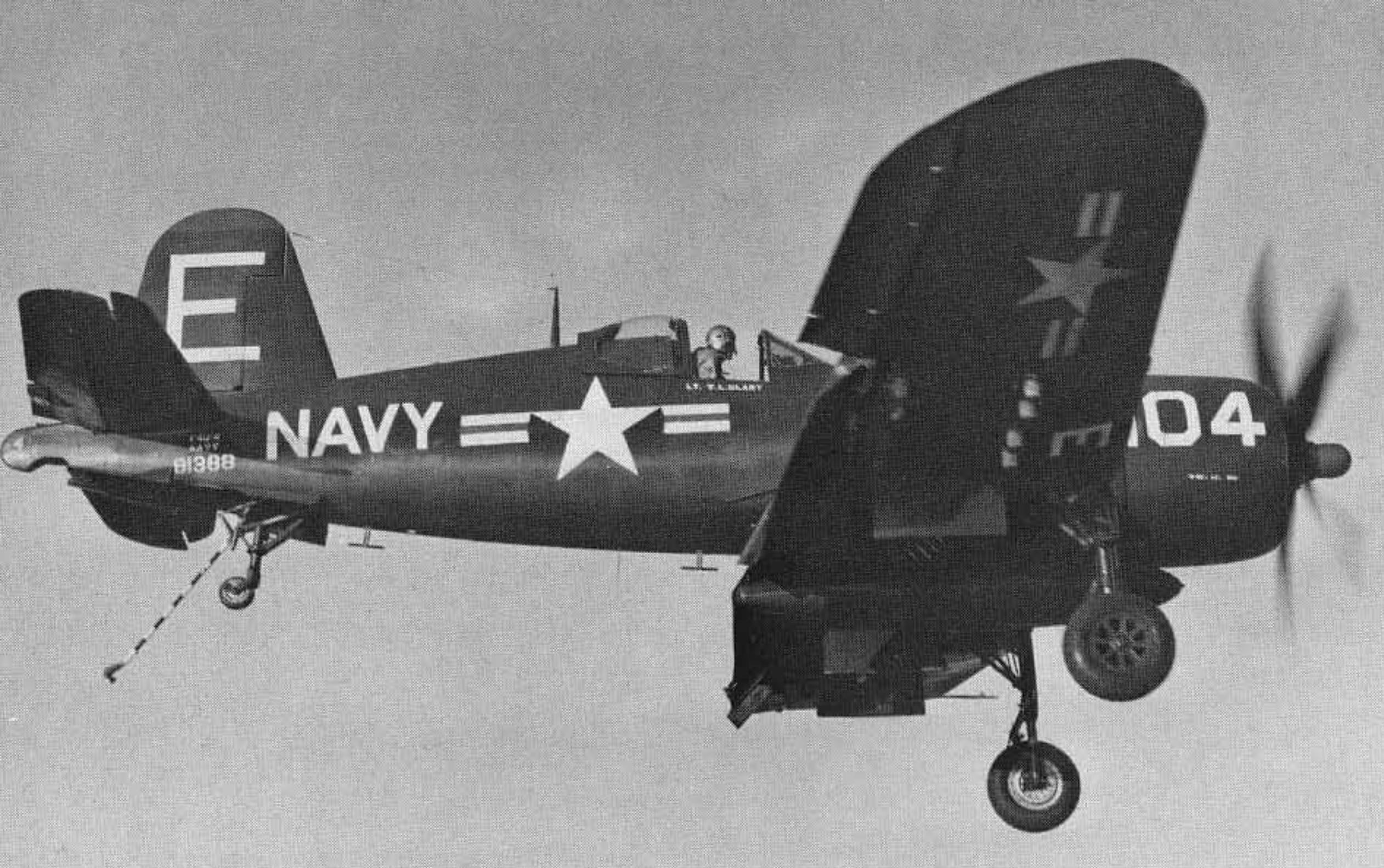

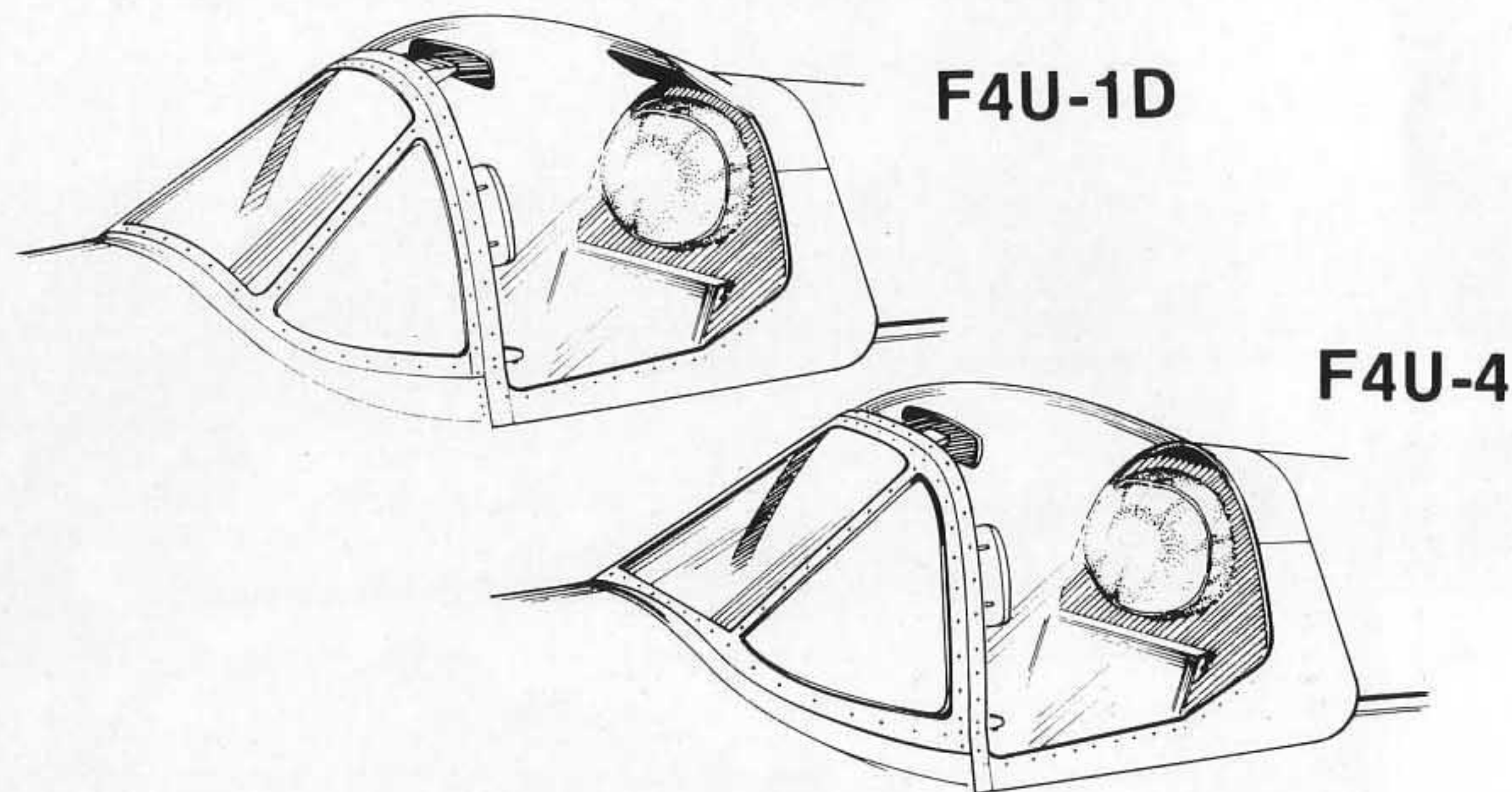

Logging over 64,000 combat sorties during WWII, the Corsair in the hands of Navy and Marine pilots was credited with the destruction of 2,140 enemy aircraft in air combat. The kill ratio of 11:1 was achieved with the loss of only 189 Corsairs although another 1,435 were lost as a result of operational accidents and enemy anti-aircraft fire.

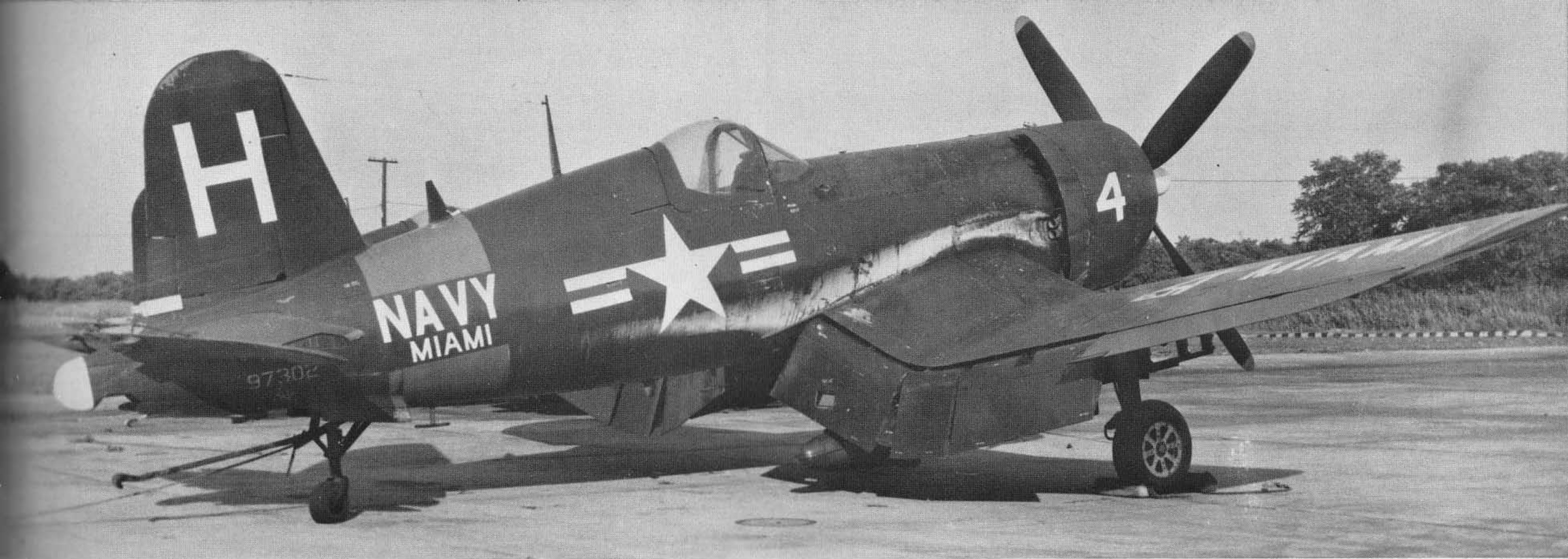

## Korea

The Korean hostilities began on June 25, 1950 and shortly thereafter the Corsair was called back to action. VF-53 and 54 onboard the USS Valley Forge hit Pyongyang, North Korea in early July and the air war was on. The Valley Forge was joined shortly by the USS Philippine Sea with VF-113 and -114 and the USS Sicily and USS Badoeng Strait with VMF-214 and -323 with others on the way. The F4U was back in action. One Marine pilot, Capt. Jesse Folmar from VMA-312 downed a MIG-15 and a VC-3 pilot, Lt. Guy P. Bordelon became a night-fighter ace. Throughout the 37 months of Korea, Corsairs participated in the action right up until the final day, which came on July 27, 1953.

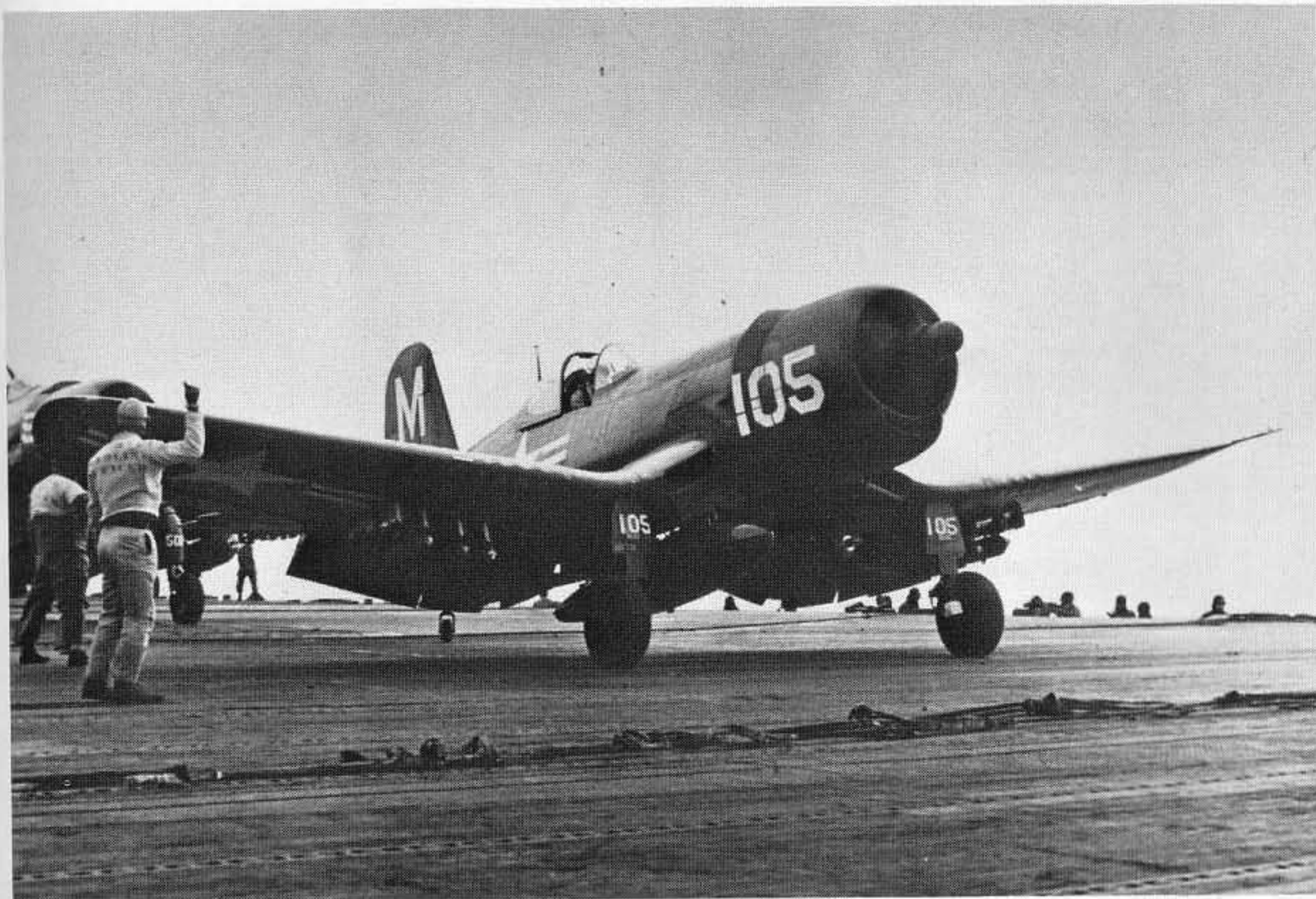

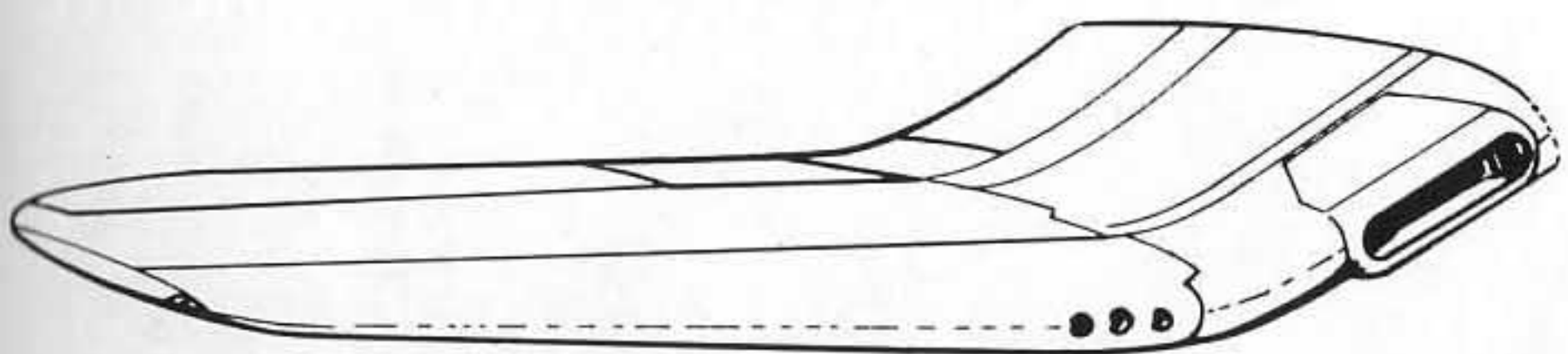

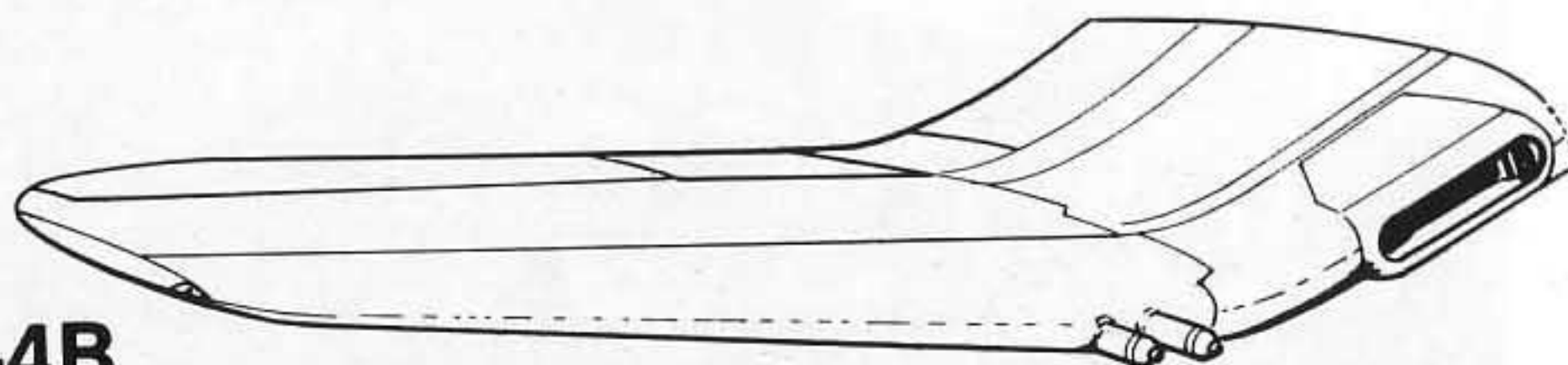

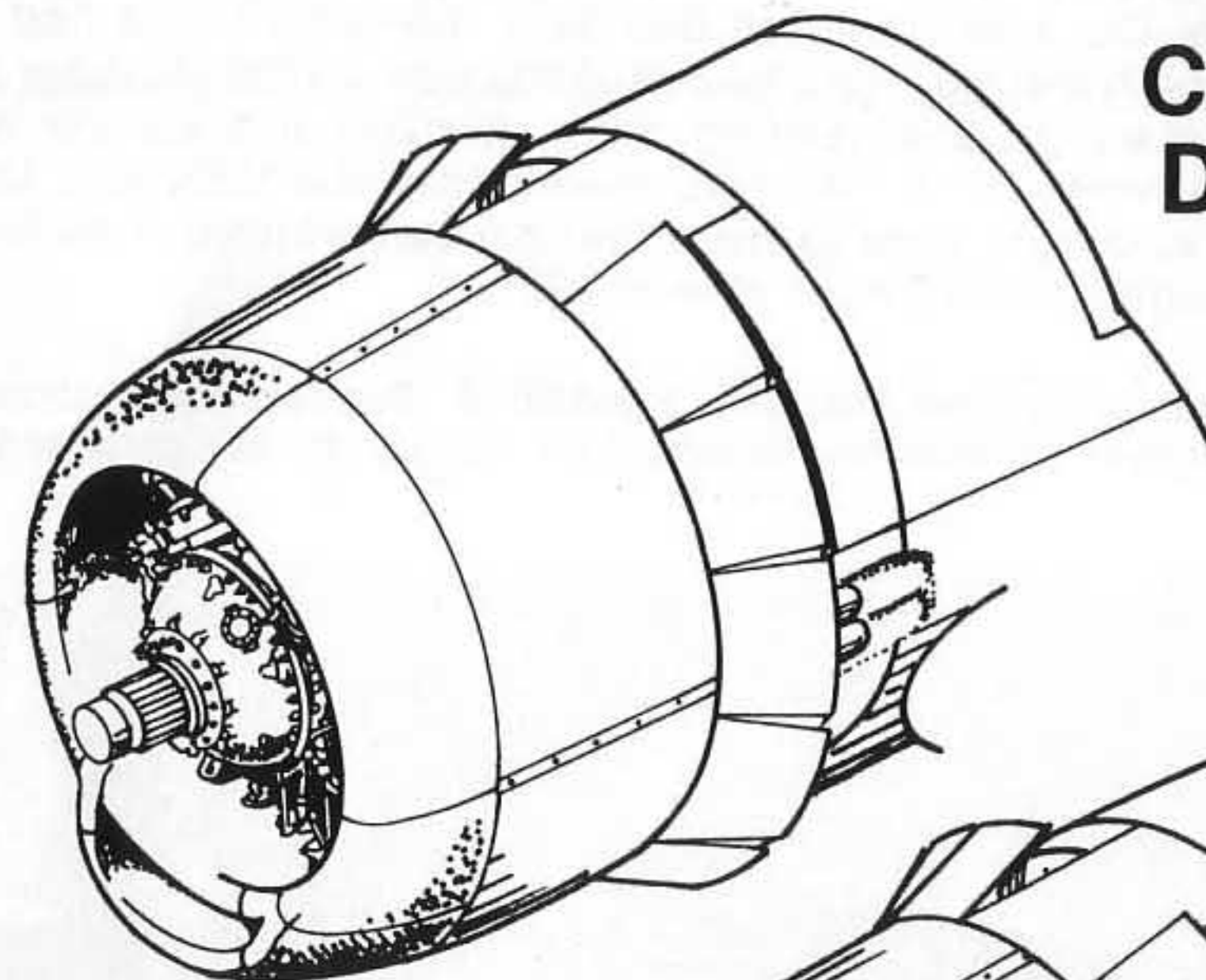
## F4U-5

The first production F4U-5 flew from the new Vought plant in Dallas in April of 1946. The main external difference from previous versions was the air intake scoops at the 4 & 8 o'clock positions in the engine cowling. A second look at the F4U-5 would reveal that for the first time since production began, the outer wing panels were metal covered. Powered by a P&W R-2800-32W double supercharged engine, the -5 version developed 2,450 HP and could do even better with the use of the emergency water-injection system. Armament consisted of 4 20mm M-3 cannons and provisions for 8-HVARs and 2 center-section bomb racks. In the total of 568 units produced, 223 were F4U-5, 214 were F4U-5N, 101 were F4U-5NL (the winterized version) and 30 were F4U-5P, the long-range photo-reconnaissance version.

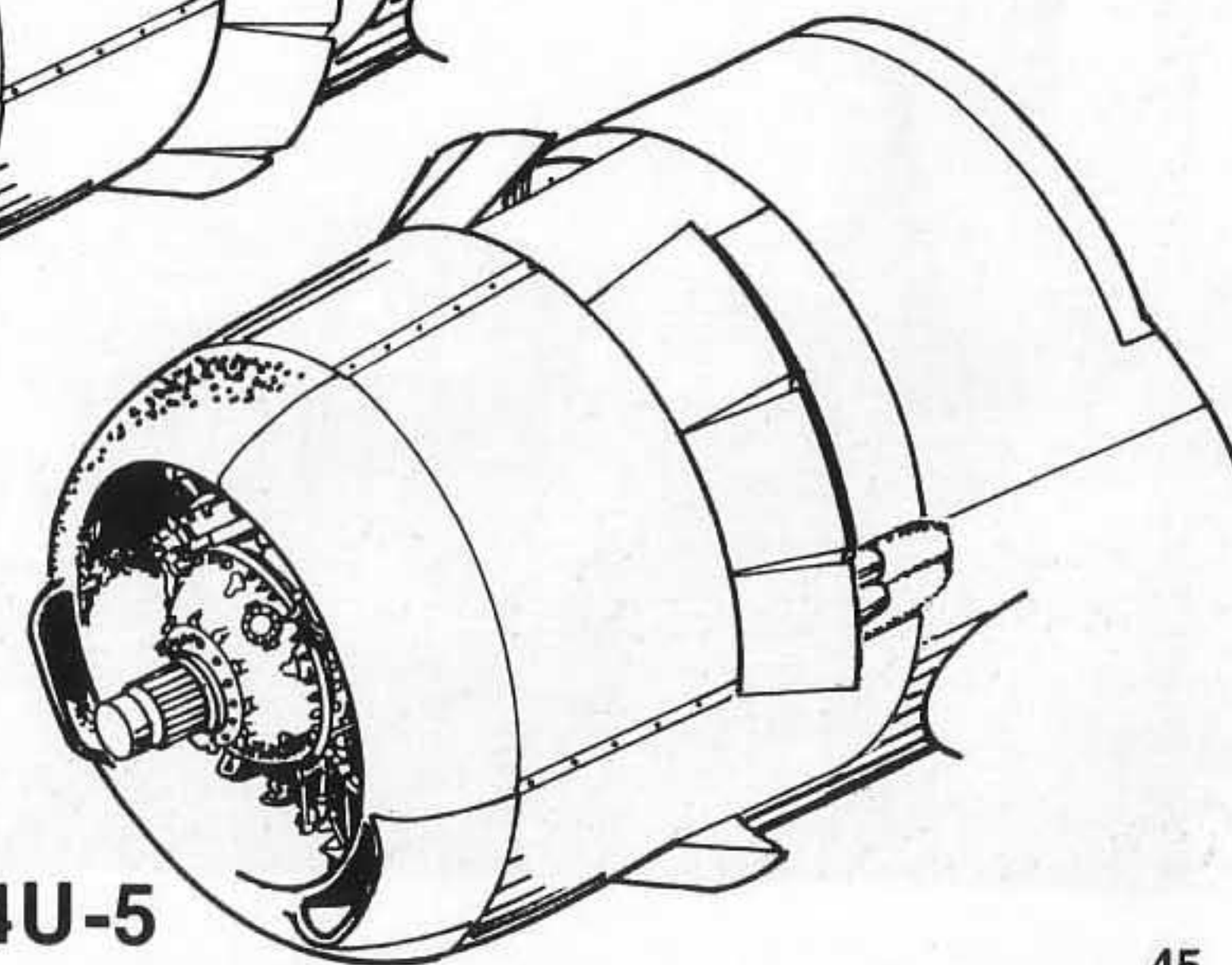

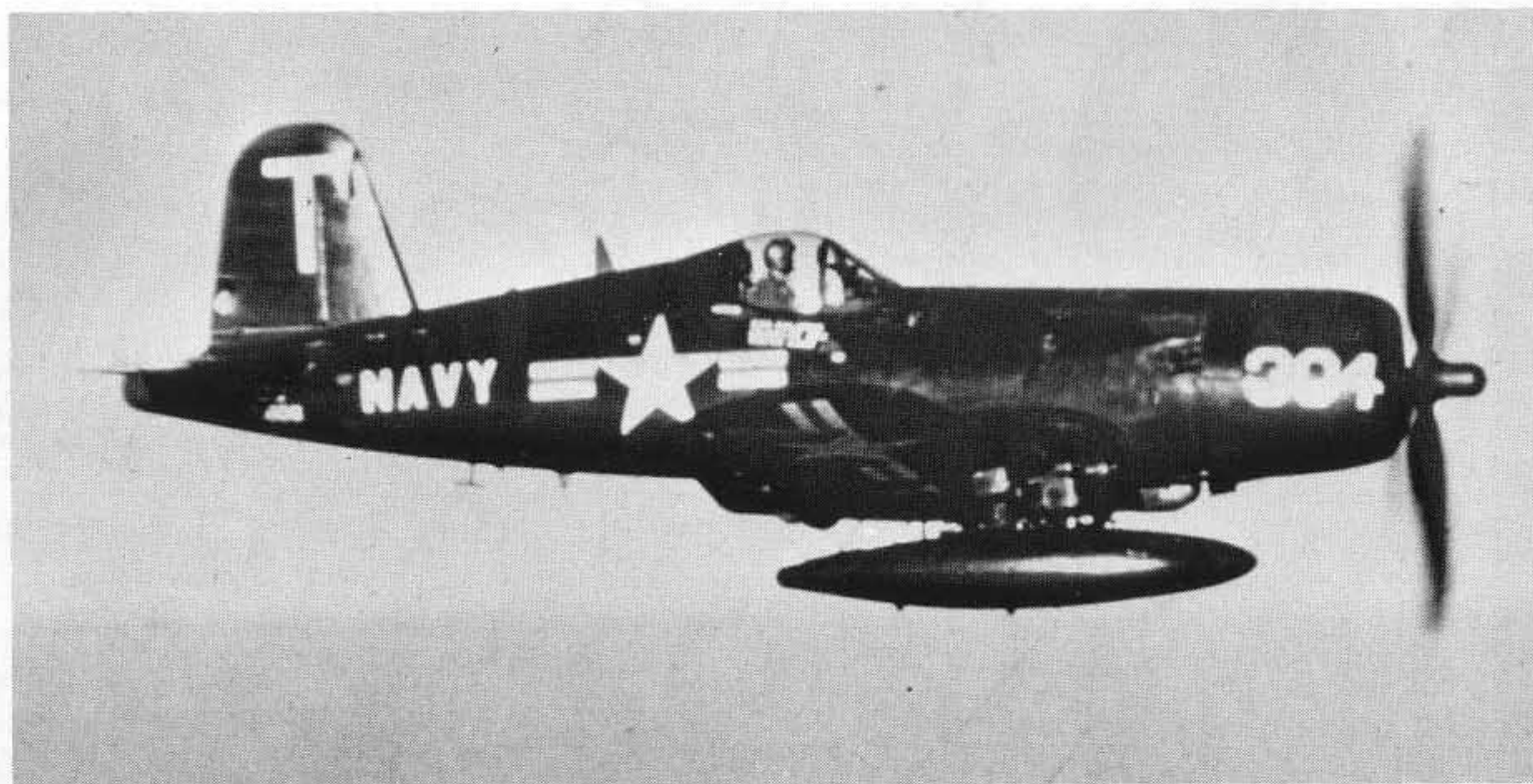

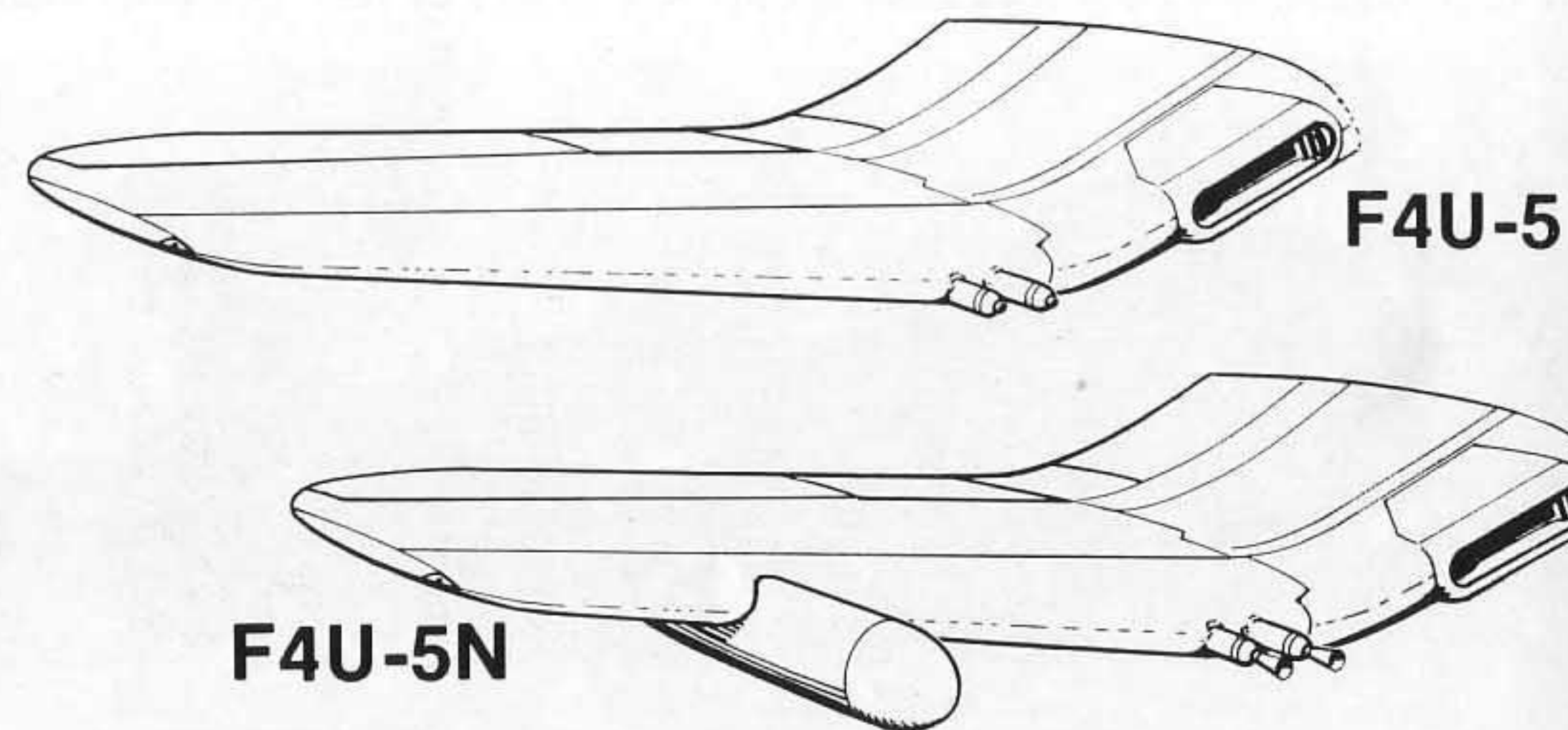
Too late for WWII, the F4U-5 series first entered combat with the Marines during Korea. The bitter winters there forced the development of the F4U-5NL by Vought, B.F. Goodrich Rubber Co. and Hamilton-Standard. De-icing boots had never been fitted to a fighter aircraft before, but the F4U-5NL was a first. Rubber boots were installed on the outer wing panel leading edge, horizontal stabilizer and fin and propeller blades. The reality of a F4U-5NL meant that the USN and USMC had a fighter that could fly and fight even in the frigid Korean winters. F4U-5NL (124665) was converted by Vought to the XAU-1 late in 1951.

# AU-1

Built especially for the low-level ground-support role, the AU-1 was utilized in Korea by the Marines. Heavily armor-plated in vulnerable areas, the AU-1 was externally similar to the F4U-5 but without the twin cowling air intakes. These were faired over when the oil cooler was relocated to be less vulnerable to ground fire. Powered by the P&W R-2800-83W, the AU-1 had a single-stage single-speed supercharged engine. Armament was identical to that of the F4U-5 except that two additional outer wing racks were added bringing the total now to 10. This permitted the AU-1 to deliver 10 HVARs or 10 100-lb. bombs in addition to the center-section racks. By the Summer of 1952 Vought completed the run of 111 Corsairs specifically designed for low level attack. After Korea many of the combat-veteran Corsairs were assigned to Naval and Marine Reserve units.

### F4U-7

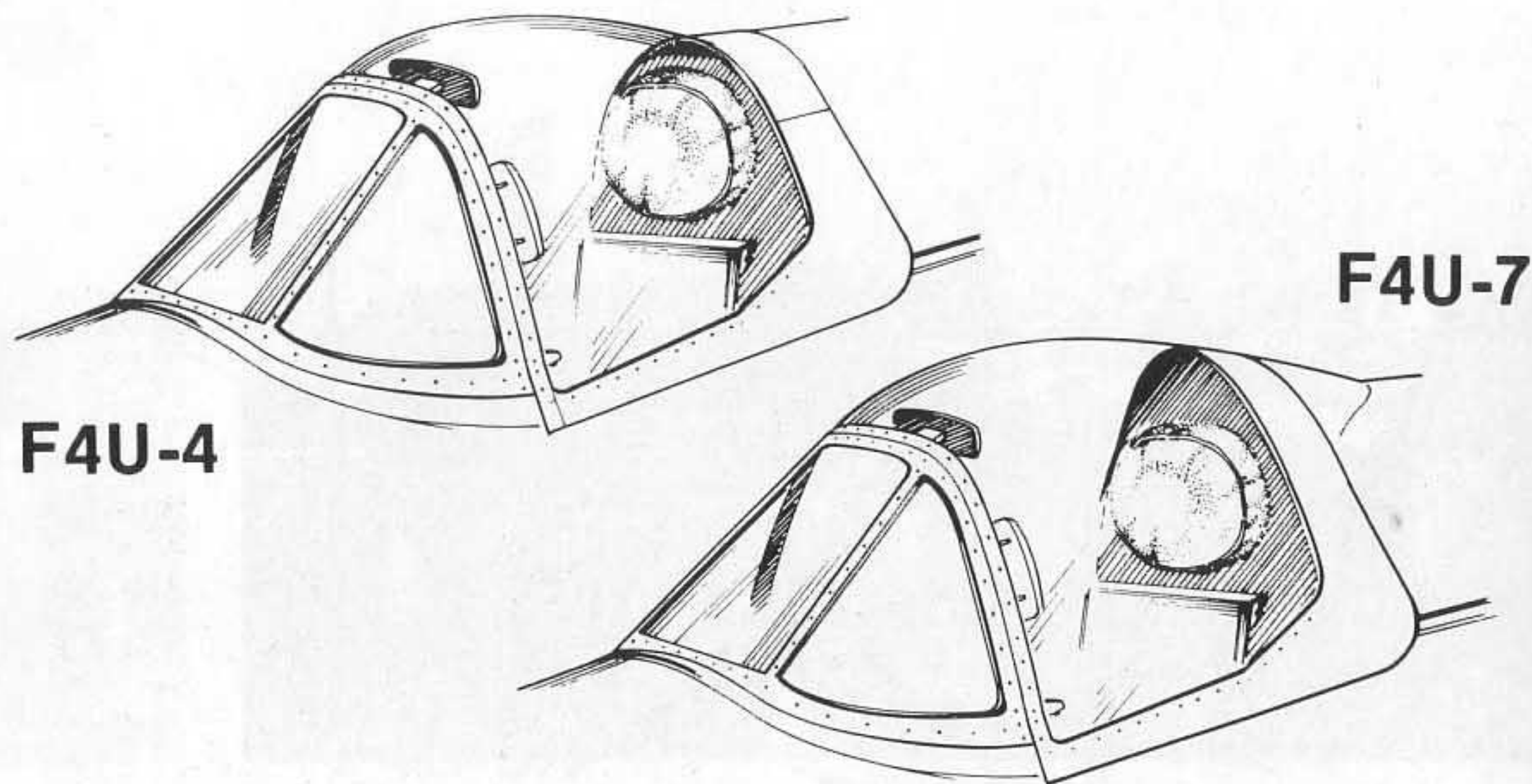
The first F4U-7 was flown by Vought in July 1952 and was very similar to the earlier F4U-4B in appearance. Powered by the P&W R-2800-18W engine, the F4U-7 was produced exclusively for France under the M.D.A.P., a total of 94 Corsairs were delivered. Along with a few AU-1s from the USMC the French equipped 4 units and fought with the F4U-7s in 3 conflicts; Indochina, Suez and Algeria. The last F4U-7 rolled off the Vought Dallas assembly line in January of 1953. Late in 1964 Flottille 14F phased out the last of the French Corsairs.

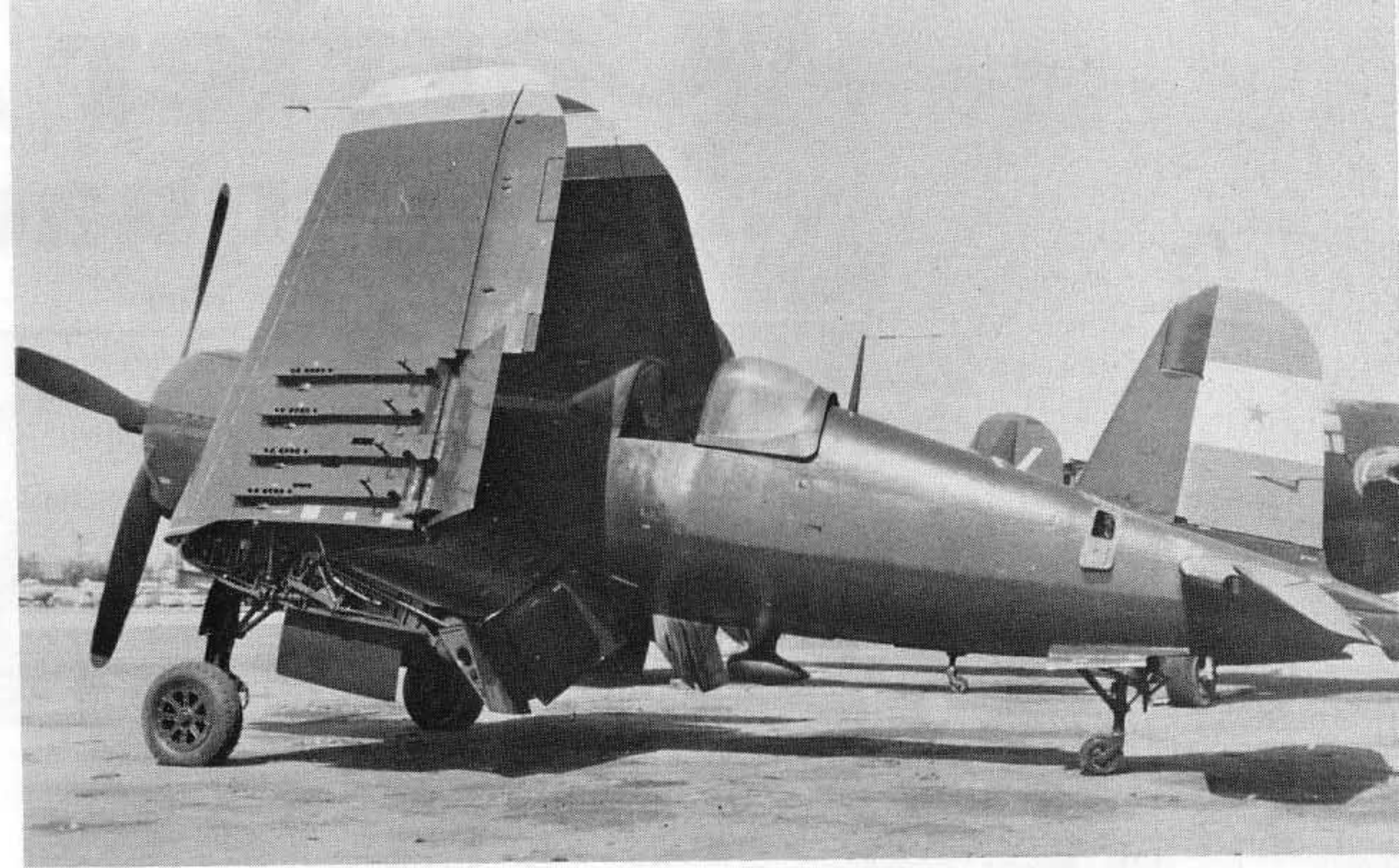

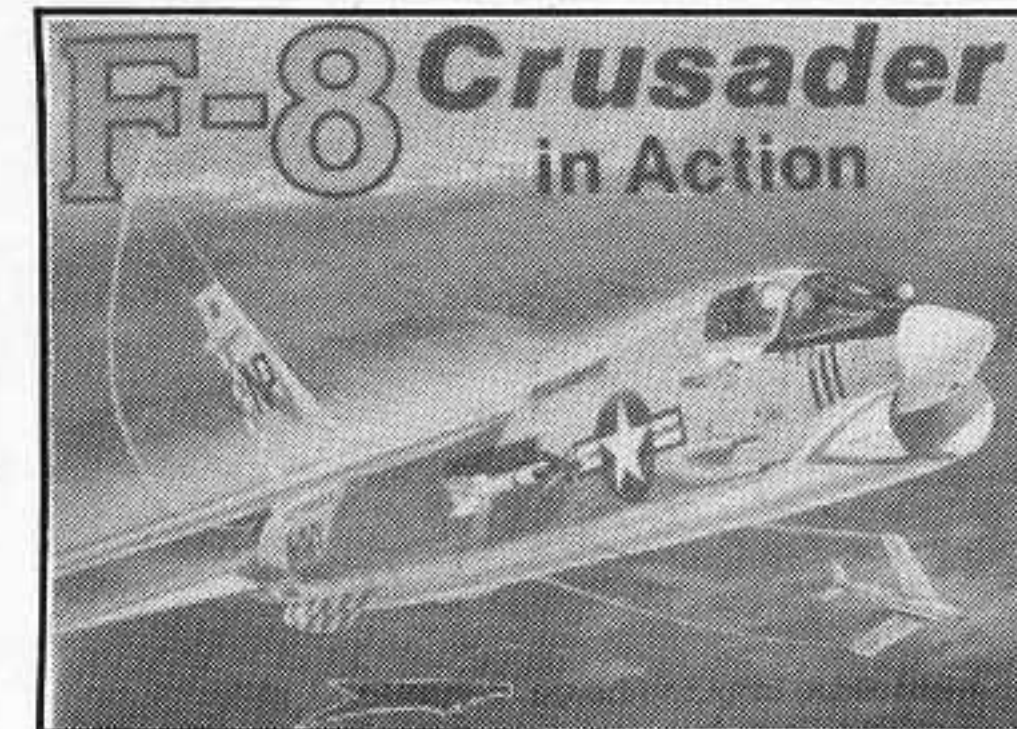

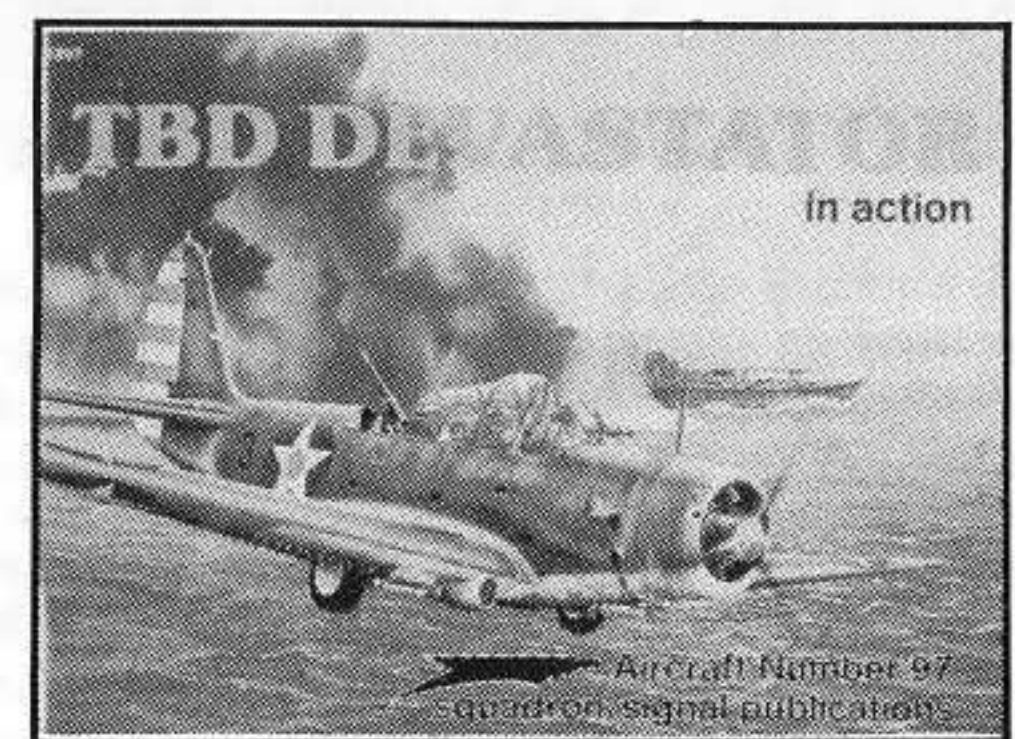
