

CONDITIONS AND INFORMATION

- All hounds will be run in trios or braces, twice, unless excused, dismissed or disqualified.
- Hounds not present at roll call will be scratched, and their entry fee will NOT be refunded.
- All handlers MUST use a slip lead when releasing their hounds.
- Hounds may wear muzzles and/or catch collars at the owner / agent's discretion.
- Bitches in season and lame hounds will be excused and will have their entry fee returned if notice is given to the secretary **prior** to roll call.
- The Chairman may excuse any hound from competition for any reason deemed justifiable.
- A \$5.00 fine, payable to ALCA, will be levied for any hound loose on the field at any time between roll call and the completion of Best in Field.
- There is NO shade or water available, so come PREPARED.
- Best in Field will be offered only on Sunday, September 6, 2008. Breed Winners from both Saturday and Sunday will be eligible to compete.
- You may camp overnight but, with the exception of a Port-a-Potty, there are no camping facilities.

EQUIPMENT AND FIELD CONDITIONS

An electric drag or continuous loop will be used for the regular classes.
A continuous loop may be used for the Puppy and Veteran stakes.
The field is pasture and park land with NO shade or water available.

Attention all Foreign Exhibitors!

All dogs that are foreign born and foreign owned and enter Canada for the sole purpose of entering CKC events will no longer require a CKC registration number but will require an Event Registration Number (ERN). This ERN does not register a dog with the CKC for breeding purposes as defined in the Animal Pedigree Act but rather enables foreign-born and foreign-owned dogs to be awarded titles by the CKC. Each dog must have its own number. To obtain an ERN mail or Fax a copy of the dog's registration certificate with payment in the amount of \$57.75 Canadian funds, payable to the CKC as of 15 April 2000. This ERN must be applied for within 30 days of the first day of entering a CKC event. DIRECTIONS TO THE FIELD

The field is located east of Sherwood Park and 18 km east of Highway 21. Go east on Baseline Road (becomes Twp 530) to Range Road 211. Turn left, then first entrance on the left. From Highway 16, go right at Range Road 211, south to last driveway on the right before Twp 530. This is north of the Sherwood Park Freeway.

ELIGIBLE ENTRIES

To be eligible for this trial, your dog MUST be a purebred of one of these following breeds: AFGHAN, BASENJI, BORZOI, DEERHOUND (SCOTTISH), GREYHOUND, IBIZAN, IRISH WOLFHOUND, PHARAOH, SALUKI OR WHIPPET.

All entrants must be registered or be eligible for registration with the Canadian Kennel Club. Altered or neutered hounds **may** compete. Hounds presently disqualified under C.K.C., CSFA, ASFA or AKC rules are not eligible.

CLASSES AND STAKES OFFERED

Lure Trial Official Classes

OPEN - Offered for all eligible hounds one year of age or older on the day of the trial, including Field Champions of Record.

Lure Trial Unofficial Classes

Best In Field Offered on Sunday only to include all Best of Breed winners from both Saturday and Sunday.
Puppies Offered Saturday, after official classes
Vettrans Offered Saturday, after official classes

Payment in full must accompany all entries. Tendering of an N.S.F. cheque shall be considered non-payment of entry fees and is an offense punishable by disciplinary action and cancellation of awards by the Canadian Kennel Club. There will be a \$20.00 service charge for any N.S.F. cheque. Overpayment of entries will be considered a donation to the Trophy Fund.

FIRST TIME ENTERED HOUNDS

As of July 1st, 1998, all hounds competing for the first time must be certified prior to entry in a Field Trial. If this is the Hound's first Trial you must submit the Certificate to the Field Trial Secretary (3, 3.1.2 (a) CKC Field Trial Regulation).

CERTIFICATION RUNS

ALCA will hold Certification runs after the completion of the Regular Trial on Saturday evening. Cost is \$10.00. You are expected to make your own arrangements for a suitable dog to run yours with.

CKC definition:

7.1.1 To be eligible to compete at approved lure coursing field trials a dog must meet the following requirements:

(a) A hound must be tested with another dog, not a kennel mate, preferably of the same breed, and certified running clean by a licensed judge. Hounds must be a minimum of 12 months old prior to being certified, and must run a normal course of 600 yards (548.4 m) in order to be certified.

ROLL CALL TIMES AND RUNNING ORDERS

Post Entry closes at 8.30 a.m. each day. Roll call will be at 9:00 a.m. each day.

Breeds will be run in alphabetical order on Saturday, and reverse alphabetical order on Sunday.

Puppy Stakes and Veterans will be run AFTER Official Classes on Saturday.

PRIZES

Prizes and Rosettes will be awarded to BOB winners and BIF. Flats will be offered for all placements.

A Trophy is being offered to the highest scoring aggregate Whippet over the weekend.

Extract from CKC Field Trial Rules and Regulations for Lure Coursing Chapter 7, Placements and Awards

Section 1: *No hound which is not to be scored is to be added to a course.* Championship points in regular stakes shall be awarded on the basis of the following:

FIRST: 4 x No. of hounds competing in the stake to a max. of 40 points.

SECOND: 3 x No. of hounds competing in the stake to a max. of 30 points.

THIRD: 2 x No. of hounds competing in the stake to a max. of 20 points.

FOURTH: 1 x No. of hounds competing in the stake to a max. of 10 points.

NEXT BEST QUALIFIED (NBQ): no points awarded.

No hound shall receive a placement or be awarded points if it does not score at least 50 per cent of the total possible combined scores. Hounds which do not receive placements under this provision will nevertheless be considered as in competition for the purposes of awarding points to hounds who do place. *If a hound is excused in the preliminary run, that hound will not count as having been in competition when computing championship points. Hounds that are dismissed or disqualified shall count as having been in competition when computing championship points.*

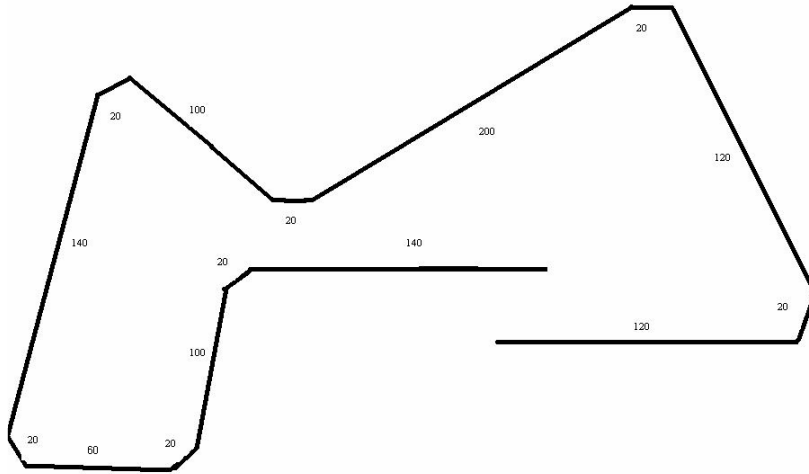
ATTENTION

It shall be the duty and obligation of the trial-giving club to see that a judge, club official, volunteers or any participant at the event held under these rules is not subject to indignities of any kind. The Field Trial Committee Chair shall promptly report to the CKC any infringement of this regulation, and the Discipline Committee shall have the authority to take such action as it deems fit on the receipt of a report indicating that this has occurred.

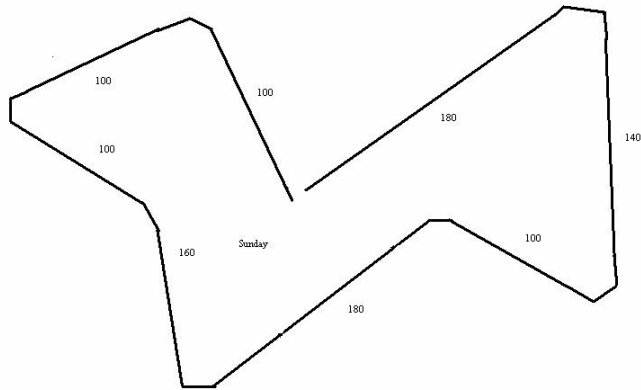
COURSE LAYOUTS
