If an instrument, probe, or other part is returned or presented for service without a Cleaning Certificate, and if in our opinion it represents a potential biological or radioactive hazard, our service personnel reserve the right to withhold service until appropriate cleaning, decontamination, and certification have been completed. We will contact the sender for instructions as to the disposition of the equipment. Disposition costs will be borne by the sender.

CLEANING INSTRUCTIONS

Before they can be serviced, instruments subjected to either biological or radioactive exposure, or to toxins, must be cleaned and disinfected. Biological contamination is presumed for any instrument, probe or other device that has been used with blood, body fluids or tissues, or with wastewater. Radioactive contamination is presumed for any instrument, probe or other device that has been used near any radioactive source.

When service is required, either at the user's facility or at YSI, the following steps must be taken to insure the safety of our service personnel.

1. Empty any containers or chambers, then thoroughly clean all matter from the device.
2. In a manner appropriate to each device, disinfect or decontaminate all exposed surfaces, including any containers. 70% isopropyl alcohol is suitable for most disinfection; any instrument used with wastewater should be cleaned with .5% Lysol or .1% glutaraldehyde. Allow the instrument to air dry. Protect any electronics from spillage and wetting.
3. The user shall take normal precautions to prevent radioactive contamination and must use appropriate decontamination procedures should exposure occur.

If exposure has occurred, the customer must certify that decontamination has been accomplished and that no radioactivity is detectable by survey equipment.

4. Complete the Cleaning Certificate and return it with the product. If the unit is to be serviced at the user's facility, keep the certificate with it.

5. If the product is being returned to YSI's Product Service Department, pack it securely to prevent damage. If a needle, probe, or Syringejet is being returned, it must be packed so it cannot cause an accidental puncture wound to the person unpacking it.

Our service personnel reserve the right to withhold service from any product until proper cleaning and decontamination have been accomplished and certified.

Cleaning must be completed and certified on any product before returning it to the YSI Product Service Department, or before field service.
